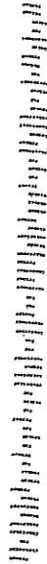

WHEREAS, Police Officer Christopher CONWAY has this day complained (by attached affidavit) to this Court upon oath showing probable cause that on Monday March 6, 2017, in the County of Milwaukee, there is now located and concealed in and upon certain premises located within the City of Milwaukee, in said County, occupied by Marquell D. WARE B/M 08-29-93 and more particularly described as follows:
