Returned herewith is a document filed by Attorney Laurie Eggert for attorney's fees for representing Police Officers Andrew Gebhardt and Thomas Dineen. The claim is in the amount of \$568.68 including \$7.68 in disbursements for 5.10 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the Police Officers on whose behalf this claim was filed.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Sec. 895.35, Stats., Bablitch and Bablitch v. Lincoln County, 82 Wis. 2d 574 (1978).

pockets. He states that Officer DINEEN pointed his service weapon at him and stated, "I'll shoot you." Mr. GATLIN states he then became afraid and started running. Fearing he would get shot, GATLIN reports he then stopped fleeing and sat down on the ground with his hands up. He contends at this point he was immediately pushed to the ground and the left side of his face was' on a concrete walkway. He states that one of three uniformed officers, determined to be that of Officer Thomas DINEEN, then put his knee on the right side of his face causing the left side of his face to be ground into the concrete pavement. He further indicates he was kicked in the stomach, groin and head several times, as well as punched into his back and stomach. Mr. GATLIN indicated that he did not want to pursue charges against Officer DINEEN but wanted the Milwaukee Police Department to be aware of what had happened to him.

Investigation into this incident revealed that complainant GATLIN was being pursued by Officers GEBHARDT and DINEEN on foot as a suspect in an armed robbery. Upon being taken into custody GATLIN was positively identified by the complainant in the armed robbery as the individual, who at gun point, robbed him of \$62.00 in U.S. currency as well as a pair of men's tennis shoes.

Upon interview of Officers GEBHARDT and DINEEN, they report while monitoring their squad radio a description was put out for an armed robbery suspect who was in the area of 30th and Meinecke. Upon entering said area Officers GEBHARDT and DINEEN observed an individual, later determined to be complainant GATLIN, matching the description of the wanted suspect. GATLIN did flee but was eventually cornered in a gangway of a residence. Officer DINEEN states that he then pointed his service weapon at complainant GATLIN and ordered him to show him his hands. He states that GATLIN then sat on the ground in the gangway, at which time he (P.O. DINEEN) did put his knee in GATLIN'S back to gain control. Officer DINEEN reports at this time he and Officer GEBHARDT did handcuff complainant GATLIN. Upon bringing GATLIN to his feet, both officers report observing a cut on his face. Officer GEBHARDT states that he did eventually apply a band-aid to the wound. Prior to leaving the scene both officers report that a supervisor was apprised of the situation and a Use of Force report was generated. Both officers denied using excessive force in taking complainant GATLIN into custody.

CONCLUSION:

Investigation into this incident revealed that while the officers were in foot pursuit of complainant GATLIN, he was observed to have struck his face against a fence resulting in the cut to his face. Further, complainant GATLIN gave a false name at the time of his arrest making his credibility questionable. This investigation did not reveal that the officers used excessive force when apprehending GATLIN as a suspect wanted in an armed robbery. It is for said reason that this complaint will be cleared as baseless.
