
We return the enclosed document which has been filed with the City Clerk and ask that it be introduced and referred to the Committee on Judiciary & Legislation with the following recommendation.

Claimant, Mary Rogers, 2512 West Lloyd Street, Milwaukee, Wisconsin 53205 alleges through her attorney, James C. Mentkowski, 111 East Wisconsin Avenue, Suite 1750 Bank One Plaza, Milwaukee, Wisconsin 53202 that on December 31, 2000 she slipped and fell on a stairway of a City of Milwaukee building located at 2511 North Martin Luther King Drive and sustained injuries. She seeks \$60,000.00 in damages.


March 23, 2001

A site investigation conducted by Infrastructure Services revealed that there are no stairs adjacent to any City sidewalk at this location. In addition, there is no City building located at this location. The City of Milwaukee cannot be held liable for this incident. Accordingly, we recommend that this claim be denied.
