Please advise Alderman Bauman that I am reluctantly withdrawing my objection to the Public Entertainment License renewal at the Astor Hotel.

After much review and determining that it is all or nothing regarding the license I can not support cancelling already scheduled weddings. I would prefer that already scheduled wedding be permitted to go forward while prohibiting any future bookings. This option is not available prompting my decision to not support the 90 day suspension of the license.

Management has agreed to cancel all future Promoter events which have been the source of the majority of the pending issues and has proposed preliminary plans to address the concerns of tenants and neighbors. I have been informed that a Security Officer will be on duty this evening starting at 2200 hours.

I have agreed to assist Mr Cadd in seeking solutions to the continuing disruptive behavior (Disorderly Conduct) issues as well as their failure to adhere to the municipal ordinance dealing with Noise Control (Chapter 80, Sub chapter 2, s 80-61 to 80-65.

Continuing complaints and or the failure of management to act in good faith addressing pending issues in a timely manner will result in me personally pursuing all avenues under existing ordinances/statutes to resolve the issues.
