There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 2. On 02/27/2017 Milwaukee police responded to an injured person at St. Mary's Hospital. The victim, Megan Demunck, told officers she had been at Scooter's Pub (158 East Juneau Avenue) when an argument began between a male and a female inside the business. The male broke a glass and kicked one of the broken pieces in anger. This piece of broken glass struck Demunck in the leg, causing a laceration that required 6 stitches. Milwaukee police incident report #170580007 filed.

- 3. On 03/30/2017 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, was able to enter Scooter's Duke's on Water (150 East Juneau Avenue) where she was served a Miller I ite beer. An officer later informed Todd Wargula that the business had failed.
- 4. On 06/17/2017 Milwaukee police responded to a trouble with a subject complaint at Dukes (158 East Juneau Avenue). Investigation revealed a subject attempted to gain entry to the business after bar hours. When he was told he could not enter, the subject broke the glass on the door with his fist. The subject was cited for vandalism.
- 5. On 08/26/2017 officers were dispatched to a fight at Dukes on Water, 158 E. Juneau Av. The investigation revealed two subjects, who were friends, got into an argument over one of their girlfriends. One subject attempted to hit the other while in the bathroom causing the subject to slip and fall hitting his head. The subjects were kicked out by security. A Disorderly Conduct citation was issued.
- 6. On 03/17/2018 an officers was outside Duke's on Water, 150-58 E. Juneau Av, and observed an altercation between one of Duke's security, Abdullah GILBERT, and another person, Aaron WUEBBEN. The investigation revealed WUEBBEN was in line waiting and became upset with the wait. He was stating GILBERT was not letting him in because of his race and he then grabbed GILBERT by the throat causing GILBERT to push WUEBBEN to the ground and hold him for Police. WUEBBEN was cited for Disorderly Conduct.
- 7. On 07/15/2018 officers were flagged down for a fight at Duke's, at 158 E. Juneau Av. The officers observed a security guard from Dukes, Travis COLEMAN, stepping on a subject, Jarvis NTABA, lying on his back. COLEMAN stated NTABA was upset because he was not being let inside after "last call" and got in his face in an aggressive manor. COLEMAN stated he grabbed his shoulders and performed a leg sweep, taking him to the ground and held him for officers. NTABA had pain to his head and was taken to the hospital for evaluation.
- 8. On 11/29/2018 officers conducted underage tavern enforcement in District 1. An underage Police Aide attempted to gain entry to Dukes on Water, 158 E. Juneau Av. The Police Aide was allowed entry and was served a Miller Lite for \$4.00. The bartender was identified and issued a citation.
- 9. On 03/07/2019 at 2:02am officers observed multiple people inside Duke's on Water, 158 E. Juneau Av, after closing time. The officers entered and observed 6 patrons inside the bar and 2 drinks on the bar. The bartender stated he was trying to get the patrons out but they were not leaving fast enough and they try to remain friendly with patrons so they will become repeat customers. The officers advised him the patrons must be out of the bar by closing time.

- 10. On 03/18/2019 at 12:42am an officers observed a patron exit 158 E. Juneau Av with an open bottle of beer. The officer advised the subject he had to return to the bar with the alcohol and reminded security that patrons could not exit with alcohol. The officer observed the tavern was very busy and asked the security guard what his patron count was. The guard stated he was not keeping count. The officer spoke with the manager who stated he has not been keeping count but knows they are below capacity. When asked how he knows they are below capacity he stated he has been doing this for 18 years and has been through many counts, so he knows what 400 people in the tavern looks like. He was advised that St Patrick's day is a very busy day on Water St and it is best to keep a count to remain under capacity.
- 11. On 05/23/2019 at 11:13pm officers observed patrons of Duke's on Water leaving the tavern with open glass bottles of beer. The officers conducted a licensed premise check and observed the patrons standing shoulder to shoulder with no room to move. The officer asked the security person at the door what his patron count was, and he stated he did not know. The officer attempted to locate the manager but was unable to find him in the bar. The officer returned at closing time to speak with the manager about the violations. He stated he knows they are not over capacity because he has been doing this for 18 years and knows what 400 people in the bar looks like.
- 12. On 05/26/2019 at 1:50am a Police Sergeant observed a Dukes on Water bouncer standing in the middle of the cross walk yelling at a patron. He observed the bouncer pointing in the face of the patron threatening to beat him up. The sergeant approached the bouncer and told him to return to the bar. The sergeant then spoke with the manager of Duke's, who stated he had been threatened by customers several times and he was closing early because of an unruly crowd. The sergeant advised that Code Red officers were nearby to help.
- 13. On 06/11/2019 officers, along with agents from the WI Department of Revenue, conducted a licensed premise check at Duke's on Water. The two bartenders, who did have valid operator's licenses, could not provide paper copies to the officers. The officers observed that the posted Class B Tavern license was expired and advised the manager to post the current license.
- 14. On 08/24/2019 at 1:53am officers were flagged down by security at Scooter's Pub for a subject who was sick. The officers observed a subject, sitting at the bar, begin to vomit and fall to the floor hitting her head on a bar stool. The bartender stated the subject came into the bar intoxicated and was only served alcohol when her friend ordered it. The bartender stated she took the alcohol away when the patron got sick. The subject was conveyed to the hospital for being incapacitated by alcohol.

15. On 12/22/2019 at 12:07am officers responded to Duke's, 158 E. Juneau Av, for a Trouble with Subject. The officers a subject punch another patron and flee the scene. The officers spoke with security in an attempt to identify the subject. Security was uncooperative with the officer saying he didn't have to be a witness. The manager was cooperative with the officers and did identify the subject as a frequent patron. Another patron made a complaint that she was pushed to the ground by security. The security officer was issued an Assault and Battery citation. The patron who was punched stated he did not want to prosecute for his incident.

- 16. On 03/02/2020 officers conducted training at Duke's on Water, 158 E. Juneau Av, in the identification of fake ID's. There were 10 security member there for the training.
- 17. On 07/24/2020 at 11:02pm officers spoke with the manager of Duke's, 158 E. Juneau Av, about foot traffic around the tavern. Suggestions were made about the entrance and exit of patrons from the business. The manager was receptive and stated they would make the necessary changes.

- 18. On 01/30/21 at 2:22am, Milwaukee Police were flagged down for a fight at 150 E. Juneau Avenue. Investigation revealed that a security manager had to physically escort a patron out of the establishment and when they got to the front door, he two hand pushes the patron through the front door into a snow bank. While the patron is walking away, the security manager strikes the patron in the face causing him to fall and he begins to taunt the patron as he is on the ground. The patron then flees the scene and is pursued by the security manager. The security manager, along with the majority of the security staff were terminated and the new security manager said that a new surveillance system will be installed.
- 19. On 12/18/20 at 12:30pm, Milwaukee Police received a call from a subject who lives above 158 E. Juneau Avenue complaining about the noise emanating from the tavern. The complainant said that the tavern turns on the music around noon on the weekends and stays on until bar close. Officers responded to the establishment and spoke with the manager who stated that he would turn the music down.
- 20. On 02/07/21 at 1:40am, Milwaukee Police were dispatched to 158 E. Juneau Avenue for a battery complaint. Investigation revealed that an armed security guard was battered by a patron they were escorting out of the tavern. The armed security guard lost consciousness from the altercation and when he woke up he observed the subject walking towards him. He then drew his firearm and ordered the subject to stay back. The subject then fled on foot.
- 21. On 04/20/21 at 1:50am, Milwaukee Police were dispatched to 158 E. Juneau Avenue for a Threat compliant. Upon arrival, officers interviewed the caller/employee who stated that two subjects entered the establishment at bar close and asked for drinks and the bartender refused them service. The subjects became irate and had to be escorted out of the tavern by the caller and when they were outside, the subjects threaten to shoot up the establishment. While the subjects were walking away, surveillance footage captured one of the subjects breaking a window at the tavern. The tavern staff was helpful and cooperative with the investigation.\
- 22. On 06/12/21 at 12:34am, Milwaukee Police responded to 158 E. Juneau Avenue for a shots fired complaint. While walking near the tavern, officers heard what appeared to be a single gunshot from inside the tavern. Investigation revealed that a group of males and females were arguing inside the establishment and security was escorting them out when someone fired a single shot inside. None of the employees witnessed who fired the shot and officers recovered surveillance footage. The bar staff was cooperative regarding the incident.

- 23. On 06/14/21 at 12:00am, Milwaukee Police conducted a license premise check at 158 E. Juneau Avenue. Officers interviewed the manager who stated that they are going to make some changes to the tavern due to events that have recently occurred. These changes include, starting a weekend cover charge, the purchase of two hand-held metal detectors, a dress code, and at the end of the night security will help clear the corner and the front of their business.
- 24. On 06/15/21 at 12:19am, Milwaukee Police were dispatched to 158 E. Juneau Avenue for a battery complaint. Investigation revealed that a female was kicked out of the tavern for slapping a male and antagonizing fights with patrons. While outside the male and female began to fight and the male was assaulted by numerous males. The female was arrested for an outstanding warrant.
- 25. On 06/30/21 at 1:08am, Milwaukee Police observed a fight outside 158 E. Juneau Avenue. The fight was broken up and investigation revealed that a female, who was denied entry earlier in the evening, came back and spit in a bouncer's face. The bouncer then grabbed the female, fearing that she might retrieve a weapon from the vehicle she exited before the assault, and tried to flag down police. While looking for the police, a male subject approached the bouncer and both subjects began to assault the bouncer. The incident was captured on surveillance footage and the male subject was cited.
- 26. On 07/30/21 at 2:00am, Milwaukee Police observed a tavern violation at 158 E. Juneau Avenue. One of the windows was open to the location and people were talking through that window. When officers entered the tavern, they observed 4 employees and two unknown people who were later to be identified as and off-duty employee and a regular citizen. A co-owner was told about the incident the following night and they said that they would address that with staff.
- 27. On 09/02/21 at 2:00am, Milwaukee Police observed an altercation outside of 158 E. Juneau Avenue. While dealing with the argument, officers observed patrons inside the tavern with zero intention of being out of the tavern by 2:00am. An officer went inside and observed 15-20 people still standing inside as well as people in the men's bathroom. The manager told officers that she was one of only two employees and did not have any reason as to way there were still patrons inside the tavern after hours. The tavern has been warned previously about having patrons in the bar after hours.

28. On 12/25/21 at 10:40pm., Milwaukee Police were dispatched to a Sick and Injured at N. Water St., and E. Juneau Av. On arrival officers observed a subject on the ground slumped over and unresponsive. The officers called for medical attention and the subject was conveyed and admitted to the hospital for a fractured skull and brain bleed. Officers were advised by employees the citizen was intoxicated in the bar and causing a disturbance with staff and patrons. Security escorted the patron out and he fell and hit his head, causing him to lose consciousness. Video surveillance depicted a discrepancy in what officers were originally told during the initial investigation. Video surveillance showed security approach the subject and apparently ask the subject to leave. The subject heads toward the door, then appears to advance on one security officer, causing the other security officer to put his hand up in an effort to stop any physical contact. The subject then stands in the doorway, in an attempt to prevent security from closing the door, however, security pushed the subject, causing the subject to fall. The subject then gets up, opens the door and throws a punch at

the security guard, which resulted in a struggle between the two. The security guard is then seen pushing the subject to the ground, at which time the subject immediately goes limp and does not respond. Security then called the non-emergency line to facilitate police and medical assistance. Officers interviewed security regarding the discrepancies and decision to call non-emergency versus 911. The security officer stated they were not a medical professional and therefore could not determine if this call was 911 worthy. The case was reviewed and no processed.

29. On 07/06/22 at 1:04am., Milwaukee Police were dispatched to a Subject with Gun at 158 E. Juneau Av. Officers were advised by security two subjects were denied entry into the establishment, when one of the subjects brandished a firearm and pointed it at security. Employees were cooperative with the investigation and provided video surveillance of the incident.

30. On 11/11/22 at 8:43pm, Milwaukee Police conducted a license premise check at 150-158 E. Juneau Street. Police talked to the staff about loitering, patrons leaving with plastic cups, helping to clear the sidewalks at tavern close, and using metal detector every night of the week. The staff was receptive to the suggestions.

- 31. On 02/15/23 at 1:04am, Milwaukee Police were flagged down for a fight at 150-158 E. Juneau Street. Investigation revealed that a subject was asked to leave because he was harassing customers. When he refused to leave, security physically escorted him out and sprayed him in the face when he became aggressive.
- 32. On 06/17/23 at 2:10a.m., Milwaukee Police observed a disturbance and the entrance of 150 E. Juneau Av. Officers entered the business and observed a physical fight between 2-4 subjects. While officers were breaking up the fight, drinks were thrown at them and officers were struck by the drinks. The officers eventually were able to separate the subjects and escort them out separate doors. Once outside another fight took place inside requiring additional officers to respond due to the large number of patrons physically fighting.
- 33. On 08/18/23 at 2:18a.m., Milwaukee Police were monitoring bar close on Water Street, when they observed a large crowd loitering in front of 158 E. Juneau Av. Employees of the establishment were attempting to disperse the crowd; however, the subjects were refusing to comply and became loud and boisterous, prompting police intervention. One of the staff members appeared to be intoxicated, which added to the disorder. It is unknown if any of the subjects were patrons of the establishment. Officers advised the manager of the incident.
- 34. On 08/31/23 at 2:46p.m., Milwaukee Police along with agents from the Department of Revenue Alcohol and Tobacco Division, conducted a License Premise Check at 158 E. Juneau Av. The officers were met by the wife of the current agent. The officers observed empty liquor bottles that were emptied and destroyed by employees. The Revenue Agent requested to see the liquor invoices and were led to an upstairs office, that was not a part of the licensed premise. While in the office they observed an open box of cigarettes. They were advised the tobacco was sold behind the bar. The Revenue Agent advised them that all invoices need to be kept on the license premise, and empty liquor bottles being destroyed needed to be marked with an 'X" or the label removed. They were further advised they did not have a tobacco license and could not sell any tobacco. The employee was very cooperative.

On Friday, 11/11/22 at 8:43pm, Sgt. Fawn SCHWANDT (Squad 1410) along with my partner PO Shawn SWITZER and I (Squad 1440) conducted a tavern check at 158 E Juneau Ave, DUKES on Water.

We spoke with the manager, Amanda ARANC, regarding some issues that have been occurring with the tavern over the last few months. We reiterated to the staff that they are not to allow patrons to leave the tavern with drinks in plastic cups. We also asked for the staff to help with loitering in front of the tavern. The tavern has several no loitering signs visible on the building as well. We also asked that the security staff help clear the sidewalks in front of the tavern at bar closing. Several fights have occurred outside of the tavern recently.

Security currently uses metal detectors on weekend nights. We asked that they start using them every night of the week.

The tavern staff was receptive to our suggestions regarding these issues.

INITIAL INVESTIGATION

This report is written by P.O. Lafayette TURMAN, assigned to District One, Late Power Shift.

On Wednesday, February 15th, 2023, I was assigned to Squad 1441 with PO. DUDLEY PS#030892. We were operating a marked black and white Milwaukee Police Department Chevrolet Tahoe (Car 133) equipped with red/blue emergency lights and audible siren. We were in full MPD uniforms with badges and nameplates affixed to our outermost garments. We were equipped with body worn cameras, which were activated and captured this incident.

At approximately 1:04 AM while monitoring the Bars /Taverns (Code Red) on N Water ST and E Juneau Ave, I was flagged down for a fight at Dukes on Water Bar located at 158 E Juneau Ave (which is in the City and County of Milwaukee and State of Wisconsin). Upon arrival I observed an unknown male being sprayed in the face by Dukes bar security. I then approached the victim (black male approximately 45-50 years of age) who was uncooperative and did not want to give his name or be a victim of what had occurred. I observed that the unknown male was complaining about his face so at approximately 1:15 AM, I called for Bell ambulance to respond to him for medical treatment. Andrea was able to provide us with a current liquor, and Public Entertainment Premises license. Officers POPP and ERTL checked open liquor bottles that were behind the bar for any contaminants, and located 12 bottles that were emptied and destroyed by employees of the bar. Agent DORN asked Andrea for invoices for liquor purchases that are supposed to be kept on premise. Andrea informed us that they were kept in the upstairs office and we could come up and look at them. Agent DORN informed Andrea that is not part of their licensed premise and informed her that she needed to give us permission to come up with her. Agent SCHNERING informed Andrea that they could not sell tobacco because they do not have a current license. Agent SCHNERING informed Andrea that she would be confiscating them.

At the conclusion of the inspections Agent SCHNERING reminded Andrea that invoices must be kept on the licensed premise, she must retain invoices on premises for at least two years, and to "X" or destroy labels on bottles before recycling them.
