Pursuant to sec. 125.12 of the Wisconsin Statutes, and Chapter 90 of the Code of Ordinances of the City of Milwaukee, you are hereby commanded to appear on January 5, 2009 at 9:00 a.m. p.m. at a hearing before the City's Licenses Committee to be held in Room 301-B, City Hall, 200 East Wells Street, Milwaukee, Wisconsin to show cause why your Class "B" Tavern license should not be revoked. The hearing is being initiated because of the City of Milwaukee's receipt of a signed and sworn complaint filed by Captain Anthony Smith, Commander of the Milwaukee Police Department, District Five. A copy of the above-referenced complaint is attached hereto as well as a copy of § 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes.

On January 5, 2009 at 9:00 a.m., you will be given an opportunity to speak on your own behalf, and to respond to and challenge any charges or reasons given by witnesses at the aforementioned hearing in support of a revocation or suspension of your license. You may present your own supporting witnesses, under oath, at this hearing, and you may also confront and cross-examine opposing witnesses. If you wish to do so, and at your own expense, you may be accompanied by an attorney of your own choosing to represent you at this hearing.

If you, Emantha A. Peavey, fail to appear in person before the Committee on January 5, 2009 at 9:00 a.m. in Room 301-B, of City Hall, as required by the summons, the Committee will proceed to consider the allegations of the complaint, which allegations shall be taken as true. If the Committee determines that the allegations are sufficient, the law requires that the license shall be revoked or suspended.

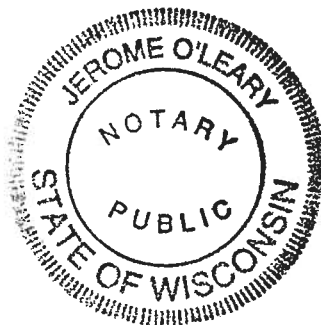

You are invited to attend a hearing on Monday, January 5th, at 9:00 a.m., in room 301-B, Milwaukee City Hall at 200 E. Wells St. Your Class "B" Tavern and Tavern Dance licenses for the premises at 333 E. Hadley St. ("Groovin Inn") may be revoked based upon sworn charges from the Milwaukee Police Department.

I have enclosed a copy of the objections filed by the Milwaukee Police Department, your license application, the documents entered into the record at the previous Licenses Committee meeting, the transcript of the previous Licenses Committee meeting and an updated copy of the police report, which is all that is currently in the file.
