Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. I hope that all is well. The first five attached photos were taken at 11pm last night. The last attached photo was taken at approximately 8am. I returned at 10:15am and the same litter was in place (with additional litter) as of 10:15am. My office connected with you on 9/12 via phone and I followed up with a letter requesting that you reach out to schedule a meeting to discuss plans that have been put in place to address the extremely high level of litter that covers the entire property. With the non-response to my request along with the continued litter issue – I am concerned and disappointed. I always start with a conversation to get cooperation, but sometimes that doesn't work.

During our last conversation – you mentioned that each individual tenant is not responsible for the exterior clean up, the landlord is. I'd just like to communicate that you have tenants at the shopping center that hold certain licenses to operate. Those licenses are in jeopardy based on the level of litter and that will be communicated with them. I will work with licensing along with Department of Neighborhood Services on this continued concern. I look forward to your response.

This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/29/23 at 1:14am, Milwaukee Police were dispatched to 7600 W. Capitol Dr, for a theft complaint. Officers spoke to the manager who stated that two subjects took items without paying for them and left in a vehicle. The manager was able to get a plate of the vehicle. Officer checked the plate and it listed to a recently stolen vehicle. The manager was cooperative with the investigation.
2. On 05/29/23 at 8:31pm Milwaukee Police were dispatched to 7600 W. Capitol Dr, for a bomb threat complaint. Officers spoke with security who stated that the business received a bomb threat 10 minutes after a regular shoplifter was denied access to the business. Officers checked the area and video looking for any bags or packages left around the business. No suspicious items were located around the area.
3. On 06/08/23 at 12:47am, Milwaukee Police were dispatched to 7600 W. Capitol Dr, for a theft complaint. Officers spoke with security who stated that at 11:00 pm, two subjects took items without paying for them. One subject had a firearm visible on his hip. The gun was visible but not used in a threatening manner. The security guard further stated that the subjects left the store in an unknown direction. The business was cooperative with the investigation and spoke with staff regarding the incident.

4. On 07/16/23 at 4:00pm, Milwaukee Police were dispatched to 7600 W. Capitol Dr, for a shoplifter complaint. Officers talked to staff who stated that a group of subjects took items without paying for them and fled in a vehicle. Officers searched for the vehicle but did not locate it.
5. On 08/22/23 at 1:24am, Milwaukee Police were dispatched to 7600 W. Capitol Dr for a shots fired complaint. Officers spoke with security, who stated that he heard a gunshot in the parking lot, coming from a vehicle leaving the lot. Officers located and recovered the casing in the parking lot.
6. On 08/28/23 at 1:00am, Milwaukee Police were dispatched to 7600 W. Capitol Dr. for an armed robbery complaint. Officers spoke to the manager who stated that a known shoplifter attempted to enter the store and he tried to stop the subject from entering. The manager stated that the suspect pushed by him and took an item to the cashier area. The manager stated to the suspect that he is refused service and to leave. The suspect took the item then left the store, the manager followed the suspect. The suspect brandished a hand gun while outside making threats to harm the manager. The manager backed away from the suspect once the hand gun was displayed. Officers reviewed video which corroborated the manager's statements.
7. On 09/20/23 at 2:05am, Milwaukee Police were parked in a police squad at the location of 7600 W. Capitol Dr. The officers were flagged down for a theft complaint outside the location. The citizen stated that a subject took items from her purse, the business was not involved with the incident.
8. On 11/18/23 at 4:10am, Milwaukee Police were dispatched to 7600 W. Capitol Dr. for a reckless use complaint. Officers approached the business which was closed but were able to contact store employees. The employee stated that earlier two subjects were kicked out by security after trying to steal items. One the subjects then returned to store and produced what appeared to be a hand gun. Officers reviewed video of the incident with the employee. The business was cooperative with the investigation.
9. On 11/20/23 at 12:35am, Milwaukee Police were dispatched to 7600 W. Capitol Dr, for a shop lifter complaint. Officers spoke with the employee who stated that a subject tried to take items without paying for them. The employee was able to get the items back from the subject, and the other employee called for police. During the investigation none of the employees were able to access the video surveillance.
10. On 02/12/24 at 12:57am, Milwaukee Police were dispatched to 7600 W. Capitol Dr, for a suspicious person complaint. The employee stated that three subjects were in the location filling up a shopping cart with items, and acting suspiciously. Two Milwaukee Police officers made a purchase in the store and the three subjects abandoned the cart of items and left the store immediately. The subjects did not returned and no crime was committed. The business was cooperative and provided officers access to the camera for the subjects description.

On Monday, May 29th, 2023, at approximately 1:14 am, Squad 7369 (myself) was dispatched to a theft that occurred at approximately 11:40 pm on Sunday, May 28th, 2023, at 7600 W. Capitol Dr (Walgreens), which is located in the City and County of Milwaukee.

Upon arrival on scene, I made contact with the shift lead and reporting person who was identified as ~~Justin D. ROGERS (M/D, 06-23-79)~~. ~~ROGERS stated that around 11:40pm, he was walking from the back of~~ the store when he observed two female subjects stealing merchandise. ROGERS stated him and another employee tried to catch them, but that the two had already entered into their awaiting vehicle and fled. ROGERS stated he didn't get a great look at the two and wasn't entirely sure how much merchandise was actually obtained. ROGERS stated he knows some food items were stolen and numerous blankets. ROGERS stated he believes the cost for the stolen property was at least more than \$100.00. ROGERS stated he closed down the business following this incident and then eventually re-opened it once I left. ROGERS described suspect one as a black female, thin build, early to mid 20's, skinny build, with brown/black braids. ROGERS described suspect two as a black female, early to mid 20's, with a skinny build. ROGERS described the vehicle and plate, or another employee did when they called 911. The vehicle that the two fled in was identified as a gray 2021 Nissan Rogue bearing FL auto QMV-C76 VIN JN1BJ1AW7MW660315. This vehicle was reported stolen through the Milwaukee Police Department under IR #23-146-0132.

ROGERS was cooperative throughout the investigation.

On Monday, May 29, 2023, at approximately 8:31 P.M. Squad 7450 (myself along with P.O. Joshua GRAMINSKE), and Squad 7421 (P.O. Michael GRUSZKA), responded to a Bomb Threat call for service, at Walgreens located at 7600 W. Capitol Dr. in the City and County of Milwaukee, Wisconsin. Upon arrival, I spoke with the security guard, identified as Darrion J KAZEE, 5-18-98, regarding the incident.

Summary of Interview of Darrion J KAZEE

KAZEE stated on Monday, May 29, 2023, at about 8:17 P.M., he was working at security at Walgreens located at 7600 W. Capitol Dr. in the City and County of Milwaukee, Wisconsin, when he observed a subject KAZEE identified as, "Lil Jojo," attempting to enter the business. KAZEE stated he knew, "Little Jojo," was a regular customer at the address, and he frequently shoplifted at the business. KAZEE stated he denied, "Lil Jojo," entrance to the building, which caused, "Lil Jojo," to be upset. KAZEE stated, "Lil Jojo," made a comment regarding KAZEE working on a holiday, in which, "Lil Jojo," stated he would help KAZEE get off of work.

KAZEE stated, "Lil Jojo," then claimed he would go to the Walgreens at 5201 N. 92nd St. because the Walgreens at the location does not have an active security guard.

KAZEE stated 10 minutes later, his co-worker, identified as Yaneysha M DIAZ DE JESUS, B/F 2/24/01, received a call claiming a bomb has been placed in the store and was about to go off.

KAZEE did not see any subject enter the store or place any suspicious package in or around the building within the ten minutes of his encounter with, "Lil Jojo."

P.O. GRAMINSKE spoke with DIAZ DE JESUS regarding the incident.

Summary of Interview of Yaneysha M DIAZ DE JESUS

DIAZ DE JESUS stated she was working as a cashier at 7600 W. Capitol Dr. in the City and County of Milwaukee, Wisconsin, on Monday, May 29, 2023, at about 8:27 P.M., when she received a phone call from the phone number, (414)587-7143.

DIAZ De JESUS stated the exact words from the phone call was, "There's a bomb in y'all store. Its finna go off."

DIAZ DE JESUS stated she did not take the phone call serious so the subject on the other line hung up the call. DIAZ DE JESUS stated she did not pay much attention to the caller because she believed it was a prank call. DIAZ DE JESUS stated she could hear a young male's voice from the other line but could not identify any more from the voice.

P.O. GRAMINSKE observed the surveillance from Walgreens but did not observe any additional subjects entering the store and leaving packages between, "Lil Jojo," attempting to enter and the phone call being made. A preliminary search through the store revealed there was no suspicious packages or bags left behind in the store. The store was then deemed safe.

Walgreen's store has a valid and posted license within the store and was able to be observed.

The workers at Walgreens had access to camera footage and were helpful in showing us footage of the incident as well as access through locked doors in the building.

This report is written by PO Anthony DAVENPORTE, assigned to District 7, Late Shift, Squad 7322.

On Thursday, June 8th, 2023, at approximately 12:47 AM, PO Andrew STEWART and I were dispatched to a Theft complaint at the Walgreens located at 7600 W Capitol Dr.

Upon arrival, we spoke with Jordan D. WALKER (B/M, 05/11/1998) who was working as a security guard at the time of the incident. WALKER stated that at approximately 11:00 PM, he observed two males who took items from the store and left without paying for them. WALKER stated he confronted them near the checkout lanes, but they denied stealing anything. We also spoke with Justin D. ROGERS (B/M, 06/23/1979) who identified himself as a Shift Lead. ROGERS stated he also observed the same two males be confronted by security and walk out of the store without paying for the items they had on them. WALKER and ROGERS both stated they observed a firearm on the hip of one of the subjects. They stated he had the gun on him, so it was visible but did not pull it out or threaten anyone with it.

The first male was described as a Black male in his mid 20's, 5'11" Dark brown complexion, black snap back style hat, 165lbs, wearing a black t-shirt, dark ash grey jeans and black shoes. The second male was described as a black male, in his mid 20's, dark brown complexion, 5'03", 145lbs, black short afro, wearing a black t-shirt, black jeans and black shoes. The unknown subjects fled in an unknown direction in a Grey Infinity bearing Amato dealership plates.

ROGERS was very cooperative during our investigation. He made sure involved employees were available for questioning and was available for the duration of the investigation. ROGERS also informed us that their surveillance cameras were operational but only the manager had access to them.
