There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/18/22 at 10:29p.m., Milwaukee Police were dispatched to a Subject with a Gun at 5321 W Green Tree Rd. Investigation revealed a patron was argumentative with other patrons in the tavern, therefore security escorted the patron out. Once outside the patron remained in the parking lot stating "I'll blow you away" to the security guard. The officers conducted a traffic stop of the patron's vehicle and did recover a firearm. The patron stated they did not have the weapon inside the establishment as they were checked for firearms upon entry. The agent and staff were very cooperative with the investigation.
2. On 02/06/23 at 12:09a.m., Milwaukee Police were dispatched to a Subject with a Gun at 5321 W. Green Tree. Investigation revealed two subjects, who were not patrons, were pacing back and forth in front of the building, whey they pulled out firearms and began to fire at the building. The suspects then began running away on foot through the parking lot, continuing to fire shots. A house near the establishment was hit, along with multiple vehicles in the area. No patrons or citizens were injured during the incident and officers recovered multiple casings both inside and outside of the establishment. The agent was on scene and all employees were cooperative with the investigation, allowing officers to view video surveillance of the incident.

3. On 02/22/23 at 11:54a.m., Milwaukee Police conducted a License Premise Check at 5321 W. Green Tree Rd. On arrival officers observes security denying access to a patron, who became argumentative with security. Once the patron observed the officers, they returned to their vehicle, and officers observed security remain calm throughout the incident. No violations were observed.
4. On 05/19/23 at 2:10a.m., Milwaukee Police were dispatched to a Trouble with Subject at 5321 W Green Tree Rd. Prior to arrival officers contacted the caller who stated they were frustrated due to loud noise coming from the business. The officer interviewed the security guard who stated there were a few small fights and arguments in the parking lot earlier and had since cleared the bar. The employees were cooperative with the investigation.
5. On 07/19/23 at 1:44a.m., Milwaukee Police were dispatched to a Tavern Violation at 5321 W. Green Tree Rd. The caller stated there were underage patrons, drinking inside the bar. On arrival officers observed approximately 15 patrons that all appeared to be of legal drinking age. The security officer was cooperative with the officers and showed them an ID reader used to verify age.
6. On 08/27/23 at 12:09a.m., Milwaukee Police were dispatched to a Noise Nuisance at 5321 W. Green Tree Rd. On arrival officer observed a large crowd of people outside of the establishment. The agent was on scene and stated they set up a sound system on the patio for people to enjoy music. The agent agreed to stop the music outside immediately.
7. On 09/02/23 at 1:24a.m., Milwaukee Police were dispatched to a Shooting at 5321 W. Green Tree Rd. The caller stated they had been pepper sprayed on shot, however, this was deemed to be not true as MFD was on scene and evaluated the caller. The agent was on scene and stated the caller had been causing a disturbance inside the bar and was trying to physically fight with other patrons, when they were escorted out and called people on the phone to come and shoot up the establishment. The agent was cooperative and allowed officers to view video surveillance of the incident.
8. On 10/01/23 at 1:26a.m., Milwaukee Police were dispatched to a Sexual Assault at 5321 W. Green Tree. Investigation revealed a sexual assault did not occur. The caller was attempting to enter and refused to allow security to search them, therefore, was denied entry. Video surveillance was observed and at no time did any security touch the caller.
9. On 10/01/23 at 9:57p.m., Milwaukee Police were dispatched to a Subject with Gun at 5321 W. Green Tree Rd. Investigation revealed an argument took place between the victim and a subject regarding the ownership or rental of a car. While the victim was inside the establishment, the other subject arrived and put a gun to their stomach and demanded the car. The victim turned over the keys and the suspect fled the scene with the car. The officers later conducted a traffic stop of the vehicle, a firearm was recovered and the suspect was taken into custody. Video surveillance of the incident was provided by the establishment.
10. On 10/21/23 at 2:00a.m., Milwaukee Police were dispatched to a Shots Fired at 5321 W. Green Tree Rd. The caller stated they observed a subject exit the bar and fire a shot into the air. The agent was on scene and stated no one from the bar fired shots, however, there was a vehicle parked across the street and fire a round into the air as they were driving away. A casing was recovered and seemed to be in the location the agent stated, not where the caller stated the incident occurred. The agent was cooperative and allowed officers to view video surveillance of the incident.

11. On 10/26/23 at 12:40a. m, Milwaukee Police were dispatched to a Shots Fired at 5321 W. Green Tree Rd. The caller stated they heard several shots fired in the area and a subject screaming near the bar. On arrival officers did not locate any evidence of shots being fired and interviewed the agent who stated they did not have any problems at the bar, nor did they hear any shots fired. The agent was cooperative and checked video surveillance for any evidence of vehicles in the area discharging a firearm, however, found none.

12. On 10/26/23 at 8:18p.m, a Milwaukee Police Officer conducted follow up at 5321 W. Green Tree Rd., to interview the agent regarding Shots Fired complaints. The officer asked the agent about a Shooting that was later downgraded to an Endangering Safety by Use of a Dangerous Weapon. The agent stated they recalled the incident and was cooperative with police and provided video surveillance of the incident. The officer then interviewed the agent regarding an incident on 09/29/29 at 2:50a.m., however, the agent stated the business was already closed at that time and they were no longer on scene, therefore, had no knowledge of the incident. The agent stated the area around their establishment has issues with shots being fired and residents always assume it's coming from the bar. The agent stated they are attending an upcoming meeting at the District to discuss the business and has recently changed their Plan of Operation to increase age limit to 25 and set in place a dress code to enter.

13. On 11/22/23 at 1:56a.m., Milwaukee Police were dispatched to a Trouble with Subject at 5321 W. Green Tree Rd. On arrival officers were met by security who stated they no longer needed police. Security stated they called just in case an intoxicated patron refused to leave on their own.

14. On 12/12/23 at 4:30p.m., Milwaukee Police held a meeting with the agent of 5321 W. Green Tree. This was in regards to recent incidents that occurred at the establishment. The agent provided the following updates regarding safety measurements to alleviate some issues:

- Reduced hours (closes at 1:30a.m.)
- New dress code
- Cover Charge for Males
- Age restriction (25 males/21 females)
- ADT system sends alerts to agents' phone regarding capacity

15. On 10/18/24 at 1:50a.m., Milwaukee Police were dispatched to a Battery at 5321 W. Green Tree. Investigation revealed security was escorting a subject out of the establishment, when another group approached and threw bleach at security and the subject. The business was cooperative and allowed officers to view video surveillance.

16. On 11/08/24 at 2:18a.m., Milwaukee Police were dispatched to a Trouble with Subject at 5321 W. Green Tree. Officers observed security escorting two groups of subjects out of the establishment. Officers ordered the groups to leave, to which they eventually complied. Security advised the subjects they were no longer welcome at the establishment. The business was cooperative.

The following items are related to New Entertainers located at 5321 W. Green Tree Rd., and the listed agent.

17. The agent has an open **Warrant** with Milwaukee County Sheriff's office.
WARRANT #2025010590, Case 2025CT001468.

18. On 11/22/24, at 2:18 a.m., officers on patrol observed a Trouble with Subject outside of the business. Security guards were attempting to escort a disorderly female from the business. A crowd formed around the scene, which security assisted officers in dispersing. The female was conveyed to her home and issued a citation for disorderly conduct.

19. On 01/16/25, at 11:02 p.m., officers were dispatched to a Battery complaint. A subject known at the business engaged in a fight with another patron. A security guard attempted to mislead officers by stating the fight occurred outside of the business and was hesitant in allowing officers into the bar area.

20. On 01/26/25, at 1:55 a.m., officer heard gunshots in the area and proceeded to the Shots Fired. Officers did locate 12 spent casing on the street a distance away from the business. Security guards and the agent were located in the business which was closed. Officers were informed that two groups engaged in a fight inside of the business and had to be escorted out. Outside both groups displayed firearms before driving away. At a second location a victim involved in the fight was reported as deceased from a gunshot wound. Officers were able to retrieve security camera footage from the business. The agent was cooperative during the investigation.

21. On 03/16/25, at 1:51 a.m., officers were dispatched to a Subject with Weapon complaint. A security guard escorted a disorderly female out of the business. The complaint of a weapon was found to be baseless.

22. On 04/01/25, at 1:20 a.m., officers were dispatched to a Trouble with Subject complaint. A disorderly subject refused to leave when asked. The subject was under the legal age to be allowed into the business. Security camera footage showed the subject entering and presenting a different form of identification to an employee at the door. No business violations observed.

This report is written by PO Khalid MAJEED assigned to District #4, Late Power Shift. On Friday, November 22, 2024, my partner PO O'Neal STAMPS III and I, assigned to Squad 4467, were on "Patrol" in the area of N. 54th / W. Green Tree Rd. when we came across a "Trouble with Subject" in the area. It should be noted that there is a bar located at 5321 W. Green Tree Rd. and located in the city and county of Milwaukee.

NATURE OF CALL/JUSTIFICATION

While on patrol we noticed security of the establishment were dealing with a female who was escorted outside of the location due to being unruly and trying to fight a security guard. PO STAMPS III and I exited our marked MPD squad car with our body worn cameras activated in full duty uniform and ordered the female to leave. After numerous orders to leave the premises, the female would not leave. Security on scene verbally stated that the female would no longer be allowed entry into the bar and that she would be banned.

Security on scene assisted police with moving along the crowd of people and encouraging everyone to leave the location. The unruly female was conveyed to her residence and she was given a c12 for disorderly conduct. The business was cooperative with police and showed no operational infractions at this time.

This report is written by P.O. Chandra FULLER, assigned to *District Four, Late Power Shift, Squad 4440*.

On Thursday, January 16, 2025 at approximately 11:02 PM, I and partner P.O. Michael SMITH were dispatched to 5321 W. Green Tree Rd., located in the City and County of Milwaukee for a Battery Call for Service. *Per the CAD, Caller was assaulted, states suspect is a minor.*

Upon *our arrival* I observed this to be a bar, Regal Begal, and the armed Security Guard verbally identified as Romaine JACKSON (b/m, 12/08/1996) as well as the caller verbally identified as Alicia MCMILLIONS GORDON (b/f, 10/05/2002) immediately approached our Squad Car.

Officers suggested to JACKSON that we go inside to talk, however JACKSON suggested that Officers talk in the vestibule area that was separated by a door that leads to the actual bar area. JACKSON reasoning for talking with Officers in the vestibule area was because of the loud music, however it was very apparent that JACKSON did not want Officers inside of the actual bar area. After speaking with JACKSON in the vestibule area, Officers informed him that we would have to enter the bar area to look at their licensing.

JACKSON stated that he got to work at 10:00 PM, it is ladies night, and there was a group of girls fighting. JACKSON stated that they didn't have an ID scanner. JACKSON stated that MCMILLIONS GORDON is a regular customer, and stays fighting with females. JACKSON stated MCMILLIONS GORDON was upset that they wouldn't let her back in the bar, and wanted a refund on the \$25.00 liquor band that she'd purchased. It is to be noted that MCMILLIONS GORDON was given a refund. JACKSON stated that MCMILLIONS GORDON got banned last year for fighting and was allowed back in the bar this year. JACKSON stated that MCMILLIONS GORDON picked up a piece of broken glass in the parking lot and tried to stab one of the females. It is to be noted that although JACKSON appeared to be cooperative, he initially mislead Officers by portraying that this incident occurred outside of the bar, instead of inside the bar.

I spoke to the caller, MCMILLIONS GORDON who called from 262-899-9690 who stated that she was assaulted and the subject is a minor. MCMILLIONS GORDON stated she arrived to Regal Begal at approximately 9:45 PM, and appeared to have some familiarity with the subject, as MCMILLIONS GORDON stated she has had problems with her in the past. MCMILLIONS GORDON was unsure of the correct spelling of the unknown b/f name, did not know her date of birth, and did not know her phone number. MCMILLIONS GORDON stated she was sitting at the bar when she heard a voice state something to the effect of "You said you wanted to fight me." MCMILLIONS GORDON stated the unknown b/f subject was hitting her, pulling her hair, and people tried to break it up. MCMILLIONS GORDON gave very vague answers when she was asked very specific questions regarding the nature of the alleged battery, prompting Officers having to ask the same question multiple times. MCMILLIONS GORDON continually stated this unknown subject "Kept trying to hit me in the face." MCMILLIONS GORDON eventually stated she was hit in the mouth, however didn't know if she was slapped or punched. It is to be noted that there was a challenge interviewing MCMILLIONS GORDON as she interrupted Officers every time, upon attempting to explain anything to her.

P.O. SMITH spoke to Agent/Owner verbally identified as Justin D. JACKSON (b/m, 12/11/1976) inside of the bar area while I look at the licenses. Per P.O. SMITH he asked J. JACKSON to walk to another area/back of the bar away from the music where it was more quiet, however it was apparent that he did not want P.O. SMITH walking any further stating "No. We can stop right here in this hall." D. JACKSON stated that he was "Upstairs" when this incident occurred, and didn't "Need this paperwork" referencing a License Premise Report. He further stated that this is bullshit that this all comes to him and he has to answer for it. The aforementioned statements led Officers to believe that this is why the staff/employees/owner did not call the Police.

Officers reviewed video surveillance footage on the armed Security Guard Romaine JACKSON cellular

phone, prior to entering the bar area to check the licenses. When asked did they have any surveillance monitors inside of the bar that Officers could look at, he stated "No." The footage depicted that this incident occurred at 10:00 PM inside of the bar, not the outside as R. JACKSON initially portrayed it. Officers observed an unknown b/f with braided her get out her seat from the bar and walk over to MCMILLIONS GÖRDON who was still seated at the bar area. The unknown subject appeared to strike MCMILLIONS GORDON at least one time before multiple patrons immediately intervened, which led Officers to believe why MCMILLIONS GORDON thought she may have been struck numerous times by the unknown subject. Security Officers escorted the unknown subject out of the bar as R. JACKSON appeared to attempt to keep MCMILLIONS GORDON inside the bar by holding his arms out, to prevent further escalation of the incident. MCMILLIONS GORDON is then observed pushing pass R. JACKSON and walking outside, appearing to be yelling, pick up a piece of broken glass and run towards the unknown subject who was walking away. It is to be noted that when this was brought to MCMILLIONS GORDON attention she acted as if she forgot to disclose this to Officers.

While on scene, I observed the licenses posted and they were not up to date. Per P.O. SMITH the Agent/Owner D. JACKSON stated the licenses hadn't came in yet.

NATURE OF CALL/JUSTIFICATION

On Sunday, January 26, 2025, PO MAJEED and I were on duty in the area of 4700 W Woolworth Ave which is in the City and County of Milwaukee, WI. While in the area, I heard multiple gunshots coming from the area of 5400 W Mill Rd. I then informed the dispatcher of the incident and proceeded to the area to investigate the SHOTS FIRED (END RESULT WAS A HOMICIDE).

Upon arrival in the 5800 block of W Mill Rd, PO MAJEED and I located approximately 12 casings in the westbound lane of W Mill Rd. While marking the casing locations, a SHOOTING complaint came over stating that a male victim was shot in the head near 89th and W Mill Rd and was believed to be deceased. The caller of this complaint stated that there was a fight with women at a bar and a vehicle

PO CATHEY and PO AWOLOLA arrived on scene and remained with the casings while PO MAJEEED and I changed locations to the Regal Beagle Bar located at 5321 W Green Tree Rd. The mentioned bar is in close proximity to the casings recovered in the street on W Mill Rd.

BAR WITNESSES and VIDEO RECOVERY

Once PO MAJEEED and I arrived and the Regal Beagle, I observed that the business was closed and the main door was secured. I was able to see inside of the building by looking through the front glass window where I observed 3 security guards inside of the bar. After knocking on the main entrance door, PO MAJEEED and I were granted entry into the establishment. I then spoke with the security company owner Romaine JACKSON (B/M 12/08/1996) who stated that there was a small physical altercation inside of the bar between a group of female patrons near bar closing time. JACKSON is the owner of his security company named GORILLA SECURITY SERVICES. JACKSON stated that his security staff, consisting of Rickey L. NORMAN (B/M 09/19/1996) and David T. CALDWELL (B/M 06/02/1989), immediately broke up the fight and escorted the two group of women out of the bar, one group at a time.

JACKSON stated that as him and his staff escorted the second group out of the building, the two groups once again attempted to fight but ultimately entered personal vehicles and left the scene. JACKSON, NORMAN and CALDWELL stated that they observed firearms being displayed by both groups prior to the vehicles leaving the area. JACKSON stated that the entire incident was captured on the security camera system on both interior and exterior cameras.

Justin D. JACKSON (B/M 12/11/1976) was also on scene and fully cooperative with this investigation. JACKSON stated that he was in the upper level of his business when the fight occurred in the bar and was informed of the situation by JACKSON after the parties left the area.


