Dear Attorney Hitt:

We have received your claim on behalf of Tyler Perales for the amount of \$19,841.96 in relation to the injuries he sustained on August 1, 2015 on the 1700 block of South 1st Street.

Our investigation determined the Milwaukee Police Department was called to South 1st Street due to reports of an electrocution as a result of an open pedestal on a light pole. Once the police department arrived, they secured the area and called the Department of Public Works. The Electrical Services Division sent an electrician to South 1st Street and the pedestal was repaired. There were no other prior complaints made to the City of Milwaukee regarding the open pedestal.

The injuries sustained by your client were not the result of any negligence of the City of Milwaukee. Therefore, the City is not legally liable his damages. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the


