While going to my van I fell over a 2 inch bump, higher than the rest of the walk. I thought I broke my knee at first. My 12 yr. old daughter was with me. Her name is Kristina Cabot. She was going to run in and get my cousin to help me. But my cousin happened to come out, because I forgot a flower she gave me. She saw me laying on the walk and asked if I was ok. I could hardly drive home because of the pain.


On December 23, 2003, I called the city of Milwaukee at 11 a.m. to report the accident. They transferred me to the city clerk, then to alderwoman Suzanne Breier's office. I told everyone I talked to what happened. The next day, I talked to my cousin's son, and he told me that they fixed it for now along with some other areas. This was on December 24, 2003.

On December 30, 2003 I finally got into the doctor. My regular doctor wasn't in, so I saw a fill in. He checked my knee which had become infected. He put me on 500mg of Cephalexin (for infection) for 10 days.

I would like to settle this matter without an attorney. I would like to file a claim in for the sum of \$500.00 for the 3 weeks of pain and suffering. I think this is a reasonable amount.

Please take care of this matter as soon as possible.
