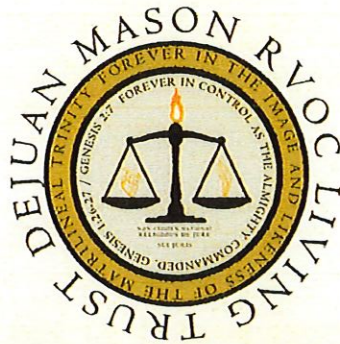

PRIVATE NOTICE

AFFIDAVIT & CLAIM FOR DAMAGES

COMES NOW, Executors of the PRECEDENT VESTED LANDED ESTATE(s), HOLDER(s) IN DUE COURSE AND EQUITABLE OWNER(s). On or about 03/31/23, at 4971 North Teutonia Ave, Milwaukee, Wisconsin [53209] about 10AM, PRIVATE CONTRACTORS d/b/a the CITY OF MILWAUKEE baring CITY OF MILWAUKEE EQUIPMENT tread upon PRIVATE PROPERTY without warrant / work order / or just cause.

- 1.) In doing so not only did these state subjects destroyed the roots of HERBS my family and I use for healing / meditation / and worship, which took three years to cultivate;
- 2.) They destroyed a large format television module whose materials were set to be repurposed for summer programming for our children.
- 3.) After reviewing the footage, they in fact loaded parts of the module into the back of the dump truck but consequently left the remaining pieces scattered.
- 4.) They left the properties grass destroyed without STATE REQUIRED NOTICE or AN OWNER'S CONSENT.

- 5.) This is in fact causing emotional distress to my wife as she is the primary cultivation(s) specialist of our living plants/ herbs / apothecary needs. This year's yield has been taken; for these Takings we must receive just compensation(s).

After finally getting my wife calm we made several calls, one of which landed me a very respectable and extremely kind MS. STACEY of the FLEET DEPARTMENT. With her, I attempted to confirm the work order number for this project and yet to no avail.

Adding insult to injury, at around 4PM the same day. POSSIBLY or WHOLLY due to the state of the yard and it's now seemingly abandoned look in appearance, AFTER the indiscretions of the CITY EMPLOYEES – we suffered another incident of Trespass at ILLEGAL DUMPING. While this may seem totally random to others, it seems inherently interconnected altogether.

WISCONSIN STATUTE(S) ON TRESSPASSING

Pursuant to 943.14 Criminal trespass to a dwelling is not a lesser included offense of burglary. Raymond v. State, 55 Wis. 2d 482, 198 N.W.2d 351 (1972).

(1m) Whoever does any of the following is subject to a Class B forfeiture:

- (a) Enters any enclosed, cultivated or undeveloped land of another, other than open land specified in par. (e) or (f), without the express or implied consent of the owner or occupant.
- (am) Enters any land of another that is occupied by a structure used for agricultural purposes without the express or implied consent of the owner or occupant.

(2) (b) "Property" means all forms of tangible property, whether real or personal, without limitation including electricity, gas and documents which represent or embody a chose in action or other intangible rights.

(3) PENALTIES. Whoever violates sub. (1):

- (c) If the value of the property exceeds \$10,000 but does not exceed \$100,000, is guilty of a Class G felony.

RELIEF SOUGHT

Having removed all doubt of who committed the offense against us with video evidence to **PETER** an INVESTIGATOR at (414) 405-8113 for THE CITY OF MILWAUKEE.

- 1.) We demand all legally applicable forms / amount(s) of restitution subject for felony damages to property pursuant and not limited to WISCONSIN statues at large concerning § 943.14 Trespass.
- 2.) **\$36,000.00 USD** for the destruction three years of cultivation(s) efforts and success to bring life to our plants / herbs. Efforts which have now been tainted and utterly destroyed by the CITY WORKERS. Recovery of this year's yield is virtually impossible and have rendered our potential to heal holistically from that part of our garden incalculable as their roots have been severed.
- 3.) We demand **\$30,000.00 USD** for the emotional distress caused in the surprise of these events.
- 4.) We seek (2) Two complete sets of any available and in working order / motorized / battery powered / hand-held / riding / gardening equipment / tools in the efforts to restore our property and its potential(s) for growth.
- 5.) We demand that the CITY OF MILWAUKEE endow us with a Land Grant of **\$60,000 – \$100,000.00 USD** for us to secure Fencing(s) / Signage(s) / and camera equipment / Property Development(s) to ensure that this property is no longer mistaken as a potential dumping site.
- 6.) These funds, now ACCEPTED as redemption(s), can / may also be in the form of Labor performed by trusted CITY of MILWAUKEE CERTIFIED LANDSCAPPERS / BUILDERS 1.) would complete said FENCINGS / CAMERA INSTALATION(S) / SIGNAGE(S) and 2.) other necessary beatification(s) per our available floor/gardening plans in conjunction with said Land Grant(s).

- 7.) We demand that the pole holding the powerlines be removed from the property: 1.) It makes for a most undesirable sight to have dangling powerlines after they been cut by a CTITY EMPLOYEE. 2.) Safety.

This matter has created a Constructive Trust for which we now accept all charges as redemption. For your convenience, we now release and assign all chattel papers and securities, given for patent rights, appointing a necessary and competent member CITY CLERK / OFFICIAL / AUTHORIZED AGENT / COMMON COUNCIL / ACTING MAYOR to fiduciary of the TRUST to settle all matters on this mutual account.
