Atty. Farris said that the commission should not consider business practices and regulatory actions of a for-profit college as those aspects were under the jurisdiction of the State.

Those who testified opposed the allowance for a new for-profit college to occupy and operate at the site due to negative impacts (predatory actions, inadequate instruction, and/or fraud) caused by such an operation and affecting the public health and welfare of the community, especially towards students who are low-income and of color, when those colleges go out of business. They cited their own past personal experiences and/or the failures of other for-profit colleges that have closed.
