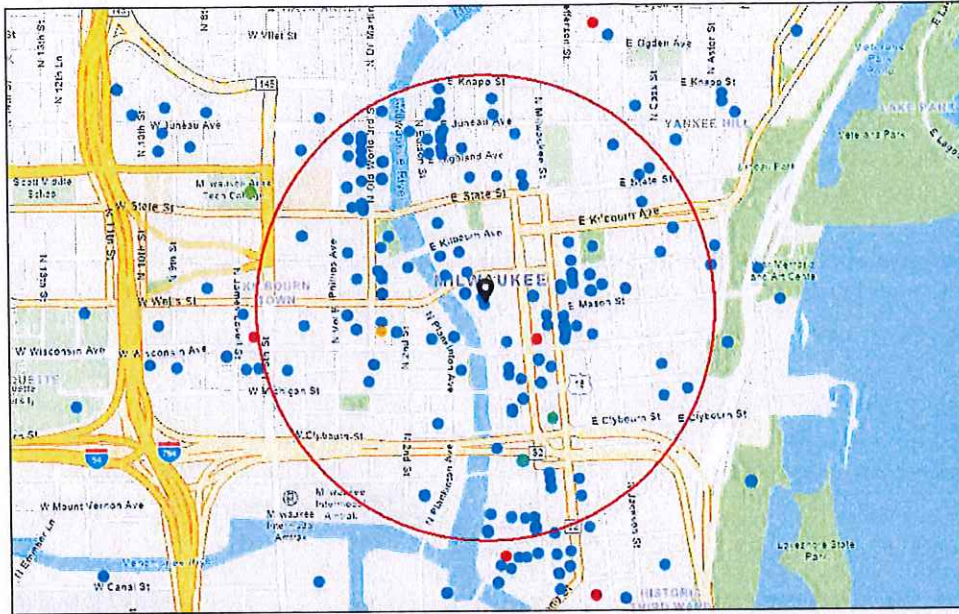


Concentration Map for 755 N Water St.

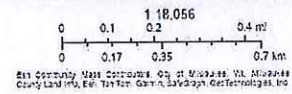



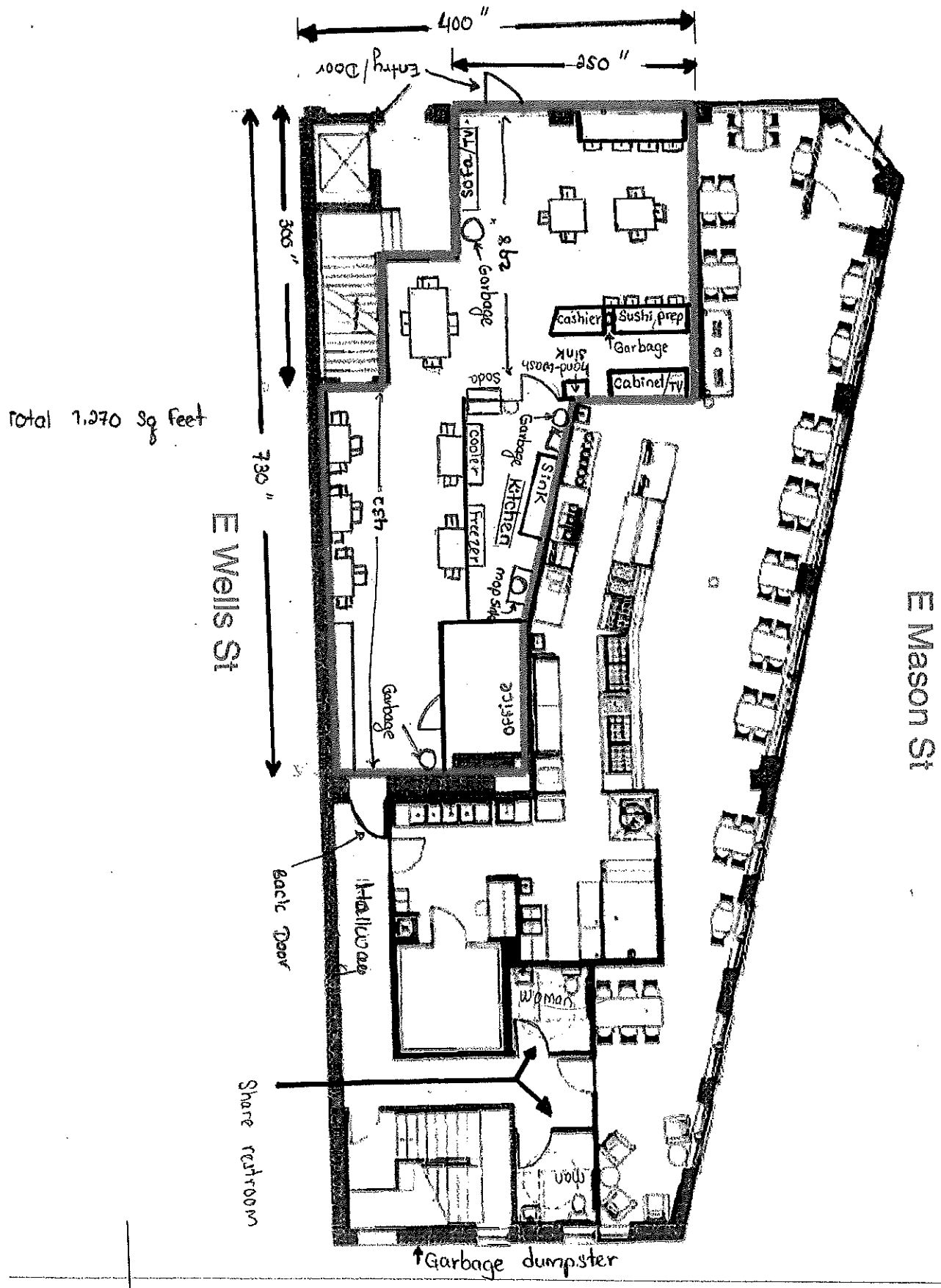
