SUMMARY

This report recommends amending Part III of the Salary Ordinance to provide a stipend of \$25 per meeting, up to 22 meetings per calendar year, to the members of the Milwaukee Youth Council as approved in the 2025 budget. Payments shall be made every three months.

Stipend for Members of the Milwaukee Youth Council

Under File 240001, the 2025 Budget includes a stipend of \$25 per attended meeting for up to 22 meetings per year for members of the Milwaukee Youth Council. Payments shall be made every three months.

At the end of each quarter, the City Clerk will provide a list of members eligible for payment, and the number of meetings each member attended, to the Comptroller's Office. Payments are to be made as soon as administratively feasible every three months.

To reflect this change we recommend amending the Salary Ordinance by adding the following paragraph under Part III – Boards and Commissions: Compensation and Reimbursement

G. Milwaukee Youth Council: Members of the Milwaukee Youth Council shall be compensated at the rate of \$25 per meeting, for a maximum of 22 meetings per calendar year. At the end of each quarter, the City Clerk shall submit to the Comptroller's Office a list of members eligible for payment together with a record of the number of meetings each member has attended during that quarter. Compensation shall be made at the end of each quarter or as soon as administratively feasible.
