There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/12/23 at 12:55pm, Milwaukee Police were dispatched to 2470 N. Martin Luther King Dr., for an entry complaint. Officers observed that two windows of the business were boarded up. Officers spoke with the manager who stated that they arrived to open the business and observed that the windows were damaged. The business was cooperative with the investigation. The manager provided officers with video that was sent via email to the police. In the video it was observed that the windows were damaged by an unknown subject in the morning. No violations to the business were observed.
2. On 10/27/23 at 12:21pm, Milwaukee Police were dispatched to 2470 N. Martin Luther King Dr., for an entry complaint. Officers spoke with the manager who stated that the front door was damaged prior to her arriving at work. The manager stated that an unknown subject damaged the door gained entry to the business and moved some files around in the office. The business was cooperative with officers and police were emailed a copy of the video. The video emailed showed the incident it's entirely.

incident. I was in full MPD uniform equipped with my issued body camera, which was activated during this incident.

On Saturday, March 3rd 2024 at approximately 5:25pm my partner PO Joshua Thompson (driver) and I (passenger) were dispatched to 2470 N Doctor M.L.K. Jr Dr, located in the city and County of Milwaukee for a subject with weapon complaint.

Upon arrival, we were met by the manager, of Kentucky Fried Chicken, Brenda S Avery (b/f, 11-10-1985) stated on 03-01-2024 at approximately 4:50pm Ashanti S Sayles (b/f, 02-04-2003) intentionally and without consent threw a brick in the business window causing approximately \$5000 worth of damage.

Interview of Avery

Avery stated on 03-01-24 Sayles came to the business at approximately 11 am. Avery stated at 4:30pm she went up to Sayles and stated she had to leave because she was scaring the customers. Avery stated Sayles then came up to the registers and poured soda all over the front counter and register and walks out of the business. Avery stated Sayles then goes to 2400 N MLK Dr and stands there yelling at the top of her lungs for approximately 15 minutes. Avery stated it at which point Sayles comes to the front of the business with a brick and throws it at the front window. Avery stated when Sayles threw the brick at the window it bounced off of the window so Sayles picks up the brick once more breaking the window.

On 03-02-01 Avery stated Sayles came back to the location at 5:25 pm and attempted to break the side window of the business. Avery stated it was at which point she comes outside and detains Sayles.

Avery stated she called her boss Humberto Sierra who was not on scene and he stated it would cost approximately \$5000 to get the window fixed, and he wanted to press charges.

Avery stated the this act was done intentional and without the consent of the business.

Avery stated she feeds Sayles daily and she believes she suffers from some mental disorder and she has never acted like this in the past.

The hearing before the Licenses Committee will take place on 1/28/2025 at 10:35AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
