Dear Council Members:

Claimants, Kristine and Larry Thimmesch, 1512 Valley View Drive, Hubertus, WI 53033, allege through their attorney, Snyder & Ek, S.C., 117 West South Street, Oconomowoc, WI 53066, that on August 5, 2012 Kristine Thimmesch sustained injuries when she tripped and fell on an uneven sidewalk at 535 South 84<sup>th</sup> Street. They claim damages in the amount of \$50,000.00.

Based on 2011 Wisconsin Act 132, Wisconsin municipalities are not liable for any damage that occurs on or after April 5, 2012 due to a defect in a sidewalk or street. Therefore, we recommend that these claims be denied.
