This office is in receipt of your claim in the amount of \$334.00, relating to injuries you allege you received during your arrest on November 30, 2002 when City police officers were making another arrest at 2603 North 47th Street.

The police department records indicate they responded to a situation involving Lisa Haynes at 2603 North 47th Street. The report notes you interfered during the process of Ms. Haynes' arrest, as a result, you were also taken into custody. The Milwaukee Police Department followed standard procedures in this matter, and as such, the City cannot accept liability for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
