If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/31/10, Milwaukee police were dispatched to 3079 N Holton Street for a Shooting complaint. Officers spoke with Parwinder Bhagat who stated on at approximately 8:00 pm, a male subject entered the store and bought a bottle of liquor. The subject became angry and made a statement to Bhagat stating, "You mother fuckin Arabs come to this county to make money" and then threw Bhagat to the ground and punched him in the face, head and back 15 times causing pain to Bhagat. Bhagat stated he ran to the back room and locked the door. The subject then began kicking and punching the door causing damage. The subject was on scene when police arrived who received several citations. Police also spoke with Herishr Kumar who is also a clerk for the store and was he was questioned as to why he called stating that someone had been shot. Kumar stated that Bhagat was getting punched so he wanted police to come. Kumar was issued a citation for Misuse of 911. No citation was found in the municipal court system.

The officer asked the business closing time and the clerk stated 9pm. The officer advised that all customers must be out of the store by closing time. 6. On 05/11/2019 a 17-year-old working in conjunction with the Milwaukee Police and the WI WINS Tobacco Initiative was able to purchase a Black and Mild cigar from the clerk at 3079 N. Holton St, who did not ask for ID. The clerk admitted the sale stating he was on the phone and not paying attention. The applicant was mailed a citation for the violation.

On 04/21/19 at 08:59pm, PO David LETTEER and I conducted a random license compliance check at CORNER LIQUOR II located at 3079 N Holton Street. Upon arrival inside the store, I observed (1) patron attempting to purchase items from the cashier. I asked the cashier later identified as Manpreet SINGH what time their business closes, SINGH stated 09:00pm. I informed him that if the business was closed that the patron needed to leave and he was not allowed to sell items to him. The patron then left the store.

PO LETTEER and I informed SINGH and the other employee identified as Jagit SINGH (W/M 08/24/66) that we were there to inspect their business licenses. PO LETTEER asked if Manpreet SINGH had a Class D License. He stated that he did not, however that Jagit SINGH did. Jagit SINGH showed PO LETTEER his posted Class D License while I inspected the dairy products and checked the store for signs of rodents. All dairy products were up to date, and I did not observe any signs of rodents. We informed both employees that we would be generating a report regarding our inspection and that we would be in contact with the store licensee.

THIS REPORT IS WRITTEN BY P.O. DENISE RUEDA ASSIGNED TO THE LICENSE INVESTIGATION UNIT. ON SATURDAY MAY 11, 2019, I WAS ASSIGNED TO WORK THE WISCONSIN WINS YOUTH TOBACCO INITIATIVE, CHECKING AREA VENDORS FOR AGE COMPLIANCE TOBACCO PURCHASES. ASSISTING IN THIS ASSIGNMENT WAS STEFFANY D. GARCIA (W/F, 04/02/2002, OF 5517 S. 26TH STREET). GARCIA IS 17 YEARS OF AGE WHICH IS NOT OF LEGAL AGE TO PURCHASE TOBACCO.

AT APPROXIMATELY 11:46AM, GARCIA ENTERED CORNER LIQUOR II AT 3079 N. HOLTON STREET AND PURCHASED 1-PK OF SWISHER SWEET CIGARILLO CIGARS, GARCIA STATED THE CASHIER DESCRIBED AS A YOUNG MIDDLE EASTERN MALE WITH SHORT BLACK HAIR AND FACIAL HAIR WEARING A BLACK SHIRT W/GRAY UNDER SHIRT NEVER ASKED HER FOR AN I.D. AND SOLD THE TOBACCO TO HER ANYWAY. I ENTERED THE STORE AND IMMEDIATELY IDENTIFIED THE CASHIER BASED ON THE DESCRIPTION GIVEN. THE CASHIER WHO WAS THE ONLY EMPLOYEE IN THE STORE IDENTIFIED HIMSELF AS MANPREET SINGH (A/M, 09/23/98). SINGH DID ADMIT TO SELLING GARCIA THE SWISHER SWEET CIGARS AND NOT ASKING FOR HER I.D., SINGH FURTHER STATED THAT HE THOUGHT HE SAW GARCIA BEFORE IN THE STORE AND HAD PREVIOUSLY CARDED HER SO HE KNEW SHE WAS OF AGE. SINGH WAS ADVISED THAT THE AGENT WOULD BE CITED FOR THIS VIOLATION.

The hearing before the Licenses Committee will take place on 9/10/2019 at 10:00 AM, in Room 301-B, Third Floor, City Hall. If you wish, you may provide testimony at the hearing regarding the request; see below for further information. You are not required to attend the hearing. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing. Please review the information below and if you have further questions regarding this process, please contact the License Division at (414) 286-2238.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

Dear Alderwoman Coggs,

I just saw your shared post on Facebook regarding preliminary City approval for a boutique hotel at 419 West Vliet Street. My husband and I live on the corner of 5th and Reservoir. We love our community and try to stay involved. This new hotel sounds like a wonderful conversion of a historic building but I wanted to share some concerns regarding the Days Inn located at 1840 North 6th Street, which is across the street from our home. We understand that Mr. Rajani and Mr. Prabhu also operate this property. Since we purchased our home in October, 2017, we have noticed concerning activity in and around the hotel. Sadly, we were unable to attend the Council meeting regarding the hotel's license/permit less than a year ago to voice our concerns. Honestly,

this past winter was fairly uneventful so we were hopeful what we suspected was drug activity and prostitution was under control. However, in the past 6 weeks, we have observed no fewer than 5 instances of women, parking vehicles and/or being picked up outside the hotel on Reservoir or in the alley behind the hotel. In addition the trash and overall condition of the property has not improved with the continued development of the Deer District and what appears to be increased business of the Days Inn. I believe other neighbors and the neighborhood association have previously voiced concerns. As the owners seek to operate additional hotels in the area, we simply want to make you aware of our concerns as neighbors of the existing business.

PRABHU was advised that based upon their admission of operating without a license during the committee hearing that they would be issued 1 citation for each week they are determined to have operated without a license.

PRABHU stated that the hotel has been taking the following steps over the past several months to a year to combat illegal activity at the Hotel, such as prostitution and drug dealing:

- Security patrol in parking lot and exterior of business from 9pm to 7am. Daytime security personnel have other responsibilities so it is not monitored as closely during the day.
- Hotel personnel conduct background checks (CCAP) and get ID cards from every customer.
- Entrance doors are locked in the evening and overnight and patrons must be buzzed in by employees.
- Monitored phone numbers given by patrons on "backpage" and other sites for possible illegal activity
- Age policy, patrons must be 21 years old or above. Anyone below 21 must be accompanied by parent or have written parent permission.
- Have drawn up plans for a smoking patio only accessible from inside to combat loitering outside the front doors.
- Claimed to have an open door policy with Police and grant access to cameras and ledgers.

The following recommendations were made to PRABHU to better business practices in relation to deterring illegal activity:

- Conduct a CPTED survey with District 5 CPU personnel
- Human Trafficking training for all employees, with assistance from Sensitive Crimes
- Purchase ID scanner
- Don't allow rooms to be rented after 10pm without a reservation

PRABHU was receptive to possible changes and said the business would be cooperative with law enforcement moving forward.

**** BODY CAMERA EVIDENCE WAS CAPTURED ****

On 01/26/19 at 02:32am, PO David LETTEER and I (SQ#5468) conducted a Tavern Check at 1422 W Atkinson Ave (STEWART'S REST SPOT). Upon arrival, I observed (4) patrons leaving the bar and walk to nearby cars. As PO LETTEER and I attempted to enter the tavern the front door was locked. PO LETTEER began to knock on the door to an attempt to gain someone's attention inside. I could hear people inside of the bar say "it's the police" shortly after the interior lights began to turn off.

After a brief moment a woman identified as Gloria RAGSDALE (B/F 09/06/63) opened the door for PO LETTEER and I. RAGSDALE stated that she was one of the bartenders. Upon entry into the tavern there were (7) persons inside including the bartender. I observed (4) patrons sitting at the bar with drinks on the bar in front of them. PO LETTEER informed RAGSDALE of our Tavern Check and asked for all of the licenses for inspection. RAGSDALE did not know where any of the licenses were and needed to make a phone call to verify where they were located. While on the phone, RAGSDALE moved some liquor bottles behind the bar and located the licenses folded up behind the bottles.

RAGSDALE stated that she started work at approximately 07:00pm, and the other bartender identified as Dedra Y. MCCASKILL (B/F 04/01/78) began her shift at approximately 10:00pm. I made contact with MCCASKILL who was sitting at the bar with a drink next to (2) other patrons. MCCASKILL stated that she did not have a copy of her Class-D License. MCCASKILL stated that it was located in her vehicle which was currently in the auto shop. Upon checking with LIRA there were neither an application nor a license for MCCASKILL.

I made contact with Oliver L. CATHEY (B/M 04/14/80) who stated that he was the "Security / Bouncer". CATHEY stated that he started his shift at approximately 10:00pm. I asked CATHEY
