This report is written by Police Officer (PO) BUKOVSKY, assigned to District 5 Late Power Shift.

On 04/08/2023 my partner PO Dominique PRICE and I (Squad 5428) were dispatched at 2115hrs for an Entry at 2011 W Capitol Drive, which is the business CASH4GOLD and is located in the City and County of Milwaukee.

Dispatch stated the suspect had tampered with the security system / cameras and was unknown if still inside.

We arrived at 2117hrs and viewed a single broken front windowpane to the listed business at the listed address. Ourselves and Squad 5463; PO SANDOVAL AND PO ARNOLD held containment on the business until the Manager Medhai I. ISMAIL (W/M 09/29/1959) who was enroute to the listed address with keys arrived.

ISMAIL arrived at approximately 2120hrs and gave me keys to the front door and gave permission to clear the business. ISMAIL stated it was unknown if the suspect was still inside due to the suspect allegedly tampering with the security system.

Officers cleared the business after receiving the front door keys from ISMAIL, no persons were located inside.

Once the building was safe, I had ISMAIL enter his business to inventory for missing property. One item / property was taken per ISMAIL:

One security DVR system; SuperSonic model # SC5004NVR, No serial number available, valued at \$350.00.

Further investigation revealed the Entry / Burglary began at approximately 2050hrs per a motion sensor. This information was recorded by ADT Security Company per their representative. The representative gave this information to me while on speaker phone with ISMAIL per my request.

2003 W. Capitol Dr. does not appear to have cameras facing the location and no persons answered after knocking.

I added information onto the business computer and Pete Thelen from RISSPROP remotely took control of the computer adding the needed software, so items could be uploaded in RISSPROP. Peter remotely gave Medhat a demonstration, which Medhat stated he understood. There were Milwaukee secondhand ordinance signs posted in his business and Medhat stated he did not need a copy of the city ordinance because of being in business for years. I left him with my contact information and the follow-up was concluded.

This report is written by Police Officer Joshua TRYAN-HERNANDEZ, assigned to District 5, Early Power Shift, Squad 5222. I was operating a marked black and white MPD squad car, vehicle 102, equipped with the MDVR system which was not activated during this incident. I was in full MPD uniform equipped with my issued body camera, which was activated during this incident.

On Friday, June 7, 2024, at approximately 11:09 AM, my partner Jermaine BRISCO (passenger) and I (driver) were dispatched to Threat/Theft at Cash and Gold, 2011 W. Capitol Dr. During the investigation, the incident was determined to have occurred at 3760 N. 10th St, located in the City and County of Milwaukee.

Upon arrival, victim identified as Desmin L. WARD (b/m, 03/26/1990) reported jewelry (14k Byzantine chain worth approximately \$9999.01 dollars, and a 10k yellow gold Diamond Frame pendant worth approximately \$7,800 dollars) being stolen from his home address of 3760 N. 10th St. WARD reported last seeing the jewelry at his residence on Monday, June 3, 2024, at 8:00 AM and realized the jewelry missing from his first-floor bedroom dresser on Tuesday, June 4, at 9:00 AM. WARD reported his live-in cousin identified Quentin A STURDIVANT (b/m, 11/09/1972) admitted to him on Thursday, June 6, 2024 taking the jewelry prior and selling to Cash and Gold for money. WARD reported STURDIVANT being a known drug user. STURDIVANT on scene at Cash and Gold admitted to taking the jewelry to officers.

Upon arrival on scene at the Cash and Gold business was WARD, STURDIVANT, David L. HAWTHORNE (b/m, 10/20/1957), Cash and Gold owner/employee identified as Medhat M ISMAIL (w/m, 09/29/1959) and Off duty Milwaukee Police Officer Darrell OWENS. During the investigation, Squad 5217 (Sgt Andrew KEMPEN) also responded to the scene.

CAD comments read "CALLER STATES THAT THE OWNER AT THE LOCATION IS BUYING STOLEN JEWELRY FROM PEOPLE AND STATES HE IS REFUSING TO GIVE HIM BACK THE ITEMS/CALLER IN STORE ARGUING WITH THE OWNER/ NFI/CLLR MAKING THREATS TO HARM EMPLOYEE/CLLR STS THAT THIS IS THE 4RD TIME HE'S CALLED AND OFFICERS HAVEN'T SHOWED UP AND HE'S UPSET THAT STORE OWNER IS RIPPING OFF PEOPLE WITH DISABILITIES - CLLR STS THAT THIS IS AN EMERGENCY - NFI/CLLR CHECKING STATUS // HE IS UPSET ABOUT THE RESPONSE TIME AND STS THE SITUATION IS ESCALATING /// AND STS HE IS FLASHING HIS HAND LIKE HE HAS A GUN BUT DID NOT SEE ONE // NFI/LR CHECKING SQD STATUS - STS HIS COUSIN STOLE APPROXIMATELY \$20,000 WORTH OF JEWELRY FROM HIM AND PAWNED IT AT THIS SHOP ON 6/4/2024 // CLR STS HE HAS HIS COUSIN WITH HIM, WHO IS ADMITTING TO HAVING STOLEN THE JEWELRY, AND CLR ALSO HAS THE RECEIPTS, HAS OFFERED TO BUY THE JEWELRY BACK, BUT THE PERSON AT THE STORE IS INSISTING CLR'S JEWELRY WAS NOT PAWNED HER/CLR STS HIS COUSIN ALSO DID NOT HAVE PROPER I.D WHEN HE PAWNED THE JEWELRY, YET THE STORE STILL ACCEPTED THE I.D

AND ALLOWED THE PAWN TO OCCUR/"

HAWTHORNE reported he did not see the jewelry being taken. HAWTHORNE reported on "Monday or Tuesday" he was at the location of 3760 N. 10th St in his bedroom upstairs with the "tv too loud". HAWTHORNE reported hearing someone enter the residence and did call out "whos that? whos that?" HAWTHORN reported he did hear STURDIVANT admit to taking the jewelry by saying he did it.

I interviewed ISMAIL at the location of 2011 W. Capitol Dr. ISMAIL reported being at the business and working when STURDIVANT entered his business on both Tuesday, June 4, and Wednesday, June 5, 2024. ISMAIL reported no transaction was made regarding any jewelry and the encounters were only two to three minutes. ISMAIL reported on Thursday, June 6, 2024 at approximately 4:30 PM, WARD and HAWTHORNE came into his store. ISMAIL reported WARD told him his jewelry was lost and there was no mention of the jewelry being stolen. ISMAIL reported on Friday, June 7, 2024, WARD came to his business and wanted "20k" or his jewelry returned. ISMAIL reported WARD became upset and would say "lets settle this man to man". ISMAIL reported he told WARD to contact the police. ISMAIL did report there being video footage of inside the business, but he kept in a different part of the building which he did not have access to until Friday, June 7, 2024, after 5:00 PM. ISMAIL provided no further information.

On Saturday, June 8, 2024, at approximately 11:10 AM, I spoke with the Cash and Gold Employee, ISMAIL, on his cellphone of #414-444-7777. ISMAIL reported he had reached out the individual involved in getting to access the video footage which can only be done from the upstairs unit of the building. ISMAIL reported he had no received word yet. ISMAIL reported he would only have the exterior video footage as the inside camera systems have been stolen numerous times. ISMAIL reported the other camera views do not currently record. It should be noted when I was in the office of the business on Friday, June 7, 2024, I did observe three camera view of the business, one which would include an interior view.

As of Saturday, June 8, 2024, at 4:50 PM, video surveillance has not been viewed yet.

During the initial investigation, a check of Risk.net which shows all transactions licensed businesses make, did not reflect any purchase of the necklace or pendant by the Cash and Gold business or by STURDIVANT. A Weights and Measures license on property were observed to be up to date with an effective date of 10/14/2022 and expiration date of 10/13/2024. The Second-hand license on property was observed to have an effective date of 10/14/2022 with an expiration date of 10/13/2023. Both licenses were listed to Haba A. TAYLOR for the listed address of 2011 W. Capitol Dr and business of Cash N Gold. A Certificate of Occupancy from City of Milwaukee Department of Neighborhood Services was shown to have been issued on 09/29/2014 and issued to Travel Maker, LLC for the use of Second-hand store. There was a notice on the attached certificate which did state "Separate Precious and Gems Dealers license required". There was a Wisconsin Business Tax Registration Certificate listed to Travel Maker LLC with expiration date of 05/31/2016 observed. There was a Precious Metal and Gem Dealer's License with a Subtitle of Transactions Conducted Off Premises listed to Haba M. ISMAIL of Travel Maker LLC and expiration date of 10/13/2017 observed. There was a Wisconsin Department of Revenue Seller's Permit issued to Travel Maker LLC also observed (no expiration date on the permit).

On Wednesday, June 12, 2024, at approximately 1:57 PM, my partner P.O. Jermaine BRISCO and I

conducted follow-up at Cash N Gold, 2011 W. Capitol Dr, located in the City and County of Milwaukee.

The store employee/manger involved, ISMAIL, was at the location. ISMAIL reported and was adamant he did not buy the stolen jewelry involved with this incident. ISMAIL gave consent for store to be searched. I had ISMAIL sign a Department Consent to Search Authorization form. The stolen jewelry was not located in side the business of Cash N Gold. ISMAIL provided a phone number (PH: 224-661-1300) of a known jewelry street dealer who he reported might be involved. ISMAIL reported he did not observe this jewelry street dealer at any point with the stolen jewelry in question.

It should be noted, P.O. BRISCO had responded to same location on Tuesday, June 11, 2024, and had obtained a USB containing video footage of the exterior of location. The video footage was uploaded to Evidence.com.

This camera view is from the eastside of the building and facing northwest towards the main entrance of the Cash N Gold and W. Capitol Dr. The video footage is shown to be approximately an hour behind of actual time when occurred.

Capitol Dr. STURDIVANT is wearing a multi-colored t-shirt, grayish pants, and white shoes. Video is 44 seconds long.
