Dear Jim Owczarski,

Happy New Year! My name is Daryl A. Parker. The purpose of this email is to communicate an incident I recently experienced. On January 1st at approximately 2:15pm, I ran over an unidentified Pothole while driving North on 27th Street. The incident occurred at the intersection of North 27th Street and West Fairmount Avenue (i.e. *I think this is District 1*). Immediately after running over the unidentified Pothole, I heard a very loud noise and noticed my front end leaning. As I pulled over to the side, out of the street, several people came out of homes in the area and inquired about what happened and my well-being. I am thankful that I did not have any bodily injuries as a result of running over this unidentified Pothole. It is my understanding that all claims and related information should be submitted to the City Clerk within 120 days of the event. As City Clerk, I trust

that you will communicate with those in leadership position to ensure that such Potholes are identified and repaired to prevent any possible tragedies as well as minimize liabilities to the City of Milwaukee.

In closing, I have submitted an Online Street Maintenance Service Request and received an electronic response. The Online Service request number is 101003010299. Enclosed with this letter of incident are photos from the location intersection, unidentified Pothole, and my vehicle. I had my vehicle towed, it is currently being repaired, and I will follow-up with you and provide the receipt(s) of the expenses incurred. 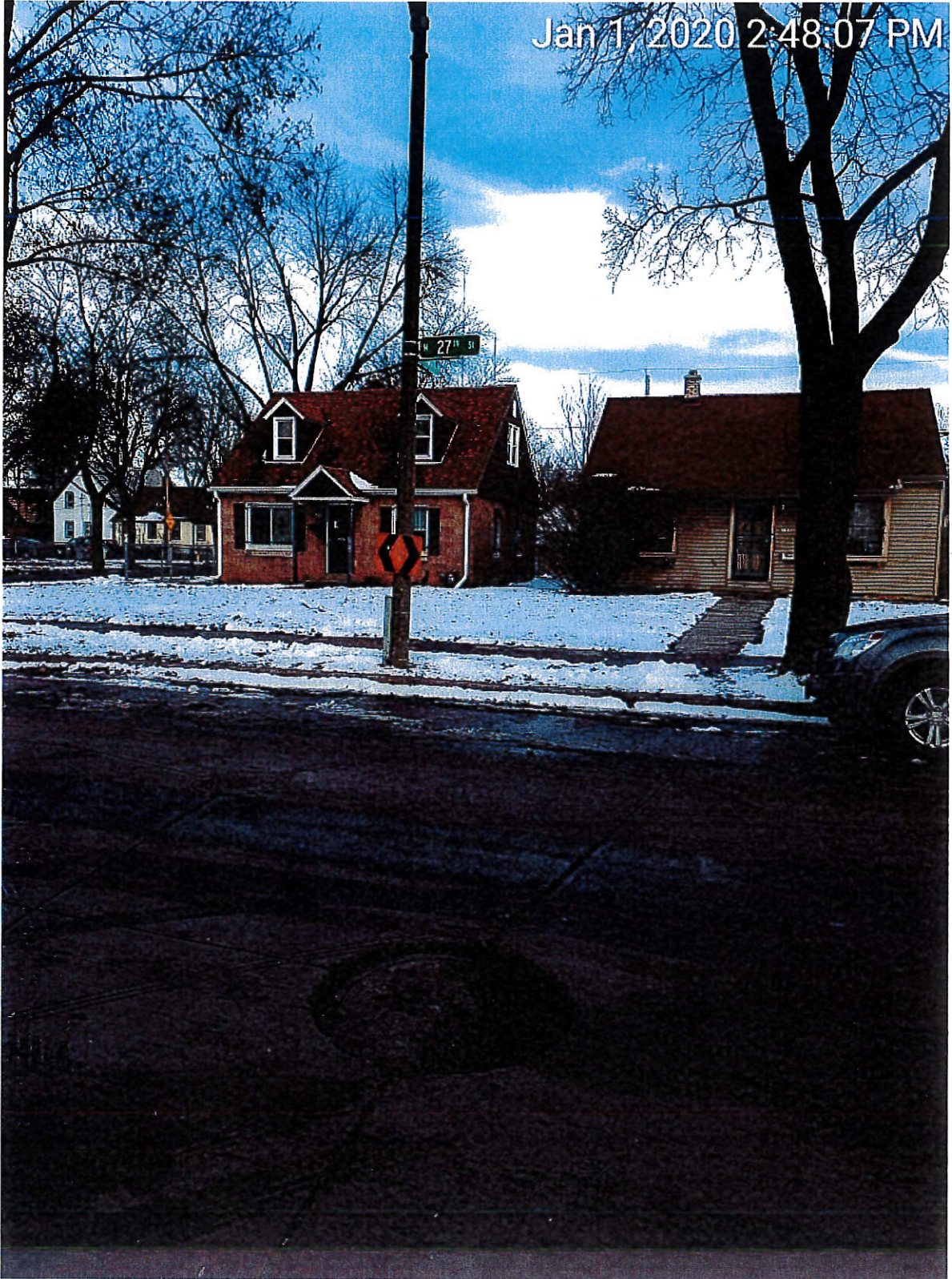

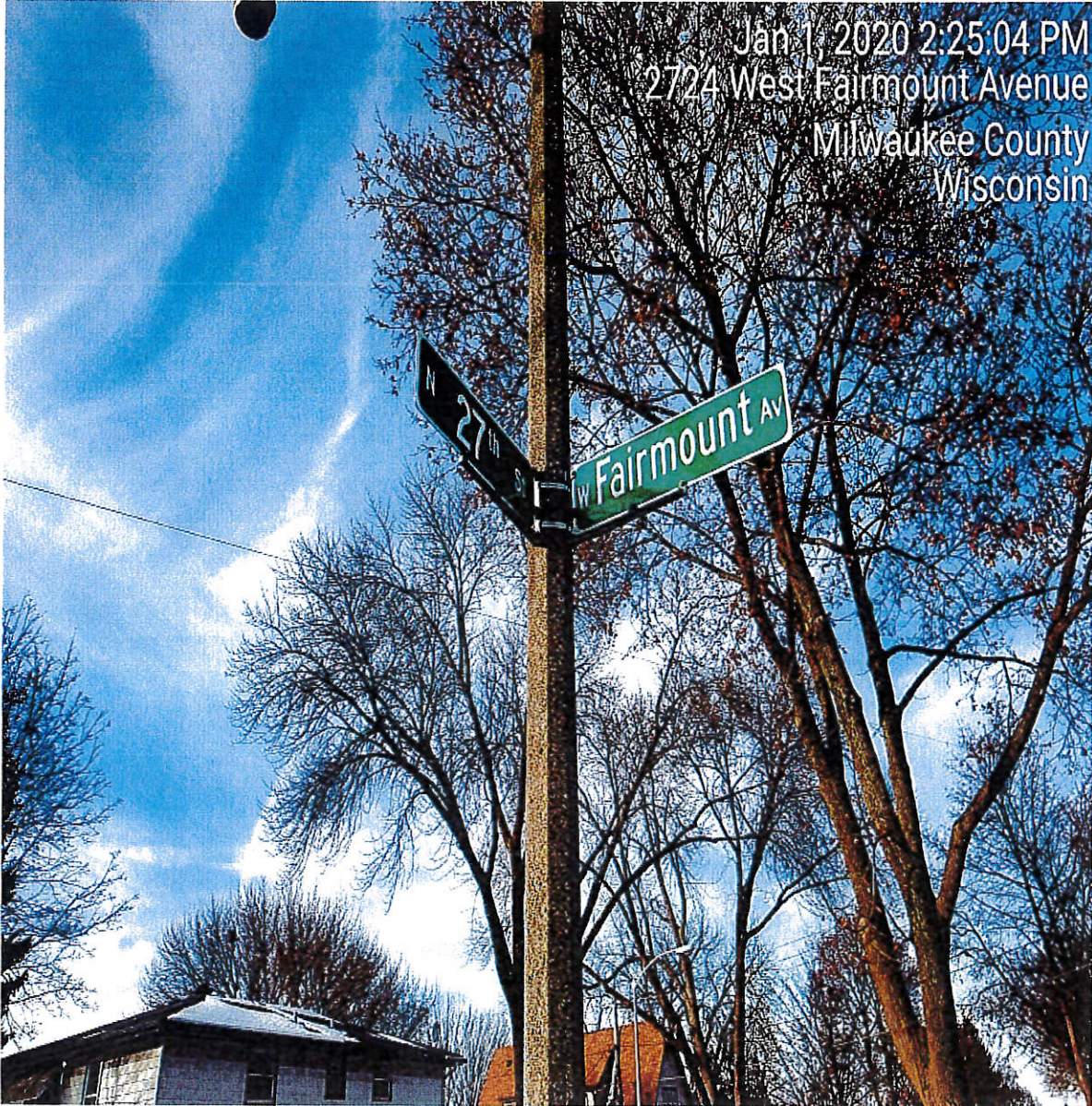
