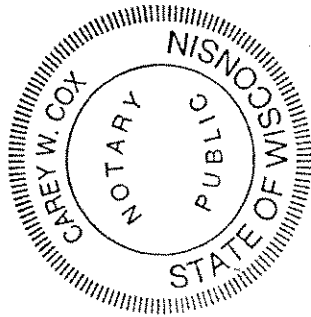

Notice is hereby given that an ordinance (passage of which is now pending) was introduced at the September 6, 2006 meeting of the Milwaukee Common Council, the essence of which is as follows:

Substitute ordinance relating to the change in zoning from Industrial Heavy to Industrial Mixed, on land located on the North Side of West Pierce Street and West of South Cesar Chavez Drive, in the 8th Aldermanic District.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-801-3.001. The zoning map is amended to change the zoning for the area bounded and described by the zoning line within the right-of-way of West Pierce Street: a line 220 feet West and parallel to the west line of South 16th Street, a line 197 feet North and parallel to the north line of West Pierce Street, a line 412 feet West and parallel to the west line of South 16th Street, thence Northwesterly to the zoning line within the right-of-way of West Reynolds Place, thence South 58 deg. 26 min. 14 sec. West 54.4 feet, thence Northwesterly along the zoning line to the southerly parcel of line, thence North 137.47 feet, thence East 132.56 feet, thence North 140.90 feet, thence West 132.50 feet, thence South 129.81 feet, thence West 18.91 feet, thence South 12.65 feet, thence West 87.36 feet, thence Southwesterly 174.94 feet, thence South 52.10 feet to a point along the zoning line within the right-of-way of West Pierce Street from Industrial Heavy (IH) to Industrial Mixed (IM).

Notice is hereby further given that the foregoing matter will be given a public hearing by the Committee on Zoning, Neighborhoods and Development in Room 301-B, City Hall, 200 East Wells Street, Milwaukee, Wisconsin, on Tuesday, October 17, 2006 at 9:00 A.M., pursuant to the provision of Sub-Section (7)(d) of Section 62.23 of the Revised Statutes of the State of Wisconsin.

PLEASE NOTE a) Members of the Common Council and members of its Standing Committees who are not members of this Committee, may attend this meeting to participate or to gather information. Therefore, notice is given that this meeting may constitute a meeting of the Common Council or any of its Standing Committees, and must be noticed as such, although they will not take any formal action at this meeting.

b) If you have difficulty with the English language, you may bring an interpreter with you, at your own expense so that you can answer questions and participate in the hearing.

c) Upon reasonable notice, efforts will be made to accommodate the needs of disabled individuals through sign language, interpreters or other auxiliary aids.
