This report was written by PO Talan MILLER, assigned to District 5 Late Shift. While on duty, while wearing a full duty uniform, equipped with an activated Axon body worn camera, assigned to marked Milwaukee Police SUV 65539, assigned to Squad 5331, with my partner PO Joel ROEKER.

On August 27th, 2024, at 5:25 am, we were dispatched to 3474 N Holton St, which is located in the City and County of Milwaukee, regarding an Overdose Complaint.

Upon arrival, to the outside gas station parking lot, we were met by Captain LIEBHERR of MFD E18 Green Shift, who stated the patient, later identified as Eric D HUGHES (B/M 10-10-1997) took some form of a narcotic and was found down. The crew of E18 administered 4mg of Narcan, 2mg intranasally and 2mg intravenously, causing HUGHES to wake up.

I briefly spoke to one of the gas station attendants, however, there was a significant language barrier, but they seemed very concerned for Mr. HUGHES.

While on scene, I observed the licenses posted and they were up to date. During my investigation of the Overdose Complaint, I did not observe any violations in the licensed premise.

On Sunday, July 27th, 2025, at 1:45 pm, my partner PO. PETTY., and I, while in full duty uniform, wearing an activated, AXON, body worn camera, and marked "POLICE" squad car, we were dispatched to a Threat complaint, located at 3476 N Holton St, which is in the City and County of Milwaukee.

Upon arrival, we spoke to the caller, identified as WALTER J MITCHELL B/M 09/27/1983. (It should be noted. MITCHELL is not an official employee of this business. The owner just allows him to keep the store clean and stock items) who stated an older B/M was yelling at him in the store. Nothing got physical with the male subject. MITCHELL stated the male subject and self-exchange words. MITCHELL stated he and the male subject never reached each other 's personal space and never used visual cues that they were having an aggressive exchange of words. MITCHELL stated he chased the male subject away from the location. MITCHELL stated he did not want to press charges. He just wanted to inform law-enforcement of the incident.

I didn't spoke to licensed premise. I do not recall entering the business on official Police duties and our exchange with MITCHELL took place outside of the location from what I recall.

While on scene, I didn't observe the licenses posted and if they were up to date.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 1/27/2026 at 10:50 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
