This report is written by P.O. Larry LEIBSLE, District 3, Late Power Shift.

On 01-16-20, Squad 3465, P.O. Andrew KEMPEN and I responded to a Shotspotter Alert at 3708 W. North Ave. for a single gun shot in gas station parking lot. This alert was under FLEX ID number 354687. After this shot spotter alert was dispatched, two additional alerts were received and dispatched other squads, 1 block to the west.

Upon arrival, we found that the gas station was currently in operation. We found a single brass 9MM casing near the east gas pump in front of the station. We also discovered a 9mm cartridge approximately 10 feet to the north of the casing.

P.O. KEMPEN went into the store and spoke with the store employees regarding this incident. The cashier, Amandeep SINGH, who was working behind a heavy glass enclosure stated that he didnt hear any gunshots prior to our arrival.

There was a black male on scene who stated that he was a security guard/ janitor for the store and observed a black male, 40-50 years old, medium build, wearing a black jacket enter the store and purchase items. The subject then walked out of the store and once in the parking lot near the east gas pump began to shout and an unknown subject. It was then that the subject pulled our a handgun and fired one shot into the air. The subject then walked west from the location. The security guard stated that he was outside when the shot was fired and immediately went back into the store.

The security guard, despite several attempts by P.O. KEMPEN to obtain his information, refused, stating that he didnt have to give his information and didnt want to get involved.

No other witnesses were located due to a large vacant field across the street to the south, and two closed businesses to the east and west of the gas station lot.

The casing and cartridge were numbered before being photographed and then recovered. These were then placed on inventory by P.O. KEMPEN under INV# 20001994.

We did observe surveillance cameras on the exterior and interior of the building. However, the camera

The hearing before the Licenses Committee will take place virtually on 1/5/2021 at 10:50 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
