This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 11/07/2020 at 3:45pm officers were dispatched to a Subject with Weapon complaint at McDonald's, 7170 N. Teutonia Av. The officers spoke with an employee, who stated customers were in the store without masks on and were asked to leave. These customers often come in the store and cause trouble. The employees went outside to fight the customers and one of the employees was hit with a shovel. The business was cooperative with officers and provided interior video of the incident.
- 2. On 02/20/2021 at 4:55pm officers were dispatched to a fight at McDonald's, 7170 N. Teutonia Av. The officer interviewed the manager, who stated two employees were in a verbal argument. He was able to separate the subjects but both employees made phone calls and two groups of people arrived in cars. These subject began fighting each other. All parties were gone when the police arrived. The manager did not have access to the employee records to give the officers their contact information. The manager also did not have access to the camera system, stating the general manager had access.

INITIAL INVESTIGATION

This report is written by PO Travis WEYMIER assigned to District 4, Early Shift.

On Saturday February 20, 2021, Squad 4241 (PO YANG and I), were dispatched to 7170 N Teutonia Av located in the City and County of Milwaukee for a Fight Complaint at approximately 16:55.

Upon arrival, Squad 4241 did not observe any active fighting occurring inside the restaurant or any fighting outside of the restaurant. Officers spoke with the shift manager Curtis G TILLMAN (b/m 07/27/83), who stated two employees began a verbal argument inside the restaurant while working and only knows them as "Shauntayvia C" and "Taliyiah H", but was unable to provide further information due to not having access to information. TILLMAN stated the arguing became more intense and he was able to calm both parties.

TILLMAN stated at which point, he observed at different times, both parties on their cellphones talking about the incident. TILLMAN stated after several minutes multiple unknown people arrived in vehicles, entered the restaurant and began to argue with each other and then began to physically fight each other. TILLMAN stated at which point he had another employee call for police while attempting to break up the fighting.

TILLMAN stated that the parties separated and entered vehicles and fled the location. TILLMAN stated both the employees that were involved fled the location as well. Officers were unable to locate anyone who may have been battered. TILLMAN stated he does not have access to employee information and well as no access to the cameras inside the restaurant. TILLMAN stated the store manager who has access is currently on vacation and returns Monday.

Follow up will be conducted to review video, locate employees, as well as identify actors involved in fight, and to speak with store manager regarding incident.

INITIAL INVESTIGATION

This report is written by P.O. Khalid MAJEED assigned to District #4, Late Power Shift. On Saturday, November 7, 2020 my partner P.O. Ngeung YANG and I, assigned as Squad 4245, were dispatched to a "Subject with Weapon" complaint at 7170 N. Teutonia Av. (McDonalds). This is located in the City and County of Milwaukee.

Upon our arrival to this location which is a single standing fast food restaurant, I observed multiple people standing around in the parking lot. I then noticed a b/f, with a torn shirt walking around the parking lot very aggressively with her fists balled. PO YANG attempted to speak with the unknown b/f, but the woman refused to talk to police. This unknown b/f, stated "They tried to jump us!" The unknown b/f, stated she did not need medical, she didn't know who the suspects were and that she did not need police. This unknown b/f, refused to speak with police regarding.

I spoke with Sarayha A. MILLER (b/f, 11-13-01) who stated she works at McDonalds and was in the bathroom at the time when the unknown suspects were in the lobby of the restaurant arguing with other employees of the business. MILLER stated these customers always come into the business and attempt to fight employees and cause trouble. MILLER stated the customers were asked to leave the establishment because they refused to put on masks. MILLER stated she went outside along with other employees to fight the customers after her manager told her and other employees not to go outside. MILLER stated "I was fighting the mama, and somebody hit me with a shovel." MILLER stated she doesn't know who hit her with a shovel. I observed a knot on MILLERS forehead and Paratech 137 arrived on scene for medical clearance.

MILLER was conveyed to Froedtert regarding. MILLER was admitted to Froedtert by doctor Johnathan RUBIN at 5:22pm. MILLER did not suffer a concussion or any internal bleeding. I observed camera surveillance on scene at the McDonalds on the inside of the building which showed employees trying to get outside to fight the customers. McDonalds staff stated they will work on retrieving the outside cameras and will call police to pick up the video if and when they retrieve the footage.

STUARD stated that police are always welcome to view and receive camera surveillance when we need it. McDonalds staff were very helpful and cooperated with police. I gave STUARD, and MILLER a MPD Community Contact Card regarding.



The hearing before the Licenses Committee will take place virtually on 6/22/2021 at 11:20 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
