This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/18/23 AT 12:05p.m., Milwaukee Police were dispatched to a Subject with a Gun at 8207 W. Brown Deer Rd. The manager advised the officers a subject entered the store and they believed, but had no evidence, the subject was stealing. The manager followed the subject outside and confronted the subject, when the subject displayed something shiny. Fearing for their safety the manager went back into the store. The manager advised the officer they would provide video of the incident for follow up.
- 2. On 04/18/23 at 3:51p.m., Milwaukee Police were dispatched to a Shoplifter at 8207 W. Brown Deer Rd. The officers were advised two suspects stole towels due to the manager refusing to give them change.
- 3. On 05/11/23 at 8:21p.m., Milwaukee Police were dispatched to a Battery at 8207 W. Brown Deer Rd. The officers were advised by the caller/manager, they were locking the store up for the night, when they observed a citizen was still in the store. As the citizen walked past the manager, the citizen pushed past the manager. An argument ensued and the citizen stated they would shoot up the place. The manager stated they would email the video of the incident to the officers.
- 4. On 05/29/23 at 7:10p.m., Milwaukee Police were dispatched to a Theft at 8207 W. Brown Deer Rd. The officers were advised two subjects entered the store and removed items, leaving the

- store without paying. The caller provided a description and last known direction of travel to the officers.
- 5. On 06/13/13 at 5:48p.m., Milwaukee Police were dispatched to a Threat at 8207 W. Brown Deer Rd. Investigation revealed two customers became upset over the long wait to check out. When the manager advised them, they could go to another store down the street, one of the subjects stated "they would have someone come back to the business and shoot". The manager stated one of the subjects *may* have had a gun, but they did not actually see one.

He stated that he then approaches her about stealing and that is when an argument began which led them to the parking lot. He stated that while they were arguing the unknown female partially displayed a shiny object which he stated could have been a handgun, but he was not absolutely sure. That is when he went back into the business and called 911.

The manager was fully cooperative and stated he would send us possible video of the incident so that we could conduct follow-up.

Upon arrival we spoke to Cornelius LEWIS (M/B, 3-20-92) who is the store manager. LEWIS stated that around 8:10pm he was starting to close the store for the night and was standing at the front sliding doors preparing to lock the doors. While closing the doors LEWIS observed there was still a citizen in the store.

The citizen observed LEWIS and began walking towards the exit of the store. LEWIS stated that he was standing partially in the doorway and the subject pushed past LEWIS while exiting the store. LEWIS stated that he and the subject exchanged words. The subject then stated that he would shoot the place up which caused a disturbance.

The subject left on foot west on W. Brown Deer Rd.

Upon arrival at approximately 5:53 P.M., officers interviewed the manager/caller, verbally identified as Cornelius LEWIS (M/B, 3-20-92, 414-248-5897). LEWIS stated on today's date, at approximately 4:20 P.M., he was checking out customers at the above location when two subjects became upset due to the long wait time. LEWIS stated he advised the two subjects that he was the only person available, but if they did not want to wait, there was another Dollar Tree location down the street. LEWIS stated the subjects began creating a disturbance, and he asked them to leave the business. LEWIS stated while the subjects exited the business, one of them stated, "They would have someone come back to the business and shoot."

LEWIS stated the subjects entered a 2021 white Hyundai Kona bearing WI registration of AJW1856, VIN # KM8K2CAAXMU715440.

It should be noted LEWIS stated one of the subjects may have had a handgun in her waist, but he did not physically observe it.

Officers observed no video surveillance of the incident.

Officers went to the listed address of the vehicle, 3507 N 91st St. No contact was made with anyone at the residence.



The hearing before the Licenses Committee will take place on 10/17/2023 at 9:55 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
