I am seeking reimbursement from the City of Milwaukee for damages my vehicle sustained on February 17th 2009. The specific amount I am seeking is \$354.17.

On February 17th 2009, at about 6:45pm I was driving South on 70th street. At the intersection of 70th and Dickinson, my vehicle rode over a sewer in which the cover was off. The impact caused my rear left tire to go flat and my rim was ruined. The tire was punctured on the side and was not fixable. A piece of the rim shattered also making it not repairable. I called Milwaukee Police, incident call #090481408. A patrol officer, Carlos Rutherford arrived about 20 minutes later. The sewer cover was laying about six feet from the hole in the center median. Officer Rutherford rolled the cover to the sewer and put it back in place. He told me he would call the City DPW and let them know about it. I then returned to my vehicle and waited for AAA to put my spare donut on.
