On December 23, 2024 I sent a check to the Milwaukee sanitation field office for a special pick up of wood pallets. Before the city came for pick up, we noticed passersby were randomly picking up pallets with just one remaining pallet, so I called to cancel the city special pick up.

On 1/21/25, inspector Rick Cervantes arrived and pasted a blue violation notice on my door. Again, at that time only one pallet and a few small scraps of wood were left. I explained to the inspector why we canceled the special pick up and stated that we would remove the pallet and scraps immediately, which we did. This is recorded on our ring security camera. He told me he was going to "rip up the violation", and I could do the same.

Late on 1/23/25 we received a letter from the City of Milwaukee DNS stating we do in fact have a violation. Within 24 hours, on 1/24/25, I called DNS at 286-2268. I was told that a reinspection was scheduled for Tuesday 1/28/25, but now she would cancel the re-inspection since the remaining pallet had been removed and was going to the dump on 1/25/25. Thirty minutes later I received a called back stating the re-inspection order was already filed and would be happening that day (1/24/25) and she stated there was no way to stop the order even though I had just received the letter on 1/23/24 and had called DNS within the 24 hours of learning that I did in fact have a violation.

I don't know why the inspector told me the violation was voided, but because he did, I had no reason to call DNS after our 1/21/25 conversation with me believing the violation was voided.

Once I received the letter on 1/23/25, I called DNS on 1/24/25, within the 24 hours. If he had told me on 1/21/25 that the violation was in effect, I would have called DNS within the 24 hours as instructed on the blue violation notice.

Attached is a copy of the email I sent to inspector Cervantes on 1/24/25. I did not receive a reply.

I feel this violation is in error and a direct result of the information I was given on 1/21/25 when the inspector told me to disregard the notice.

Hello Rick,

I am a City of Milwaukee resident that you spoke with last week on January 21, 2025. You pasted a solid waste violation on my front door and I came out and talked with you about the one wood pallet and 2 small pieces of board in front of our property at 3780 South 3rd Street. You told me you were going to rip up the violation and I told you I would move the pallet, which we did. Yesterday, Jan. 23rd, I received a letter from the city DNS stating that I do in fact have a violation. I called today, the number 414-286-2268 and was told that there was a re-inspection scheduled for Tuesday. I told DNS that the pallet will be moved off of my property and taken to the dump tomorrow, so she was going to cancel the re-inspection. Shortly after she called me back and said the reinspection was already filed and going to happen TODAY, and that she has no way to stop the re-inspection, even though I just received the letter yesterday and called within 24 hrs of learning I actually DID have a violation. When you left my property on January 21st and said you are ripping up the violation, I had no reason to call DNS. My mail is delivered after 6 PM and I call today, within 24 hrs of the USPS letter, and they tell me I'm going to get a stop charge fee and also if the inspector has already been there and saw a pallet in my front yard garden, I will get an additional fee.

I don't know why would you tell me the violation was being discarded and then I receive a letter well after the 24 hour deadline. I will be appealing any charges and will have to explain how this happened.
