The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/31/2018 the applicant was cited in the City of Milwaukee on 13<sup>th</sup> St for

2. On 11/21/18 at 2:05am, Milwaukee Police conducted a tavern check at 3261 S. 13<sup>th</sup> Street (El Tucanazo). Upon entering the establishment the officers observed 6 subjects inside (4 sitting around the bar with open beer bottles, 1 behind the bar, and one working in the back area). The person behind the bar, who was intoxicated, told the people inside that everything was alright because the tavern does not have to close until 2:30am. Officers informed the person that she was wrong and that the tavern should have closed at 2:00am (in actuality, the hours of operation on that particular day was 11:00pm according to the license). The person behind the bar then became argumentative with officers and said the people inside were employees, until one of the people sitting at the bar stated that she was not an employee. The applicant was informed of the violation and issued a citation #19009560. The citation was dismissed on 02/27/19.

3. On 09/22/2019 at 3:41am officers were dispatched to a Noise Nuisance call at El Tucanazo Taqueria Y Mariscos, 3261S 13<sup>th</sup> St. When the officer arrived they could hear music coming from the restaurant. The officers found the door locked. As they knocked they observed a female turn off the lights and walk to the back area, ignoring the officers. On 09/23/2019 the officers went to the business to speak with the applicant. An employee called him and he responded to the scene. He stated he did not know about the incident and would attempt to get to the bottom of it. the applicant was mailed a citation for Noise Nuisance.

4. On 02/16/2020 at 2:23am officers were dispatched to a Battery complaint at El Tucanazo Taqueria Y Mariscos, 3261S 13<sup>th</sup> St. When the officer arrived at the business it was closed. The officers were then advised the victim had gone to the hospital. The victim stated he arrived at the bar at 1:30am, had two beers and was waiting for food. He stated he was sitting at the bar when another customer hit him in the head with a gun. The victim stated the owner told him to hide, because the subject might kill him. He said she also told him to not call the police. The officers conducted follow up and spoke with the bartender, who stated the subjects were sitting at the bar and got into an argument. The argument escalated and the subject hit the victim with a gun. The bartender denied telling the victim to hide and to not call the police. A check revealed the business hours in LIRA are listed at 11:00am to 11:00pm.
5. On 03/25/2020 at 5:32pm officers were dispatched to check the business at 3261 S 13<sup>th</sup> St. The caller stated the business was serving patron inside and vehicles were parked outside for 20 minutes. The officers spoke with the applicant, who stated he had 5 take-out orders all day and the only person inside was his delivery driver. The officer did not observe any customers in the store and the chairs were on the tables. The applicant was reminded to have patrons who order food inside to wait outside until the food is ready.

6. On 12/16/2020 at 3:17am officers were dispatched to a Noise Nuisance at 3261 S 13<sup>th</sup> St. The officers arrived at 3:23am and heard loud music coming from the bar/restaurant. The blinds were closed but they could see three people inside but could not see what they were doing. The officers knocked and announced for several minutes before someone opened the door. The subject identified herself as the wife of the owner. The officers advised her the music was too loud and alcohol could not be served after bar close. The female did not seem to understand so the officer repeated the warning in Spanish and English. The caller wanted to remain anonymous but did advise the officer this was an ongoing problem after bar close.

## Narrative (1)

### LICENSE PREMISE REPORT

Bouzek, Matthew J 019706

12/17/2020

This report is written by PO Matthew BOUZEK, assigned to District Six Late Shift on Squad 6322, along with PO Edgar RODRIGUEZ.

On Wednesday, December 16th 2020, at 3:17 AM, PO RODRIGUEZ and I was dispatched to the location of 3261 S 13th St (**EL TUCANAZO TAQUERIA Y MARISCOS**) regarding a Noise Nuisance complaint. It should be noted that both PO RODRIGUEZ and I were equipped with functional Axon body worn cameras which did capture this encounter in its entirety.

Upon arrival at 3:23 AM (which is well past closing/serving time) both officers heard loud music coming from within the bar/restaurant. I observed all the window coverings to be pulled down as to conceal what was occurring inside the establishment. I began to look through the small openings inside the blinds in an attempt to view the inside of the restaurant. I did observe at least three individuals inside the bar area, but could not see exactly what they were doing.

PO RODRIGUEZ was looking into the glass entrance door, and also observed at least three individuals inside the bar area. Both officers began knocking on the exterior windows and door, but the individuals inside appeared to refuse us entry inside. I began to flash my flashlight inside the window to assure I was getting their attention, but yet I was still ignored. PO RODRIGUEZ continued to do the same actions all while the individuals appeared to purposely ignore our actions. PO RODRIGUEZ began to identify ourselves as Milwaukee police officers in both English and Spanish language too. I observed two of the three individuals get up from a seated position within the bar area, and walk towards the rear kitchen area.

After a few minutes of trying to obtain compliance, I heard a female's voice speaking in Spanish. PO RODRIGUEZ once again identified ourselves as police officers, and the female subject allowed us entry inside. As PO RODRIGUEZ spoke to the women in Spanish I obtained the license information that was posted to the wall. It should be noted that the women identified herself as **Tatiana FLORES (w/f, 12-31-1987)**, and that she is the wife of the owner. Also, I observed that she was definitely intoxicated by the way she was speaking, and also running into objects.

I overheard FLORES begin to argue with PO RODRIGUEZ when he was attempting to explain to her that the music volume was turned up to high, and that it is illegal to serve alcohol after legal bar close. PO RODRIGUEZ explained to me what FLORES was arguing about, and that she wasn't "getting it". Once again FLORES was advised in both English and Spanish that she can't have the music volume up so high, and that serving alcohol after legal closing time is highly illegal, and that she would be subject to

monetary fines.

FLORES was provided with a PF-6 Community Contact card, and was advised to contact the police, or the City if she has any further questions regarding this matter. The actual caller from this incident wished to remain anonymous. However, we did speak with him briefly upon our initial arrival on scene. The caller stated the tavern/restaurant often plays loud music far after "bar close", and also serves additional alcohol after legal closing time.

You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
