Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 08/31/20 at 4:17pm, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a subject with weapon complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Investigation revealed that an argument happen between a boyfriend and girlfriend where the boyfriend threatened to damage her vehicle with a bat. The girlfriend left and the boyfriend was waiting for a ride to leave the premises. Management told the girlfriend that she would also have to leave the motel.
2. On 10/18/20 at 9:33pm, Milwaukee Police were dispatched to a fire at 5253 S. Howell Avenue. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Upon arrival, officers assisted at putting out the fire and tended to subjects who had jumped out a second story window. The employee who was working at the time was cooperative with police.
3. On 12/02/20 at 4:54am, Milwaukee Police were dispatched to 5253 S Howell Avenue for a battery complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Investigation revealed that two subjects were involved in an altercation over cigarettes. One of the subjects was uncooperative.

4. On 12/02/20 at 4:57am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a trouble with subject complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Upon arrival, officers interviewed security who stated that the motel has a curfew and he was refusing to let an occupant back into the facility after curfew hours. Another patron of the motel was also arguing with security because he feels the curfew is unconstitutional. Both subjects were gone upon police arrival.
5. On 12/06/20 at 4:20am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a fire complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Investigation revealed that the tenants in one of the rooms left the bathroom fan on which caused it to short circuit, causing a fire inside the wall. The fire was contained to the bathroom and there were no injuries.
6. On 12/07/20 at 10:25am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a welfare of citizen complaint. Upon arrival, officers interviewed the caller who stated that he is disabled, was dropped off two days ago at the motel, and does not want to be there. He refused medical and does not have any complaints. Officers told the caller he could leave at any time.
7. On 12/09/20 at 11:34am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a welfare of citizen complaint. Investigation revealed that a subject, who stated that she is bi-polar and appeared to be having a manic episode, needed money to get her hair done. After talking with the subject, it was found that she was not suicidal/homicidal, and became calm. Officers interviewed the front desk employee who stated the motel is being run by Milwaukee County as a warming place for the homeless and to curb the spread of COVID.
8. On 12/09/20 at 12:28am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a trouble with subject complaint. Investigation revealed that a subject, who was there because Milwaukee County is utilizing the motel for the homeless population, did not feel safe there and wanted to leave. He refused any medical or police assistance and that a Milwaukee County supervisor was responding to the scene regarding a new placement for him.
9. On 12/09/20 at 6:38pm, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a trouble with subject complaint. Upon arrival, officers learned that the motel refused to allow a subject, who has been staying there since December 1st, to re-enter his motel room. Officers interviewed the front desk employee, who refused to identify himself and was uncooperative with officer, stated that his boss did not want the subject back in the motel even though there was no paperwork or documentation stating that he was discharged. The clerk then called his boss who has the title of Community Intervention Specialist with the Department of Health and Human Services Housing Division and he told officers that the subject was not allowed in the motel. The clerk and "boss" were uncooperative with police and still refused to allow a disabled amputee inside the motel where he had been staying.
10. On 12/10/20 at 04:30am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a trouble with subject complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Investigation revealed that a subject was banging on the walls causing a disturbance to other motel guests. The subject told officers that she has mental health issues and banging on the walls helps her calm down.
11. On 12/10/20 at 09:44am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a property damage complaint. The location is currently being used by Milwaukee County as a

homeless shelter and is not open for business. Upon arrival, officers were confronted by a subject at the front door yelling at them to shoot and kill her. Officers interviewed security who said that the subject took off all her clothing, threatened to jump off the second floor balcony, and destroyed all the objects in the lobby. The subject was conveyed to MCMH.

12. On 12/17/20 at 11:00am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a sexual assault complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Investigation revealed that a sexual assault did not occur but the subject was having thoughts in her mind about past incidents. Security on scene was cooperative.
13. On 12/17/20 at 1:00pm, Milwaukee Police conducted a virtual meeting with Milwaukee County Housing who is using the address of 5253 S. Howell Avenue for a temporary housing/warming shelter. Things discussed at the meeting were; the process for referrals and placement at the location, the high volume of calls for service at the motel, proper staffing, and ensuring case workers were being assigned to each individual at the location. The group collectively agreed to having meetings on a regular basis's to discuss these issues.
14. On 12/17/20 at 5:01pm, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a threat complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Investigation revealed that a subject who was staying at the motel was verbally and physically threatening to the employees. He was also not following the rules and drugs were found in his room. The subject was arrested.
15. On 12/18/20 at 11:55pm, Milwaukee Police were dispatched to 5253 S. Howell Avenue for welfare of citizen complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. The caller was called by phone and she stated everything was fine and the subject who was making suicidal statements was in her room now sleeping.
16. On 12/18/20 at 08:18am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a property pick up. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. The subject who wanted his property picked up because he was evicted from his room, had left and would call back later.
17. On 12/17/20 at 11:00am, Milwaukee Police were dispatched to 5253 S. Howell Avenue for a welfare of citizen complaint. The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Investigation revealed that the subject was fine and was not a threat to herself or others.

The location is currently being used by Milwaukee County as a homeless shelter and is not open for business. Surveillance footage revealed that one subject struck another in the hallway of the motel. Curtis stated that they were both sleeping in their room when he heard a noise coming from the bathroom. Shortly after Curtis notice the sudden loss of power in the room and went into the bathroom to investigate. After opening the bathroom door Curtis observed a large amount of smoke and some fire from the bathroom wall. Curtis notified the only on-duty employee, front desk security officer later identified as CARRASQUILLO, Jose L (W/M, 01-14-1991) who then called 911.

I spoke to CARRASQUILLO who stated that he heard the fire alarm go off and smelled smoke. CARRASQUILLO stated that he was alerted by Curtis of an ongoing fire. CARRASQUILLO stated that he call 911 and started to evacuate the other hotel residence.

Observation

I observed a charred metal container located on the north wall of the bathroom, along with fire damage along the north wall and ceiling of the bathroom. MFD advised me that they believed that the bathroom fan was the point of origin and that it short circuited which resulted in a fire inside the bathroom wall. I did not observed any fire damage outside the bathroom. It should be noted that Curtis did advised me that they left the bathroom fan on when they went to sleep.

No injuries and estimated damages to be around \$1,000.

At approximately 7:04 pm, Squad 6430, P.O. Jordan HEMMING and P.O. Dennis TOMASINO were dispatched to a trouble with subject complaint at 5253 S. Howell Ave. (Super 8 Motel), located in the City and County of Milwaukee.

Upon arrival, Squad 6430 was already on scene and was speaking with both parties. The caller for this assignment was later identified as **Keith M. LONDON (B/M, 5/6/73)**. P.O. TOMASINO spoke with LONDON who stated that he left the hotel earlier today to go to the hospital by ambulance and when LONDON arrived back at the hotel, the employee working there refused to let him back inside his room.

P.O. HEMMING spoke with the front desk employee who refused to identify himself and stated that he was a volunteer who was working there. There was a security personnel on scene who stated that the front desk employee does work there. The front desk employee stated that LONDON cannot come back into the hotel room because he is disabled and there is no one currently at the hotel who can take care of him. The front desk employee stated that LONDON has been at the location since December 1, 2020 but left today and him, along with his "boss", did not want LONDON back inside. The front desk employee did not have any paperwork or documentation that LONDON was discharged from the hotel. The front desk employee was described as a black male, approximately 30 years old, 5'06", heavy build, approximately 220 lbs., scruffy beard and was wearing a black hoodie and black jeans.

At some point, the front desk employee was on the phone with his "boss" and stated if officers would like to speak to his boss. The front desk employee pointed to a business card that was attached on the front desk and stated that was his "boss." I observed that the business card had the name "Ryan Hurse" with a title of Community Intervention Specialist with the Department of Health and Human Services Housing Division. P.O. TOMASINO spoke with the subject over the phone and left the phone on speaker mode. During the conversation, P.O. TOMASINO identified himself and attempted to explain the situation to Ryan but he interrupted P.O. TOMASINO multiple times and stated that LONDON cannot come back to the location. P.O. TOMASINO asked Ryan how long has LONDON been staying at the location at which time Ryan replied that it was irrelevant. Ryan stated to P.O. TOMASINO that Ryan knows the law because he took a realtor law class. Ryan refused to identify himself and stated that did not matter. The subject over the phone, Ryan, was extremely uncooperative during this entire investigation. The front desk employee was also very uncooperative and stated several times that he did not want LONDON back into the location because there was no one there to take care of LONDON. The front desk employee was advised that they cannot just discharge someone for leaving to go to the hospital and if they don't want LONDON there, they need to have discharge paperwork or evict LONDON. The front desk employee was advised that he and Ryan cannot discriminate LONDON because he is an amputee and is disabled.

I read the Emergency Hotel Stay Guidelines from the City of Milwaukee CDGA-Milwaukee County Housing Division-IMPACT and did not find anything that LONDON may have violated or anything that says LONDON could not return to his hotel room after leaving to go to the hospital.

I spoke with the security personnel who stated he works for a private company and is separate from the county. The security stated that his boss received an email from a county supervisor stating that LONDON cannot come back to the location because there was no one there that was capable of taking care of LONDON. I again advised the security personnel that if there was some discharge paperwork,

LONDON would not be allowed back into the hotel and the county cannot discriminate LONDON because he is an amputee and is disabled. The security personnel advised me that the hotel was currently being used to house the homeless population due to the COVID-19 outbreak but did not have any other information. The security personnel was issued a contact card (PF-6) and was cooperative.

LONDON was advised of the situation and was very cooperative and understanding during the entire investigation. LONDON stated he still has some belongings inside of his hotel room# 120 and because we never gained access inside, it is unknown where his property is or whether it has been discarded. LONDON was advised that if his property was discarded without his consent, he could call the police regarding. LONDON was issued a contact card (PF-6).

The agenda of the meeting was to discuss the process of referrals and placement to the location, and to discuss the high volumes of Calls for Service since location has open up for temporary housing /warming center.

During the discussion the issue of proper staffing was addressed and ensuring case workers were being assigned to each individuals. It was agreed that the location needed more staffing to handle the amount of individuals at the location.

Individuals are placed at the hotel by 211 Impact. Officers and other organizations cannot drop individuals off without a referral. Individuals are assigned a room. They are allowed to come and go from the location. The location has a 10pm curfew.

Individuals sign an Emergency Shelter Voucher Agreement. This agreement also goes over additional guidelines they must follow. The voucher states the individuals placed at location do not have tenancy rights and may be asked to leave the location at any time.

The group collectively agreed that meeting on a regular basis to discuss the issues at this location may assist with reducing the Calls for Service to this location and help with better managing the needs of the individuals at the location.

Upon arrival I spoke with ERIC L GAVIN (m/b 12 -01-1986) GAVIN was very agitated and had a strong smell of alcohol on both his clothing and breath. GAVIN kept calling me a "Bitch" and a "bitch ass nigga" and refused to cooperate with any attempt of an investigation. SUPER 8 management stated that GAVIN was homeless and staying at the motel. As part of the rental agreement GAVIN is to abide by the rules of the Super 8, including maintaining absolute sobriety and wear a mask to prevent the spread of COVID-19. GAVIN was aware of the rules. Today, GAVIN refused to wear a mask on premises stating that he had asthma, to which he did not disclose earlier as part of his rental agreement GAVIN refused to comply with this measure and acted in a disorderly manner by threatening the Super 8 staff, security and guests in the motel lobby area. On Friday, December 18th, 2020, my partner Officer Katherine STEWART, and I, while on squad 6269 were dispatched location of 5253 S Howell Ave which is the Super 8 Hotel (City and County of Milwaukee) for a Battery complaint.

Upon arrival we were met by public safety officer Luis E. CRUZ (h/m 04/08/1980) who was able to show myself and my partner video surveillance footage of the incident which depicts a black male subject wearing a dark hoodie and a female subject in the hallway of the hotel.

The footage goes on to show the black male subject struck the female subject one time and both later walk out of frame.

I then spoke with the victim Tirzah M. ANGLIN (b/f 12/07/94) who stated she was in the hallway of the hotel when she was approached by the black male suspect and he began to yell at her. ANGLIN stated while the suspect was yelling at her he then struck her with one hand in the bottom jaw slipping down to her neck causing her face mask to fall off and also causing her pain. It should be noted that ANGLIN stated this was done to her intentionally and without consent. ANGLIN stated she does not know the suspect and has only seen him a few time the three days she has been at the hotel. After reviewing the video footage with public safety officer CRUZ we were able to observe the suspect go inside of room #227 after the incident.

We then went the room and made contact with the suspect later identified as Padrein K. KERN (b/m 12/22/79). KERN stated he was in the hallway after warming up some food in the microwave when ANGLIN approached him and started to yell at him. KERN stated he has never spoken to ANGLIN and does not know why he was yelling at her. KERN then stated that ANGLIN got into his personal space so to remove her from his personal space he pushed her way.

It should be noted that upon making contact with KERN he appeared to my observations to be the same subject from the video surveillance footage I review from the incident.

KERN was issued the above citation on scene with a future court date and also provided a contact card.

She also stated that since she was a child she has been taking medication for mental health issued but she does not believe she has any.

I asked her if she was free to leave on her own and she stated she was and just needed information on suing the Federal Government because she had a lot of documentation for her case. I advised her she would have to take her issues up with the Federal courts.

We were operating vehicle 127 which is equipped with an MDVR system. We were also equipped with bodily worn cameras which were active and operational at the time of this investigation. Audio/Video evidence was recorded which pertained to this incident.

On Sunday, December 20, 2020 at 11:10pm we were dispatched to a "Battery" complaint at 5253 S. Howell Ave. (Super 8 Motel). Upon arrival we were flagged down by the caller, Jeremy D. TISCHER (W/M, 04/24/1979) who stated he believes someone is throwing urine and feces at his door. TISCHER stays in room #126 at the Hotel. When I asked TISCHER if he actually saw anyone throwing feces at his door, he stated he believes he saw them through the peep hole.

We went inside to look at TISCHER's door, but it was clean and dry. TISCHER stated they must have come out and cleaned it up because they knew police were coming. He stated the people in room #122 are the ones who are throwing the feces and urine at his door. He stated one of them is a lookout while the other puts on rubber gloves and throws the feces out of a paper bag. We spoke with the resident living in room #122, identified as David W. MOCCO (W/M, 07/25/91). MOCCO stated he and his girlfriend hardly ever leave their room. They stated they certainly have not thrown feces or urine at anyone's door and they stated they do not even know the subject that lives in #126. MOCCO stated TISCHER called him on the room phone and told him to stay away from his door. MOCCO stated he didn't know what TISCHER was talking about.

I spoke with security, Jose L. CARRASQUILLO (W/M, 01/14/91) who stated he monitors the hallway and has not seen anyone throwing anything at any doors. CARRASQUILLO stated TISCHER puts his own trash bags outside of his door but nobody else has had any bags near his door. This battery was found to be baseless.

GREYER also stated that unknown individuals have some of her enzymes and are using pins to stab the enzymes that then in turn stabs a pin in her leg or head. GREYER stated that she has been homeless for approximately 6 years and has talked to a therapist in the past and that a therapist has proven to be helpful to her overall situation. I encouraged GREYER to find a therapist again to explore the issues she is going through and to turn to the therapist for assistance with these issues to which she agreed.

I then spoke to the security guard, Otis A. CHARLESTON (b/m, 01-30-71).

CHARLESTON stated that GREYER frequently claims that individuals are in her room and doing various things to her, but no one is ever present in the room except for GREYER.

On 01-01-2021, at 12:23AM, P.O. Matthew PAGELSDORF and I responded to a trouble with subject complaint at the Super 8 Motel located at 5253 S Howell Av. The dispatched Cad complaint indicated "CLLR STS THEY HAVE MALE DETAINED AT LOC -- STS SUBJ JUST BOUGHT DRUGS IN THE PARKING LOT -- STS SUBJ IS IN A PROGRAM -- CLLR HAD NFI"

Upon arrival I observed a individual later identified as CASHMORE, Cory J (W/M, 07-02-1985) who was in the hallway of the hotel sitting on a luggage carrier. I also observed standing directly in front of CASHMORE another individual later identified as BATES, Damon L (B/M, 03-31-75). BATES stated that he located what appeared to be drugs from CASHMORE and presented P.O. PAGELSDORF with a receipt. Inside of this receipt P.O. PAGELSDORF observed a soft powder like substance in a small plastic baggy. From my training and experience and the way this item was package was consistent with illegal narcotics.

INTERVIEW CASHMORE

I spoke to CASHMORE who denied that he was buying or selling drugs and only went outside to smoke a cigarette and was suddenly and falsely detained by Hotel staff. CASHMORE stated that BATES searched him and located a small powdery like substance package in a cigarette package. CASHMORE stated that he had no idea where the drugs came from and is no longer a user.

INTERVIEW BATES

I spoke to BATES who stated that he is a "Runner" which he describes as a social worker of sorts. His primary duty is the welfare of the tenants at the hotel and will talk to them and provide resources. BATES stated that he is employed with Milwaukee county. BATES stated that tonight he arrived at work around 11:45 PM (12-31-20) to relieve the second shift Runner. BATES stated that he was in his vehicle in the parking lot and observed CASHMORE run up to the second shift RUNNER who was in his vehicle leaving the parking lot. BATES stated that the second shift runner then drove around the parking lot next to his vehicle. BATES was advised by the second shift Runner that CASHMORE had tried to solicit drugs from him believing him (second shift runner) to be a drug dealer and advised BATES to let the front office security officer know what's going on.

BATES stated that as he was walking into the front lobby of the hotel he observed CASHMORE walk past him going outside and talking on the phone. BATES overheard CASHMORE state that he would meet an individual at Denny's which is located roughly two blocks away at 4925 S Howell Av. BATES advised front desk security officer CHARLESTON, Otis A (B/M, 01-31-1971) who is employed by Private GT Detective about CASHMORE drug dealing. BATES stated that about 10 minutes later he observed CASHMORE walk back into the front lobby and suspected that CASHMORE brought drugs from someone at Denny's.

BATES stated that he confronted CASHMORE and told him that this location is a drug free zone and that he can't have any narcotics on him. BATES stated that CASHMORE attempt to bypass him by walking around him and heading to the elevator. BATES stated that he stop CASHMORE by lightly placing his

hand on his (CASHMORE) shoulder and again asking him to remove items from his pocket. CASHMORE complied and removed items from his pocket, BATES stated that he started to search CASHMORE jacket and removed a uncapped syringe from one of his front coat pockets. BATES stated that he then search through a pack of Marlboro and observed what he suspected to be cocaine or heroin in a clear plastic package.

I spoke to CHARLESTON who stated that BATES did advised him of CASHMORE actions in accidently soliciting drugs from another runner who was leaving for the night. CHARLESTON stated that he was sitting in the front desk when he heard a commotion from the area of the main elevator that is located just south of the lobby. CHARLESTON stated that he went to investigate and observed BATES asking CASHMORE to empty his pockets. CHARLESTON stated that he then observed BATES go through CASHMORE pocket and observed him pull out a syringe. CHARLESTON stated that he continue to observe BATES search CASHMORE Marlboro packs and pull out a plastic bag with a powder substance. CHARLESTON stated that he did NOT participate in searching of CASHMORE and just stood by observing what was going on.

CHARLESTON stated that he then contacted the non emergency line to have a officer dispatched to the hotel.

I contacted District 6, shift commander Lt Phillip SIMMERT regarding the details of this assignment. Lt. SIMMERT then advised me to no-case the suspected narcotics and to release CASHMORE who was detained and NOT handcuffed. CASHMORE then returned to his hotel room.

P.O. PAGELSDORF conveyed the suspected heroin to District 6 for testing. P.O. PAGELSDORF conducted several test on the powdery substance that weighed .065 grams but received negative results for Heroin, Cocaine, methamphetamine and Fentanyl. The unknown substance was then placed on inventory #21000038.
