The 2017 budget established a special fund for this purpose and anticipated the carryover of the unexpended 2016 funds.
<u>CITY ATTORNEY</u> Salaries & Wages Operating Expenditures	179,330	179,330	The transfer is necessary to offset the increase in operating expenditures for temporary legal office support to assist in the high volume of litigation activities and pretrial discovery as a result of three (3) Assistant City Attorneys retiring and two (2) resigning.
<u>DPW-INFRASTRUCTURE SERVICES DIV.</u> Sidewalk Assessable Alley Assessable	25,000	25,000	Additional assessable authority is needed in the 2017 Alley Reconstruction program due to the recovery ratio being increased from 30% to 50%, per File 160965 in November 2016.
Sidewalk Assessable Resurfacing Assessable	325,000	325,000	Additional assessable authority is needed in the 2017 Local Street program due to the assessment rate for sidewalks, driveway and speed humps being increased in November 2016 in order to recover the recovery rate specified in File 080034.
