Dear Council Members:


Returned herewith is a document filed by Attorney Laurie Eggert for attorney's fees for representing Police Officer William Beauchene. The claim is in the amount of \$391.99, including \$6.99 in disbursements for 3.50 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the Police Officer on whose behalf this claim was filed.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Sec. 895.35, Stats., *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).




Dear Mr. Leonhardt:



At this time it was the determination of Deputy District Attorney Jon REDDIN that a charge of Misconduct in Public Office would not be preferred against Officer BEAUCHENE. In making his decision Deputy DA REDDIN offered that the complainant lacked credibility. He further added that when the complainant made her allegations against Officer BEAUCHENE his underwear was viewed by a supervisor and found to be not the description as provided by the complainant. It is for said reasons that this investigation will be cleared as warrant refused.
