Palmer Lodge/Love Tabernacle, a locally-designated building, located at 2640 N. 1st Street satisfies the criteria to be granted a mothball certificate in accordance with Section 320-21 of the Milwaukee Code of Ordinances.

As the applicant, you are required to furnish a rehabilitation plan to the Commission on or before the date of the hearing. The plan should include one or more of the following: floor plans, detail drawings, elevations, photographs, and information on sources of financing and contractors and materials to be used. The plan shall specify a tentative time line for completion of the project or its various phases.

If the Commission grants the mothballing certificate, the Commissioner of the Department of Neighborhood Services will be allowed to stay enforcement of property maintenance and condemnation code provisions against this structure. A mothballing certificate shall be valid for the period of time deemed appropriate by the Commission.
