Meeting convened at 9:05 A.M.

1. Roll call and approval of the minutes from previous meeting.

Motion by Ms. Nicols, seconded by Mr. Mantes, to approve minutes of July 8, 2011 meeting. There were no objections.

- 2. Discussion on Milwaukee County Transit System fare collection.

Ms. Kellner gave members a general overview of the process to replace the current fare boxes that are becoming obsolete. Deadline to accept bids is August 12, 2011. The new fare boxes are expected to be implemented by the end of 2012. The idea is that Cash will still be acceptable.

Ms. kellner said that the Milwaukee County Transit System does not have plans to update signage, at this time; it is more focused on the preservation of service to the community. Based on budgetary measures the department is in the process of looking to realign bus routes.

Ald. Bauman asked what is the cost that could be managed by a third parties like business improvement districts or other organizations, to fund the cost to increase the usability of the system?

Ms. Kellner responded that the department has not done a cost analysis in order for her to answer this question.

Mr. Loughran said that there could be a requirement to Clear Channel Communications to provide routing information on bus shelters

Mr. Jasenski said that Clear Channel is willing to dedicate a part of the shelter to be used for maps and route descriptions. He is also willing to provide a report about Clear Channel's perpective on these issues at the next meeting or at the request of this body.

Ms. Kellner distributed a press release regarding MCTS Detours during the Wisconsin Avenue bridge construction; the press release included a map showing the bus stop locations for Wisconsin Avenue bus routes.

3. Discussion on Taxicab practices in the Downtown area.

Ms. Nicols said that the Milwaukee Downtown Business District recently completed a Night Time Economy Hospitality Zone Assessment. The organization wants to clarify what they can do from a communication perspective to provide the best level of service that provides safety for the cab drivers, clear regulations and direction, and can help give a sense of good management during the night.

Mr. Omar presented the members with a written request (map included) for the board to consider designating specific parking areas for cab drivers in the downtown areas of Water St., Milwaukee St., Old World Third St., and Brady St., during Thursday, Friday and Saturday nights.

Discussion took place regarding the challenges cab drivers faced during the night. It appears that the Police Department is over-ticketing cab drivers when they are dropping off and picking up passengers.

Ald. Bauman asked for Mr. Tsounis and Mr. Omar to provide board with data as to how much police officers are ticketing cab drivers in the downtown area. Ms. Nicols suggested inviting Captain Basting to discuss the initiative in managing mobility issues in the evening hours.

MCTS Detours During Wisconsin Avenue Bridge Construction

Milwaukee, WI – Milwaukee County Transit System (MCTS) buses will be detoured during construction on the Wisconsin Avenue Bridge, which is scheduled to be closed on or after October 3, 2011. Routes 10, 12, 14, 23, 30, 31, 40, 43, 44, 46, 48, 49, 79, 90, 137 and 143 will be detoured for the duration of the project.

Eastbound and Westbound routes will be detoured between 2nd and Broadway Streets. Bus stops of these routes will be moved from Wisconsin Ave. to comparable stops to the best of our ability along the detoured route.

The tentative detours are below; however, these are subject to change since construction is still several months away.

Westbound: Routes 12, 14, 23, 31, 40, 43, 46, 48 and 137 will travel south on Broadway St. from Wisconsin Ave. to Michigan Ave., then west to Plankinton Ave., north on Plankinton Ave. to Wisconsin Ave. and west on Wisconsin Ave. to regular routing.


Eastbound: Routes 12, 14, 23, 31, 40, 43, 46, 48 and 137 will travel south on 2nd St. from Wisconsin Ave. to Michigan Ave., east on Michigan Ave. to Broadway St., north on Broadway St. to Wisconsin Ave. and east on Wisconsin Ave. to regular routing.

Westbound: Routes 10, 30, 44, 49, 79, 90 and 143 will travel north on Water St. from Wisconsin Ave. to Kilbourn St., then west on Kilbourn St. to 2nd St., south on 2nd St. to Wisconsin Ave. and west on Wisconsin Ave. to regular routing.

Eastbound: Routes 10, 30, 44, 49, 79, 90 and 143 will travel north on Plankinton Ave. to Wells St., east on Wells St. to Water St., south on Water St. to Wisconsin Ave. and east on Wisconsin Ave. to regular routing.

MCTS will notify passengers of the detours via social media, passenger announcements and posted signs once the construction start date is confirmed. The Milwaukee County Transit System is a vital service to the community, connecting 40 million riders each year with jobs, schools, shopping, healthcare and recreation in Milwaukee County.

RE: Taxi Cab Stands
To The Public Transportation Review Board,

It has recently been brought to the attention of cab drivers by many of the downtown patrons that often on the weekends starting around 6:00 pm the car and pedestrian traffic gets heavy on these downtown streets. It is a dangerous situation when a cab has to park in the road to drop off a customer or wait outside a business to pick up customers. It is illegal to double park so on the weekends many of the customers have to walk 2 blks. from pick up address to find the cab pulled over to side of the road. Often times in these areas people are walking in the road, opening car doors, drinking and not paying attention. It can become a safety issue for customers and taxis. By having designated cab parking it would eliminate some of the safety concerns expressed by customers and drivers. The cab drivers receive many complaints from businesses and customers that there is not a convenient place for taxis to park during the busy hours of the weekend. It is believed that taxi cabs can safely service the downtown area on weekends if there are designated taxi cab parking on Water St., Milwaukee St., Old World 3rd St. and Brady St. for limited times and days.

These parking spaces would not need to be available every day of the week, just the busy nights on weekends.

This letter is a written request to have the Public Transporation Review Board consider setting aside pull over parking areas for taxi cabs in the downtown area on Thursday, Friday and Saturday nights. Due to the heavy traffic on Water St., Milwaukee St., Old World 3rd St. and Brady St. taxi cab drivers are requesting that each street have an area for cabs to pull off out of traffic in order to drop off and pick up customers.

Thank you for the taking the time to consider this request.

Also, I have drawn out on the map where parking space designation would be most beneficial and safest.
