Meeting Progress (Include key discussion points and 7 P's recommendations)

Problem	Great deal of programming, services and resources in city for fathers, but not often linked or coordinated to maximize impact. Issues of mistrust and lack of communication among providers preventing scaling up of collaboration and resource leveraging. Lack of programs and resources targeting young men and premature fatherhood prevention. Populations of focus include African American
Population	fathers (custodial and non-custodial), men of color and fathers with criminal backgrounds, young men and male youth; African American children and families
Policy	For the purpose of prioritizing policies essential for strengthening Black families and fatherhood involvement in Milwaukee, focused attention on strengthening advocacy and capacity around influencing expansions of, and reforms to existing policies have been identified in the following policy areas: → Increasing funding for WIC ○ to expand access to fathers ○ to support whole family unit ○ to support parent/family transition to self-sufficiency → Increasing funding for Workforce Development/Transitional Jobs Programs ○ to expand and strengthen skill-building and training components to close skills
	 gap to create pipelines and increase exposure to long-term, family supporting employment opportunities to expand focus on fathers and young men with offender backgrounds, high-school drop-outs, non-GED/HSED holders, reentry population, etc. → Increasing funding for birth to three programs and services to include and support fatherhood engagement programming-incorporating resources and services that encourage growth and



- development of fathers
- to create, expand, evaluate, and replicate best-practices for fatherhood involvement during birth to three and beyond
- → Increasing funding for education programs (primary, secondary, higher)
 - to focus on career skills preparation and workforce readiness
 - to focus on improving achievement among young African American men
 - to expand opportunities for engaging and providing educational supports to parents (i.e. parent universities providing literacy support, development, skill-building, etc. to parents/guardians)
 - to increase and expand non-traditional educational settings and communitybased schooling and support outlets
 - to target focus on providing expanded access to young fathers and men with offender backgrounds to "pick-up" and continue education (i.e. return to complete high school diploma, obtain GED/HSED, better access postsecondary training and education opportunities, etc.)

For the specific purpose of prioritizing policies that influence increasing involvement of Black fathers in the lives of children in Milwaukee, focused attention on mobilizing action and building capacity to support and strengthen existing advocacy around needed policy inclusions and expansions have been identified as follows:

- → Advocacy and legislative action to support policies that increase co-custodial guardianship for separated parents
 - to include provisions for increasing healthy co-parenting and relationship building between parents for the sake of children (i.e. mediation)
 - to emphasize and equal, shared responsibility for care and child rearing – including detailed outline of rights of



- both mother and father
- to include increasing and maintaining funding and resources for providers to support advocacy and education for both parents longer
- → Advocacy and legislative action to support policies that ensure fathers' rights to their children
 - to emphasize increasing education and awareness of rights and existing laws relating to fathers through social marketing and programming
 - to include development and dissemination of educational "Men's Equity" tool-box with information on father's rights, policy changes/updates, accessing legal aid, information on local, state, and federal resources, etc.)
 - to emphasize inclusion of non-custodial fathers' rights to school, medical, and social security records of children
 - to strengthen accountability and enforcement of existing laws/policies
- → Advocacy and legislative action to support policies that expand transitional jobs
 - to include expanding length of time in transitional job placements
 - to emphasize increasing recruitment of employers and expanding programs to include placements in emerging job sectors
 - to advocate higher, family supporting wages
 - to expand options and access, and close loopholes for fathers and men with offender backgrounds, criminal justice system connection, high-school drop outs and non-GED/HSED holders, reentry population, etc.
- → Advocacy and legislative action to support policies that creating ability for incarcerated fathers to sustain contact with their children and families
 - to include expanding pre-sentencing to incorporate and modify capacity for establishing access of children to

	incarcerated father/parents in "safe environments", in and outside of traditional jail setting to emphasize increasing and expanding supports (psychological, social, etc.) for children of incarcerated parents
	 → Advocacy and legislative action to support policies that increase placement of children with biological father when not with mother o to focus on supporting existing advocacy for placement of children with fathers as legal next of kin vs. kinship care from other family members (mandating fathers as first consideration for secondary placement)

BMAAC Recommendations

Strengthen Fatherhood Services Sector

Re-define scope and re-institute role of Milwaukee Fatherhood Initiative from direct service provider to capacity building and technical assistance resource to providers

Support Community Resource Mapping

Support development of an accessible, user-friendly resource and clearinghouse that regularly identifies, compiles and disseminates information on community assets and resources for families, fathers and men of color

Encourage Mental Health Inclusion

Increase awareness of mental health issues affecting Black families, fathers and men of color stemming from racism, socio-economic environment, and other factors; Address gaps in services and engage culturally relevant solutions in development and policy and legislation; Identify methods to eliminate the stigma of mental health services and illness; and Assess current mental health services and accessibility to services across city, county, region.
