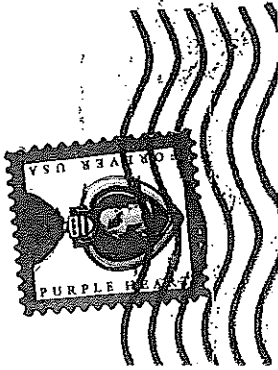

Dear Mr. Newson:


We are in receipt of your claim for damages to your vehicle that occurred as a result of white paint being sprayed on it while you were driving in the area of HWY 57 and Brown Deer Road on April 23, 2022.

Our investigation determined that the location of HWY 57 and Brown Deer Road are under the jurisdiction of the Wisconsin Department of Transportation. Accordingly, we feel the subject matter of this claim is not the result of the operation, conduct or maintenance of the City of Milwaukee or its departments and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202.
