Ordinance approving the change in zoning from Two-Family Residential (RT3) to Detailed Planned Development DPDI, on land located on the South Side of West Stevenson Street and East of North 73rd Street, in the 10th Aldermanic District. (DCD)

The Mayor and Common Council of the City of Milwaukee ("Common Council") do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances ("Code") a new section to read as follows: Section 295-907(2)(b),0074.

(I) In accordance with the provisions of Section 295-907 of the Code relating to the establishment of planned development districts, the Common Council approves the subject Detailed Planned Development, a copy of which is attached to this Common Council File as Exhibit A which is on file in the office of the City Clerk and made a part as though fully set forth herein.

2) The zoning map is amended to change the zoning for the area bounded and described by the zoning line within the right-of-way along West Stevenson Street, the zoning line within the right-of-way along North 73rd Street, a line 129 feet East and parallel to the east line of North 73rd Street and a line 1242 feet South and parallel to West Stevenson Street.

(3) The requirements set forth in said

Part 3. In accordance with the provisions of Section 295-907 of the Code, the City Clerk shall transmit a certified copy of the action taken by the Common Council to the Department of City Development.

Part 4. If any section, subsection, sentence, clause phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions. The Common Council declares that it would have passed this ordinance and each section, subsection, sentence, clause, phrase or portion irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases or other portions be declared void or invalid.
