Redefining the District Boundary Within the City of Franklin

WHEREAS, the Milwaukee Metropolitan Sewerage District was reorganized by Chapter 282, Laws of 1981, and was granted an initial boundary that was the same as the boundary established for the predecessor District pursuant to sec. 59.95(5), Wisconsin Statutes 1979-1980; and

WHEREAS, the City of Franklin has requested that the District include the north-central area of the City in the vicinity of West Loomis Road and West Rawson Avenue, more completely described in Exhibit A, attached hereto, within the boundary of the Milwaukee Metropolitan Sewerage District in a resolution dated July 24, 2001; and

WHEREAS, the City of Franklin has requested that the District include approximately 27.3 acres of land on the west side on North 60th Street, north of its intersection with West Oakwood Road, more completely described in Exhibit B, attached hereto, within the boundary of the Milwaukee Metropolitan Sewerage District in an resolution dated July 24, 2001; and

WHEREAS, the following conditions are generally applicable to the area requested to be within the District's boundary:

- A. Sewerage from the area is or may be captured in drains run to the sewerage treatment plants of the District and unless captured such sewage would flow in Lake Michigan, which is the source of drinking water for many municipalities;
- B. The Commission has authorized the addition to the sewerage system of all facilities needed to treat and dispose of sewage from the area; and
- C. The addition of this area to the District is consistent with the SEWRPC Regional Water Quality Management Plan; and

WHEREAS, a public hearing preceded by publication of a class 2 notice as required pursuant to sec. 200.29(1)(d)2., Wis. Stats., has been held; and

WHEREAS, the City of Franklin has consented to the inclusion of these areas with the District;

now, therefore, be it

RESOLVED, that the City of Franklin's request that the District include the north-central area of the City in the vicinity of West Loomis Road and West Rawson Avenue, as is more accurately described in the attached legal description, Exhibit A, is hereby incorporated into the District's boundary and be it further

RESOLVED, that the City of Franklin's request that the District include approximately 27.3 acres of land on the west side of North 60th Street, north of its intersection with West Oakwood Road, as is more accurately described in the attached legal description, Exhibit B, is hereby incorporated into the District's boundary.

A motion was made by Commissioner Burke, seconded by Commissioner Brunner, that this matter be Adopted by a Voice Vote. The motion carried unanimously.

REPORT TO THE METROPOLITAN SEWERAGE COMMISSION CONCERNING THE PROPOSED ADDITIONS THE DISTRICT'S BOUNDARY WITHIN THE CITY OF FRANKLIN

On October 26, 2001, a public hearing was held at the District's Headquarters Building, 260 West Seeboth Street, Milwaukee, Wisconsin, to receive comment from interested individuals on proposed expansions of the District's boundaries within the City of Franklin to include a proposed addition of approximately 167.3± acres around the intersection of West Loomis Road and West Rawson Avenue and a proposed addition of 27.3± acres on the west side of South 60th Street, north of the intersection with West Oakwood Road within the District's boundary. Pursuant to the Commission's resolution of September 24, 2001, James H. Petersen, Senior Staff Attorney, was requested by the Commission Chairman, Antonio Riley, to serve as the hearing officer.

The hearing was convened on October 26th at 10:00 o'clock in the morning. No person appeared at that time. As hearing officer, I announced on the record that the hearing would be recessed for a short time to allow any later arriving members of the public to make their presence known. Upon re-convening the hearing at 10:15 o'clock, it was noted that no one appeared to present any testimony either for or against these proposed expansions.

Based on the total lack of any opposition to these proposed expansions, it is the recommendation of the hearing officer that the expansion of the District's boundary to include the expansion of the approximately 167.3± acres around the intersection of West Loomis Road and West Rawson Avenue and the expansion of 27.3± acres on the west side of South 60th Street, north of the intersection with West Oakwood Road, within that boundary be approved.
