Atty. Christopher M Hayden appeared with the applicant and regarding the items on the police report said that:

First: It has been resolved with the City of Milwaukee.

Second: 6/09/21 it was the perfect storm coming from a big construction in front of the business and that his client is making sure that cars are not stopping and that has directed the security guard to monitor outside.

Third: the 6/16/21 item showed that there was no evidence of a gun shot inside the establishment and the non-cooperative manager has been reprimanded and that this business has a long story of cooperating with law enforcement.

Fourth: On 10/0521 and it was a road rage situation that was not related to the business and hit a woman eating at the patio.

Individuals also present:

Ald. Perez said that on 6/09 item the police report says that there were patrons walking in the traffic, vehicles with loud music, motorcycles on the sidewalk and that security told the police that there were few people with fire arms outside the tavern so he asked if the manager or applicant filed a police report.

Atty. Hayden said that they did not make a phone call to the police.

The applicant said that after that incident they went from one to three security guards outside and that haven't had traffic situations like that.

Ald. Perez asked if the applicant made phone call to the police regarding the incident on 6/16 and the fact of having 20 people running away from the location and police being dispatched for gun shots.

The applicant said that he did not call.

Ald. Perez asked the applicant to explain the plan of operations because it seems to be shifting from the original application.

The applicant said that they offer food until one in the morning and that it is a lounge with no dancing floor and that safety measures are in place because of Covid and that is using promoters on Fridays and Sundays and looking forward to have a live band on Wednesdays.

Ald. Perez said that even if the shots fired on 6/16 were not connected to the establishment, the police talked to a security guard and to a non-cooperative manager

so he asked the applicant if the police was able to retrieve the surveillance video from them? Added that he wanted to get it on the record that seems that this place is not well managed (crowd control, shots fired, non-cooperative manager) and that he has not heard in detail what is he doing about all these issues except for the three security guards and asked him of the security goes further beyond his property.

The applicant said that they go to the parking lot on the east of his property.

Ald. Perez asked him if the valet services and his staff use the alley and parking lot of Lady Guadalupe?

The applicant said that he used to and Ald. Perez asked him if he has received the letter from Lady of Guadalupe asking him not to do that.

The applicant admitted that he received the letter.

Sgt. Velasquez said that the video from the 6/16 incident was not available to the police because there was an issue with the applicant's laptop.

Atty. Hayden made questions to the applicant to review the safety in plan in place. The applicant responded that there are four security guards working on regular basis, that they follow the id standards, that they use metal detectors, and that there are a male and a female at the door to check patrons.

Atty. Hayden added that his client is a lifelong member of this community with other businesses on the area and that he is committed to the neighbors and their safety with safety measures in place to avoid issues and asked for renewal with a warning letter. Ald. Kovac said that the non-cooperative manager and not being proactive concerns him a lot so he moved renewal with a 10 day suspension based on the police report. (Prevailed 4-0)

Report of the Renewal Application of the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses of Felipe Martinez, Jr., Agent for Walkers Lounge & Events LLC, for the premises located at 626 South 5th Street in the City and County of Milwaukee, Wisconsin ("Walkers Lounge & Events").

FINDINGS OF FACT

- 1. Felipe Martinez, Jr. (hereinafter "the Licensee") is the holder of Class "B" Tavern and PEP Licenses for the premises located at 626 South 5th Street in the City and County of Milwaukee, Wisconsin ("Walkers Lounge & Events"). Said licenses expired at midnight on December 21, 2021.
- 2. An application to renew said licenses was filed with the Office of the City Clerk on December 8, 2021.
- Pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On December 13, 2021, the Milwaukee Police Department responded with a report that could form the basis for nonrenewal of said licenses.
- 4. On January 11, 2022, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report. The matter was scheduled for a hearing on the police report on January 25, 2022, commencing at approximately 9:20 a.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared with counsel, Attorney Christopher M. Hayden at the hearing, and admitted receipt of the notice of hearing, together with a copy of the Milwaukee Police report.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

A. On January 29, 2021 at 11:00 p.m., Milwaukee Police, along with an Environmental Health Specialist, conducted a license premise at 626 South 5th Street. Officers and the specialist observed patrons not practicing social distancing, not wearing masks, and standing/dancing. The specialist said he will be issuing three citations. The Licensee was cooperative during the investigation. (no citations were found regarding this incident).

B. On June 9, 2021 at 1:44 a.m., Milwaukee Police, while on patrol, observed a huge crowd and approximately 80 vehicles blocking traffic at 626 South 5th Street. While on scene, officers observed patrons walking in traffic, vehicles blaring loud music, and motorcycles operating on the sidewalk. Security staff told officers that there were several subjects brandishing firearms outside the tavern and one of the

first squads on scene had trash/debris throw at the wagon.

C. On June 16, 2021 at 12:40 a.m., Milwaukee Police were dispatched to 626 South 5th Street for a shots fired complaint. Upon arrival, officers observed approximately 20 people running away from the location and speeding off in their vehicle. A security guard was interviewed and he told officers that there was a "scuffle" inside the tavern and they got the people involved out of the business, but there were no shots fired. Officers attempted to talk with the manager but she was extremely uncooperative and stated that she did not hear or see a fight. All other security guards said they were not inside the business and did not see anything.

- D. On October 5, 2021 at 10:15 p.m., Milwaukee Police, while on patrol in the 200 block of West Virginia Street, heard several gunshots coming from the southwest of their location. Squads went to investigate the shots fired and were flagged down at South 5th Street and West Bruce Street who informed police that someone had been shot outside 626 South 5th Street. Investigation revealed that the incident appears to be a road rage incident between two vehicles and the victim of the shooting was eating food on the patio of the tavern and was not involved in the argument. The applicant was cooperative during the investigation and provided video footage to officers.
- E. Attorney Christopher M. Hayden appeared with the Licensee and regarding the items on the police report said that the January 29th, 2021 item has been resolved with the City of Milwaukee. He also said that the June 9, 2021 incident was the perfect storm resulting from construction in front of the business and that his client is making sure that cars are not stopping and has directed the security guard to monitor outside. He said that the June 16, 2021 item showed that there was no evidence of a gun shot inside the establishment and the non-cooperative manager has been reprimanded and that this business has a long story of cooperating with law enforcement. He further said that the October 5, 2021 incident was a road rage situation that was not related to the business and hit a woman eating at the patio.

Individuals also present:

- S. Attorney Hayden added that his client is a lifelong member of this community with other businesses in the area and that he is committed to the neighbors and their safety. He added that there are safety measures in place to avoid issues and asked for renewal with a warning letter.
- T. Alderman Kovac said that the non-cooperative manager and not being proactive concerns him a lot so he moved renewal with a 10-day suspension based on the police report. (Prevailed 4-0)

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Felipe Martinez, Jr. who holds Class B Tavern and Public Entertainment Premise (PEP) licenses for the premise located at 626 South 5th Street in the City and County of Milwaukee, Wisconsin ("Walkers Lounge & Events") has not met the criteria of Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes to not renew the Class B Tavern and Public Entertainment Premises without undergoing a ten (10) day suspension. The Committee finds the police report and aldermanic objections as stated above to be true. The Committee based its recommendation on the police report.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Class B Tavern and Public Entertainment Premise (PEP) licenses for the premises located at 626 South 5th Street in the City and County of Milwaukee, Wisconsin ("Walkers Lounge & Events") without undergoing a ten (10) day suspension. The Committee based its recommendation on the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and zero (0) noes, recommends that the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses of Felipe Martinez, Jr. for the premises located at 626 South 5th Street ("Walkers Lounge & Events") in the City and County of Milwaukee, Wisconsin not be renewed without undergoing a ten (10) day suspension.

The suspension is in effect between 12:01 a.m. on February 9, 2022 until 11:59 p.m. February 18, 2022.

OBJECTIONS TO LICENSES COMMITTEE RECOMMENDATION

On January 25, 2022, Felipe Martinez, Jr. as agent for Walkers Lounge & Events LLC ("Applicant") along with Attorney Christopher M. Hayden appeared virtually before the Licenses Committee to seek renewal of the Applicant's Class B Tavern and Public Entertainment Premises licenses. At the conclusion of the hearing, by a vote of four ayes and zero noes, the committee voted to recommend renewal with a ten (10) day suspension. As of the date and time of this submission, the committee has failed to issue its Findings of Fact and Conclusions of Law. Additionally, the committee has failed to publish minutes of the January 25, 2022 hearing. The Applicant objects to the committee's recommendation, including the renewal with a ten (10) day suspension, for the following reasons:

- 1. The business seeking renewal of its Class B Tavern and Public Entertainment Premises licenses is located at 626 South 5th Street, Milwaukee, Wisconsin 53204.
- 2. The Applicant through counsel provided testimony that the Applicant has a history of cooperation with the Milwaukee Police Department for any investigations related to the business and addressed the four incidents contained in the MPD police report.

- 3. The first incident occurred on January 29, 2021, wherein the Milwaukee Police Department along with an Environmental Health Specialist conducted a license premise check on the premises and observed patrons not practicing social distancing. The police report states that no citations were found regarding the incident. The Applicant through counsel explained that any issues related to the social distancing issue have been resolved with the City of Milwaukee.
- 4. The second incident occurred on June 9, 2021, where police observed a large crowd and approximately 80 vehicles blocking traffic on 5th Street. The Applicant through counsel explained that the traffic issues were a combination of a busy night at the business coupled with substantial construction in the area.
- 5. The third incident occurred on June 16, 2021, where police were dispatched for a shots fired complaint. The police report indicated there was no evidence of shots being fired inside the business.
- 6. The fourth incident occurred on October 5, 2021, where a patron was struck by a stray bullet from further up the street following a road rage incident. There was no allegations that the individual that fired the weapon had any connection to the business.
- 7. Alderman Jose Perez was the only individual that presented testimony in opposition to the Applicant's renewal application.
- 8. Alderman Perez asked the Applicant questions regarding the management of the business and expressed concerns related to the business using promoters and employees parking at a neighboring church.

- 9. Alderman Perez expressed concerns about traffic, crowd control, reports of uncooperative managers, and shots being fired in the neighborhood even though the police reports expressly state that there is no evidence of gunfire connected with the establishment.
- 10. In addressing Alderman Perez's concerns the Applicant provided testimony about the measures it has taken to reduce including, but not limited to, placing three security guards outside the business to move traffic along. The Applicant explained that it does not allow the establishment to reach capacity. Specifically, the business does not allow more than 300 patrons inside despite having a capacity of 364. The Applicant through counsel also provided testimony that the manager that was described as uncooperative by MPD was reprimended for her actions.
- 11. Other than Alderman Perez, there was no neighborhood testimony presented in opposition to the Applicants request for renewal.
- 12. Alderman Perez provided no recommendation as to whether the committee should recommend any type of progressive discipline.
- 13. In closing, the Applicant provided testimony as to its security measures it has adopted to prevent future incidents. Specifically, the Applicant explained that it has eight (8) cameras in and around the premises, maintains a minimum of four (4) security guards, utilizes ID scanners, and uses metal detectors when allowing patrons into the establishment.
- 14. The Applicant argued that renewal was warranted based on the fact that the issues identified in the police reports had either been addressed or did not involve

the premises at all. The Applicant urged the committee for renewal or, in the alternative, renewal with a warning letter to allow the business to continue operations.

- 15. In committee, Alderman Kovac expressed concerns for what he identified as a lack of proactive reporting for the June 9, 2021 incident.
- 16. Alderman Kovac ignored the Applicant's request for renewal or renewal with a warning letter and ultimately moved for renewal with a ten (10) day suspension based on the police reports.
 - 17. Alderman Kovac's motion passed 4 to 0.
- 18. The recommendation of a ten (10) day suspension was not supported by the aldermanic testimony presented, which did not include any recommendation as to progressive discipline.
- 19. A ten (10) day suspension was not warranted based on the police reports, which expressly showed that there was no evidence of gunfire involving the business.
- 20. The committee's failure to issue its Findings of Fact and Conclusions of Law prior to the Applicant's deadline to file its written objections thereto is contrary to MCO 85-5, which expressly requires the committee to prepare and serve a report and recommendation upon the applicant.
- 21. The committee's failure to issue its Findings of Fact and Conclusions of Law prior to the Applicant's deadline to file its written objections is a failure to act according to law in violation of the Applicant's due process rights.

- 22. The decision to recommend a ten (10) day suspension was arbitrary, oppressive, and unreasonable in that it was not supported by any testimony on the record.
- 23. The decision to recommend a ten (10) day suspension was arbitrary, oppressive, and unreasonable in that it is inconsistent with committee's past decisions and preference for imposing progressive discipline.
- 24. Based on the police reports and the testimony presented, an appropriate outcome would have been renewal or renewal with a warning letter.

Walkers Lounge & Events LLC requests an opportunity to be heard at the Common Council meeting on February 8, 2022.

We made our way to S. 4th St and W Bruce St and made sure there was no one injured or casings recovered.

We attempted to talk to the manager who identified her self as Crystal A CHAIREZ (F/W 09-30-1985) but she was extremely uncooperative with assisting Squad 2482 (P.O SANCHEZ/P.O GUTIERREZ), stated she did not see or hear a fight because she was too busy with her employees. All other security guards stated saying they were not inside the business and stated not seeing anything. A cook was interviewed, but once asked for identification walked away from officers and became uncooperative.

There was no evidence of shot being fired inside the business, and upon trying to call the caller back multiple times the line appeared to be disconnected. A review of the business discovered that they possessed a class B tavern license, (License number 0208804).



- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
