To file a claim against the **City of Milwaukee** which complies with Sec. 893.80, Stats., the following information must be submitted in writing to:

City Hall, City Clerk  
200 East Wells Street, Room 205  
Milwaukee, Wisconsin 53202

1. A document stating the circumstances of the claim, which must be signed by the claimant or his/her agent or attorney. This document should be filed within 120 days of the event.
2. A document stating the address of the claimant and a statement of the relief sought. If money damages are sought, a specific sum must be indicated.

In order to allow the City of Milwaukee to thoroughly and promptly act on your claim, the following information should also be submitted:

1. Proof of the amount of the claim by means of either two itemized estimates or itemized receipted bills.
2. The telephone number where you can be reached during business hours.
3. A detailed description of the incident, being as clear as possible as to episode of events, including the date, time and place.
