Re: Report of the Renewal Application of the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses of Jose De Dios-Sosa, Agent for Tabasco Bar, for the premises located at 1900 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin ("Tabasco Bar").

FINDINGS OF FACT

1. Jose De Dios-Sosa (hereinafter "the Licensee") is the holder of Class "B" Tavern and PEP Licenses for the premises located at 1900 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin ("Tabasco Bar"). Said licenses expired at midnight on November 19, 2020.
2. An application to renew said licenses was filed with the Office of the City Clerk on November 9, 2020.
3. Pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On November 19, 2020, the Milwaukee Police Department responded with a report that could form the basis for nonrenewal of said licenses.
4. On December 16, 2020, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the neighborhood objections. The matter was scheduled for a hearing on the objections on January 5, 2021, commencing at approximately 9:35 a.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee did not appear.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing as well as a copy of the police report was sent to Jose De Dios-Sosa, 1900 West Lincoln Avenue, Milwaukee, WI 53215 on December 16, 2020 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 1900 West Lincoln Avenue, Milwaukee, WI

53215 is the address given by the Licensee on his application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on January 5, 2021 at 9:35 a.m.

B. Alderman Kovac moved denial based on nonappearance. (Prevailed 5-0)

CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the Licensee, Jose De Dios-Sosa who holds Class B Tavern and Public Entertainment Premise (PEP) licenses for the premise located at 1900 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin ("Tabasco Bar") has not met the criteria of Chapters 85, 90, and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes to not renew the Class B Tavern and Public Entertainment Premises. The Committee finds the police report and aldermanic objections as stated above to be true. The Committee based its recommendation on nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Class B Tavern and Public Entertainment Premise (PEP) licenses for the premises located at 1900 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin ("Tabasco Bar"). The Committee based its recommendation on nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of **five (5) ayes and zero (0) noes**, recommends that the Class "B" Tavern and Public Entertainment Premises (PEP) Licenses of Jose De Dios-Sosa for the premises located at 1900 West Lincoln Avenue ("Tabasco Bar") in the City and County of Milwaukee, Wisconsin not be renewed based on nonappearance.

Said nonrenewal is effective January 19, 2021.
