### 2. Review and approval of the previous meeting minutes from December 7, 2022.

The meeting minutes from December 7, 2022 were approved with no objections.

# 3. Discussion, update, or review on RFPs, listings, projects, program, initiatives, or other aspects within or near the Granville Development District area.

A. 8320 W. Beatrice Ct. (Exotic Blends Cigar Lounge) -Adding Public Entertainment Premises and Food Dealer Licenses (requesting Instrumental Musicians, Disc Jockey, Bands, Karaoke, Poetry Readings, Patrons Dancing and 1 Pool Table )

Appearing: Lynette Patterson Chris Patterson

Ms. Patterson presented. Their license application was heard on January 24th and there was no-one present in objection. She wanted to clear up some confusion. She had checked everything on the license application regarding Public Entertainment so she wouldn't have to amend her application later. Due to all the items checked, the committee had wanted to speak with the Granville committee. She was not aware that would cause an issue. Page 1 of her operation plan lists what she needs to provide to operate at a profit (food, appetizers). They would like at least 10 live events a year, such as a live band. She doesn't want anything changed with the floor plan and she would like the support of the committee. Anything new that was added was not done to change their original presented plans. She had added: serving of food and public entertainment (entertainment is a broad spectrum, as is food). They are proposing snacks, with a warmer kitchen, not a full kitchen. The entertainment would be soul and jazz bands for certain events.

Member Dodds asked if there were any other entertainment besides jazz or soul bands.

*Mr.* Patterson said cards would also be offered (on a friendly basis), such as cards and poker. If it isn't kept friendly, folks would be banned.

*Ms.* Dotson would like the specifics outlined of what services/entertainment will be offered.

*Ms.* Patterson reiterated she had checked all those items "just in case" and she and her husband want just a cigar lounge with jazz. No gambling.

*Mr.* Patterson said they will be catering to an older crowd looking to relax after work. A privacy fence will be installed around the property which will help control who enters the business. The hope is to have electric gates to enter/leave and is cost feasible.

Members said they wanted to ensure that the applicants do what they say they will do.

*The hours of operation is from 4-10 p.m. Sunday through Wednesday and 4-midnight, Thursday, Friday and Saturday.* 

*Ms.* Dotson moved to approval with the contingency that this operation is exactly what they say it is, seconded by Mr. Dodds. There were no objections.

Chair Hinton announced SDC's 60th anniversary this year with various events and programs coinciding with the anniversary.

Member Dodds and Chair Hinton said they both anticipated to move out of the city soon and that their eligibility to the committee may be in question.
