Dear Ms. Frazier,

We have received your claim in the amount of \$9,417.92 in relation to vehicle damage you sustained, allegedly after hitting a speed bump or raised crosswalk at or near the intersection of North 35<sup>th</sup> Street and West Rohr Avenue on August 31, 2024.

Our investigation determined that no City of Milwaukee employees were performing work in the area of North 35<sup>th</sup> Street and West Rohr Avenue on the day in question. Construction work in this area was being performed by Lalonde Contractors, Inc. City records relative to this project show that the location was an active construction site open to traffic on August 31, 2024, and that the contractor kept temporary orange bump signs up in the area.

Per the City of Milwaukee Street Construction Specifications Section 209.7, the contractor shall hold the city harmless from and defend the City against all liability for damages occasioned by their work. As such, the City cannot accept liability in this case and we are denying your claim.
