I have received your letter where you conclude the City has no negligence in the matter of the City recycling my car without my knowledge or consent.

You site MPD incident number 173030161 having notified me, without mentioning that the phone number they had was wrong. You say the Tow Lot mailed something to my address but I have told you I received no mail. You say the Tow Lot called "my residence" and I have never had a residential phone line or number since I was out of my parent's household in 2004. My wife and I have never received a voicemail from the city or it's various departments with a message about the recovery of my car.

I will also note, as stated in my initial claim, that when I filed my report of a stolen vehicle in person at a MPD district I was told not to call to check in. I was told they would find it and they would call me. This never happened. I will also note that the MPD has my actual number on file. I will also note that the state DMV has my actual number on file. Both of which are accessible by the MPD or City Tow Lot. I never called to check in as a result of being told not to call. After 7 months had passed I called as that seemed like too long.

Considering my claim is based on the FACT that I was unaware my car was recovered or recycled, there is no possible way for me to have made a claim within 120 days of my perfectly functional car's early execution.

I appeal the decision made without a thorough investigation, though your letter says you have done so. I request a hearing where I hope logic will be used to weigh the FACTS made by me against whatever the various city departments have said to avoid liability.

On October 30th, 2017 my vehicle, a white 1997 Honda Civic, WI Collectors plate 195967, was stolen in Milwaukee, WI, USA outside of Goodkind restaurant around 7:00pm near the corner of S Wentworth Ave & E Potter Ave. I immediately proceeded to the Milwaukee Police Department (district 2) to file a police report. After giving the required information to Officer Tina Roberts and being told I could leave, I asked: "Should I plan on calling to check on the status?" The officer replied, "No, we will contact you. We'll find it eventually." I took the officer at her word and relied on her instruction.

After hearing nothing from the Milwaukee Police Department for over six (6) months, on June 1st, 2018 around 3:02 PM, I called the district 2 station to inquire about the status of my vehicle. The officer on duty answered my call, and after searching the VIN number of my vehicle, found my original police report (see attached Exhibit A, the "Police Report") and also found a report from when an officer recovered my car (see attached Exhibit B, the "Recovery Report"). According to the Recovery Report, the Milwaukee Police Department recovered by vehicle around 3:00am on December 15, 2017. The Recovery Report further noted that my vehicle had incurred no damage and further stated that calls were made to phone numbers on file with no response. I never received a call from the Milwaukee Police Department regarding my recovered vehicle.

During my conversation with the officer on the phone, I learned that the Milwaukee Police Department misrecorded my phone number when completing its police report. However, the secondary number (my wife's cell phone number) was correct. My wife never received a call from the Milwaukee Police Department regarding my recovered vehicle.

The Recovery Report indicates that my vehicle was transferred to a Tow Lot. Accordingly, the officer on duty gave me Tow Lot #1679806 for my vehicle and directed me to call the Tow Lot to ask for more information. On June 1, 2018, I called the Tow Lot around 3:20pm. A representative of the tow lot answered my call and indicated that the Tow Lot received my vehicle. The employee stated the Tow Lot mailed a notice to my home address. I never received written notice from the Tow Lot regarding my recovered vehicle.

According to the tow lot representative, the Tow Lot sent my vehicle to be recycled around January 2018.

Despite its representation that it would notify me when my vehicle was recovered, the Milwaukee Police Department and/or its agents (1) failed to accurately record my phone number and so failed to notify me of its recovery of my vehicle; (2) failed to call the secondary number to

notify me of its recovery of my vehicle; (3) failed to send written notice of its recovery of my vehicle to my home address; and (4) destroyed my vehicle without my knowledge or authorization. Thus, I have been without a vehicle since at least December 2017 as a direct result of acts or omissions of the Milwaukee Police Department and/or agents of the Milwaukee Police Department.

For at least the above reasons, I am filing a claim with the City of Milwaukee for restitution in the amount of \$1,154.00. I purchased the white 1997 Honda Civic (VIN# JHMEJ6524VS005390) around Saturday July 22, 2017 for \$1,000.00. The vehicle was registered and licensed as a collectors car. As a collectors car, my vehicle had value to me above and beyond it's utilitarian value as transportation. My collectors plates were also "recycled" and there is a \$4 fee to replace them. Additionally, to get the plates transferred to another vehicle will cost \$150. Despite the fact that my vehicle is worth more than \$1,000, and despite the fact that I have had to deal with the stress, inconvenience, and expense of having to make alternative transportation arrangements for over eight (8) months, my claim is limited to the original \$1,000 I paid for the vehicle (a mere five months before it was stolen). My hope is that my willingness to resolve this incident for less than my own costs will ensure prompt and full restitution.

Nothing in this letter should be construed as a waiver of any claim or argument I may make in this or any other proceeding relating to the facts giving rise to this claim.
