**W. Eggert Pl. – N. 46th St. to N. 50th St. (ST211060130):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, and grading.

**2nd Aldermanic District**

**N. 64th St. – W. Hampton Ave. to W. Villard Ave. (ST211060136):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where needed, sodding, grading, and tree removal where necessary.

**6th Aldermanic District**

**W. Walnut St. (North Roadway) – N. 6th St. to N. 10th St. (ST211050108):**

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding, and grading.

**11th Aldermanic District**

**S. 52nd St. – W. Tesch Ave. to W. Norwich St. (ST211050139):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, and grading.

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, and grading.

**W. Tesch Ave. – S. 52nd St. to S. 54th St. (ST211050138):**

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding, and grading.
