Dear Ms. Hill:


We have received your claim in the amount of \$1,503.84, relating to speakers and amps that were allegedly taken from your vehicle when it was towed to the City of Milwaukee Tow Lot on March 28, 2007.

Our investigation reveals that your 1993 GMC van was towed to the tow lot for Illegal Parking and Unpaid Citations. Your vehicle arrived at the tow lot with its doors unlocked and unsecured. The tow lot manager indicated they do not inventory items contained within a vehicle. The intake video also did not reveal any of these items. It was also noted that your unlocked vehicle was towed to the street as a courtesy. The tow lot followed proper procedures and there is no evidence to support your belief that said items were taken at the tow lot, as such; the City cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
