This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/29/2018 an officer conducted a licensed premise check at Runway Lounge, 9316 W. Appleton Av. As the officer was arriving a call came over the radio for shots fired at the tavern. The officer spoke with witnesses who stated there were no shots fired but there were subjects in a truck with guns. Security stated there were two sets of patrons who were arguing and both parties left. The manager stated the surveillance system was not working and they do not have an ID scanner.

2. On 08/10/2018 officers were dispatched to a Shooting at 9200 W. Appleton Av. The officers determined the correct location to be 9316 W. Appleton Av, the Runway Lounge. The officers did not locate a victim but observed about 200 cars in the lot and on Appleton Av. The security stated there were 144 patrons inside as indicated on her counter. The officer estimated the count to be 200. The officer observed addition people enter the after being given the capacity figure. The manager, Larry WILLIAMS, was on scene and cooperated in removing patrons from the location.

3. On 04/19/2019 at 12:08am officers were dispatched to the Runway Lounge, 9316 W. Appleton Av. for a call in which the caller stated the bar was letting minors in. The officer found the call to be baseless. The officers provided crowd and traffic control because the bar was closing early because of a failed fight attempt inside the bar.

4. On 10/21/2019 officers were dispatched to Runway Lounge, 9316 W. Appleton Av for a violation of Restraining Order. The caller stated she got to the bar at around 12:00am and observed a female already in the bar that she has a restraining order on. When the caller attempted to leave the subject punched her and spit on her. Bar security broke up the fight and the caller went outside to wait for Police. While on scene the officers were flagged down for a separate battery that occurred at the location. The victim approached officers and was bleeding from a cut to her head. The officers were interviewing her when a female exited the business. The victim then approached the female and began hitting her stating she was involved in the assault that injured her. Both parties were uncooperative with the officers and refused to prosecute. On 10/29/2019 at 2:30am the officer stopped at the bar to recover video. The door was locked but there was music inside and it appeared employees were present but no one answered the door. The officer went on 11/01/2019 and spoke with the bartender about the video but she stated he should leave his card for the owner because only the owner could access the video.
5. On 12/07/2019 at 1:08am officers were dispatched to 9318 W. Appleton Av for a Call for Police. While enroute the officers were advised that people were shooting at the location. When the officers arrived they observed the Runway Lounge was clearing out and people walking to their cars. The officers spoke with the bartender, who stated there was a fight inside the bar but she did not hear any shots fired. The bartender had shut the bar down for the night because of the fight.
6. On 01/04/2020 at 12:48am officers were dispatched to Runway Lounge, 9316 W. Appleton Av, for a shooting. The officers located a victim in a car across the street from the tavern. The victim had a single gunshot wound that occurred in the parking lot of the tavern. The officers located 3 casings and an unfired bullet 20 feet from the front entrance. The bartender stated they lowered the entrance age from 25 to 21 today. The bartender stated she observed several patrons arguing, and security escorted them out. The police arrived shortly after they left. The officers observed the video which showed several people in the parking lot firing guns at each other. The video also showed two people working as security approaching an auto parked in the lot. One subject opens the trunk and removes an AR-15 style pistol. The security guard hands the pistol to the other guard who has a his face covered, proceeds to walk around the lot with the weapon. It was later learned that the security officer was a felon. One of the victims stated he was in the bar and was only 18 years of age and was charged twenty dollars by security, which never checked his ID. The applicant was cited for Allow Underage on Premise.

7. On 01/15/2020 a meeting was held at District 4 regarding the shooting that occurred on 01/04/2020 at Runway Lounge. Present at the meeting was the applicant and the business manager. The manager stated he uses Gorilla Security and they only charge a cover on nights they have security. Captain Wurth addressed what occurred with security during the shooting. Two security officers went over to a vehicle that was parked in the parking lot, they opened the trunk of the vehicle, placed a mask over their face and retrieved additional firearms from the vehicle. Those security officers were not located when the officers on scene observed the video of this occurring. Williams stated a few employees were terminated after this incident occurred. The applicant and manager stated they were not aware that security was charging

under age people \$20 to allow them to enter the tavern. They were also not aware the bartender had changed the age restriction that night. The applicant was advised she should call the district to notify of special events. A PA33 would be filed for business checks but those would not negatively impact her license.

8. On 01/17/2020 at 11:19pm officers conducted a license premise check at runway Lounge, 9316 W. Appleton Av. The officer observed two security guards at the door, one outside in the parking lot and one roaming around the building. The officer did not observe any violations.

This report is written by PO EISSENS assigned to District 4, late shift.

On 10/21/19 at 12:17 AM Squad 4330 (PO KELLER and I) responded to 9316 W APPLETON AV, The "Runway Lounge", for a report of a violation of restraining order.

We met with the victim, Monet A BATCHELOR (f/b 2/10/19) who stated that she had been spit on and punched by Ashley C BLAKE (f/b 2/17/93). BATCHELOR states that she had a valid restraining against BLAKE.

#### Interview of BATCHELOR:

BATCHELOR stated that she and her friend, Shanique JOHNSON (f/b 10/24/93), arrived at the 9316 W APPLETON AV (Runway Lounge bar) at approximately 12:00 AM. They walked into the bar and as they entered, BATCHELOR saw BLAKE out of the corner her eye but did not make eye contact. After passing BLAKE, BATCHELOR made her way away from BLAKE and told JOHNSON that they had to leave immediately because BLAKE was present in the bar, and she had a restraining order against her.

As the two went toward the exit, BLAKE lunged toward BATCHELOR and spit on her face. BLAKE then punched BATCHELOR in the face with her fist, causing her pain without her consent. At this point, bar security stepped in and separated the two parties. BATCHELOR exited the bar and called police.

Upon our arrival on scene, we spoke with BATCHELOR who was standing out side near the parking lot. BATCHELOR gave us the above information regarding the incident. BATCHELOR also stated that BLAKE was wearing a red shirt and blue ripped blue jeans.

Along with Squad 4360 (PO SMITH and PO BEAMON) we entered the bar in an attempt to locate and arrest BLAKE. We searched the entire bar and could not locate the suspect. It should be noted that the interior of the bar was crowded and extremely loud. It was also dimly lit. After we searched the bar we went back to speak with BATCHELOR, who was surprised and upset that we did not locate BLAKE. BATCHELOR stated that she saw BLAKE exit the bar after we entered, and BLAKE proceed to flee the location in an unknown direction.

BATCHELOR also stated that on 10/14/19 there was an incident at her residence (10310 W Kiehnau) while she was away. BATCHELOR stated that her neighbor observed a black female, who was driving a black Volkswagen, dama BATCHELOR's windshield of her vehicle. BATCHELOR suspects that the person that broke her windshield was BLAKE. BATCHELOR did not personally witness this incident.

#### Interview of Shanique JOHNSON:

JOHNSON stated that she and BATCHELOR had entered the bar, and shortly after they got

inside, BATCHELOR told her that they needed to leave. BATCHELOR then explained that someone she had a restraining order against was at the bar, and wanted to leave before there was an issue. JOHNSON does not know who BLAKE is.

While exiting the bar, JOHNSON observed a black female lunge toward BATCHELOR. JOHNSON then saw the liquid on BATCHELOR's face, and later realized that that was when she was spat on. JOHNSON then observed the female punch BATCHELOR in the face one time with a closed fist. JOHNSON described the female as wearing a red shirt and ripped blue jeans.

During our investigation of the above- listed complaint, we were flagged down by patrons of the above-listed establishment, for an assault that had just occurred inside.

We returned to the parking lot where we observed a female, later identified as Menique J. HARDY (B/F 05-17-91), bleeding from a laceration above her left eye. In addition to the laceration, blood was observed on the left side of her face, as well as, on her chest and shirt. HARDY told us that the subject who had hit her was still inside the location. In our attempt to gather further information, HARDY was non-cooperative. As we tried to calm HARDY down, an unknown female, who had, according to HARDY, been a party to the assault inside, exited the location and began to scream loudly. HARDY immediately approached the unknown female and began to hit her, as well as, accuse her of assaulting her. HARDY and the unknown female were both detained. The unknown female refused to give officers any identifying information and told officers that she did not wish to prosecute. At the time of both females being detained, officers were not aware that the unknown female was a party to a crime. The unknown female was released and told to leave the location.

HARDY was then walked to our squad car, at which time, she began to complain of trouble breathing, stating she has asthma. The Milwaukee Fire Department was contacted and Med Unit #16 arrived on the scene. HARDY was non-cooperative with MFD. HARDY was checked for breathing problems and was cleared by MFD. Officers and the MFD Medical Unit asked HARDY multiple times if she would have the laceration above her left eye checked, HARDY refused.

On 11/1/19 at approximately 12:05 AM, Squad 4330 (PO KELLER and I) went to 9316 W Appleton Av for follow up regarding this incident.

We met with the manager on duty, India D HOLLAND (f/b 1/3/88). I asked about recovering video from the above case, and she advised me to leave my information for the bar's owner, Shawntel WALTON. I

left a card with my information, and the time and date of the video requested.

It should be noted that earlier on 10/29/19 at approximately 2:30 AM I went to 9316 W Appleton Av to recover video. The doors to the bar closed and locked, but it appeared as if employees were still present. The lights in the bar were still on, music was still playing, and the floors had yet to be cleaned of trash. I knocked loudly on the door and announced myself as a police officer but received no response.

Then at shift change on 10/29/19 at approximately 8AM, I arranged for a day shift officer, PO KRADECKI, to attempt to obtain video from the bar. PO KRADECKI later emailed me stating that he was unable to obtain footage because the bar was closed.

It should also be noted that the bar does not have any contact info or business hours posted on the exterior of the building. I also attempted to call the bar numerous times, using the business number listed on google maps (414 501-9918), but it appeared to be an old or wrong number.

This report was written by Police Officer Lee XIONG assigned to District 4, Late Power Shift, Squad 4486.

On Saturday, 12/07/2019 at 1:08 am, I responded to assist squad 4460, P.O. SCHLICKE for a Call for Police complaint at 9318 W. Appleton Ave located in the City and County of Milwaukee.

Prior to our arrival, the CAD system stated people were shooting at the location.

Upon arrival, we observed that the Runway Lounge Bar (9616 W. Appleton) was clearing up and observed people walking to their vehicles. As I pulled into the parking lot of the bar, I did not see anything concerning.

PO SCHLICKE and I proceeded into the Runway Lounge and spoke to the bar manager later identified as Indea D. HOLLAND (b/f, 1-3-88). HOLLAND stated there was a fight that broke out in the bar. HOLLAND stated she did not hear any gunshots. HOLLAND stated due to the nature of the fight, the bar was shut down. I asked HOLLAND who the owner of the bar was and HOLLAND stated it was Shawntel WALTON with a phone number of 262-225-9127. HOLLAND stated WALTON left earlier and was not at the bar. I attempted to call the given number but did not receive an answer. HOLLAND could not provide any additional information.

Follow-up will later be conducted with WALTON.

On Saturday, January 04, 2020 at approximately 12:48 AM, District Four squads were dispatched to 9316 W. Appleton Av (Runway Lounge LLC) located in the City and County of Milwaukee, Wisconsin for a shooting.

Please reference IR's **20-004-0008** and **20-004-0020** regarding supplemental reports with specific details regarding the incident.

Upon arrival squads located a subject, identified as Jaylin R. SMITH (m/b, 09/15/98) with a single gunshot wound, who was being treated by officers who first arrived on scene. SMITH was across the street from the tavern in a vehicle as well as a second subject, identified as Marquis J. MCMILLIAN (m/b, 12/04/95) who stated he had been "pistol whipped" and "jumped" in the parking lot of the establishment. Both SMITH and MCMILLIAN stated the incident occurred in the parking lot, and they ended up in their vehicle which was parked across the street because they took off running from the suspects once they had the chance.

After P.O. Lee XIONG and I found out the incident occurred in the parking lot, we both walked over to the establishment and began trying to speak with security. As police began arriving on-scene security began clearing out the tavern and all patrons had left without incident. While P.O. XIONG and I were attempting to speak with the head of security, identified as Isiah J. JOHNSON (m/b, 06/05/91) who stated he was inside during the time of the incident, we located one fired cartridge approximately 20 feet from the front entrance of the establishment. P.O. XIONG and I secured the scene, while the rest of the patrons exited the establishment and until other squads arrived on-scene and could assist in securing the scene. We later located two more fired cartridges and one un-fired cartridge approximately 15 feet from the first fired cartridge.

While P.O. XIONG and I were securing the scene, P.O. Jason DAERING and P.O. Shane BISHOP (Squad 4485) had gone inside and began speaking with employees, P.O. DAERING spoke with the head bartender, identified Shanina M. DANIELS (f/b, 08/17/77) who stated she was running the bar for the evening and stated that tonight they lowered the entrance age to 21 and up (normal entrance age to the

tavern is 25 years old). DANIELS stated while she was working the bar, she noticed that several individuals had been arguing inside the bar and causing a disturbance and that is when she observed security escort the individuals that were involved out of the bar. DANIELS stated shortly after everyone was escorted outside, that is when police began to arrive on-scene and they began to shut the bar down for the night.

Based on the information provided from P.O. DAERING who was able to watch the video footage from inside the bar, and the information gathered from JOHNSON and DANIELS it appears that the argument began inside the bar. Shortly after an argument began, that is when security escorted all of the individuals involved out of the bar. P.O. DAERING stated once everyone was escorted outside, he then observed on cameras on subject (suspect 1) leave momentarily, and then return with a firearm, and two other subjects, (suspect 2 and 3) then began fighting with MCMILLIAN in the parking lot. After Suspect 1 returned with the firearm, he is also the observed firing a shot at SMITH, which also occurred in the parking lot, where the casings were located. (please see P.O. DAERING's supplemental report for further details)

During the investigation, it was determined that the brother of Jaylin R. SMITH; Justin A. SMITH (m/b, 05/16/01) who was on-scene when police arrived was also in the tavern. Detective Thaddeus SCHIMMEL, who responded to the scene, interviewed Justin SMITH. Justin informed Detective SCHIMMEL that he was only 18 years old, and that there was a cover charge of \$20 for him to enter the establishment. Justin also informed Detective SCHIMMEL that security did not check his identification when he entered the establishment. (please see Detective SCHIMMEL's supplemental report for further details under IR ending in 0008).

P.O. XIONG issued a citation to the owner of the establishment Shawntel R. WALTON (f/b, 01/08/82) for Justin SMITH being inside the establishment. Reference TRACS Citation # M5816N0014.

All employees were cooperative with the investigation, and all licences (Class B Tavern and Public Entertainers Premise) were valid and expire 05/24/2020.

The owner of the establishment, WALTON was not on-scene during the time of the incident.

This report was written by PO Jason DAERING assigned to District 4, Late Power Shift, Squad 4485 with PO Shane BISHOP. On 1-4-20 at 12:51AM, PO BISHOP and I responded to a shooting at the Runway Lounge, at the location of 9316 W. Appleton Ave., within the City and County of Milwaukee.

Upon arrival, I proceeded to go to the parking lot of the property where the alleged shooting did occur. It was near the front, south east facing, single door entryway that one casing was located. A search of the roofline of the bar did reveal several cameras with possible angles of surveillance that had the potential to capture the shooting. Having located the video cameras, I proceeded to go within the bar and speak with the head bartender who was identified as Shanina N. DANIELS(B/F 8-13-77). DANIELS had been with Runway for approximately 2 years and assisted me with the viewing of the video cameras. The following is a summary of what was observed and what cameras the incident was observed from. Also, all cameras were in sync with each other and time stamped approximately 6 hours ahead of real time.

The first camera that I did view was Camera 2 which is fixed to the southern side of the building, overlooking the parking lot. When I located the start of the incident, the date stamp was 1-4-20 with an approximate time stamp displayed 6:35:48. It was at this time that I observed a black male subject walk away from the building and into the parking lot in what appeared to be an agitated state. This subject(Suspect 1) was observed to be heavy set, wearing a black baseball hat with logo, black quilted

jacket with hood, blue jeans, and armed with a black semiautomatic handgun with extended magazine. Suspect 1, after circling the lot proceeded to walk back towards the bar and out of view.

After Suspect 1 left camera view, 2 black male subjects proceed to enter the parking lot and into camera view. These subjects, upon entering camera view, were physically fighting. One of the subjects, later identified as Marquis J MCMILLAN(M/B 12-4-95) was wearing what appeared to be a white jacket with light in color, faded, blue jeans. The subject(Suspect 2) MCMILLAN was fighting with was, as stated earlier, a black male, dark complexion, medium build, bald headed, and last observed wearing white glasses, black hoody and pants with blue underpants exposed due to low riding pants. During the physical altercation, another black male(Suspect 3) entered the camera view and started to attack MCMILLAN as well. Suspect 3 was brown in complexion, medium build, and last see wearing a black hoody over a black and red plaid shirt and black pants. It was after Suspect 3 enters the frame and starts fighting that Suspect 1 reenters the camera view momentarily before running back towards the building.

When Suspect 1 runs back toward the building, I observe another camera angle/view. This camera, Camera 3, proceeded to show Suspect 1 reach over the top of a gray in color Chevy Van and discharge 1 round towards a black male subject wearing what appeared to be a two toned red shirt with blue jeans. The subject who was running, later identified as Jaylin R. SMITH(B/M 9-15-98), did end up being struck by the bullet that was discharged by Suspect 1. The date and time stamp of Camera 3 was 1-4-20 at 06:36:05.

Immediately after Suspect 1 shot at SMITH, Suspect 1 proceeds to enter Camera 2's view again and engage in the physical fight between MCMILLAN, Suspect 2, and Suspect 3. Suspect 1, however, did not spend much time with the altercation before he returned back into the camera view of Camera 3 and discharge his firearm several more times in the direction of where SMITH had ran to before walking back into view of Camera 2 that overlooked the parking lot. It was during this time that Suspect 1 got within the front driver seat of what appeared to be a black newer model Nissan Rogue. Suspect 2 also got within the Nissan and sat in the front passenger seat while Suspect 3 went back within the bar. Suspect 1 and 2 proceeded to exit the parking lot of Runway Lounge, within the Nissan, and travel westbound on W. Appleton Ave. until out of camera view. The date and time stamp on Camera 2, when the Nissan left the parking lot was 1-4-20 at 06:37:26.

Lastly, it was after the shooting and the Nissan exiting the parking lot that several of the security guards did exit Runway Lounge. One of the security guards, who was dressed in all black with a black face mask (balaclava), approached a white Kia with WI registration 545-XBL. This subject opened the rear trunk of the vehicle and proceeded to remove what appeared to be a "AR" style pistol with extended magazine and lanyard. This medium framed male proceeded to give the "AR" style pistol to a heavy set black male, also reportedly working in a capacity of security guard, while also wearing a face mask(balaclava). This subject, later identified as David C. STAPLES(B/M 3-17-76) proceeded to openly carry the firearm throughout the parking lot in his hand, with the lanyard hanging towards the ground. It should be noted that Mr. STAPLES is a convicted felon under State of Wisconsin Case #2011CF0275.

On Wednesday, January 15th, 2020 at 5:50pm, we held a meeting at District Four, in the back assembly room, in regards to the shooting that occurred on January 4th, 2020 at Runway lounge, 9316 W Appleton Ave. The following were present, Captain Heather Wurth, Sgt Mark Kapusta, Sgt Chad Raden, Officer Carrie Resnick, Myself, Shawntel Walton (Agent) and Larry Williams (Manager).

Captain Wurth began the meeting with addressing the shooting that had occurred and asked about their security team. Mr. Williams stated they hired Gorilla Security. Williams stated there is a cover charge only for special events that are scheduled but was not sure what was being charged, He stated every event is different. They have a security team that works these events and they charge \$100.00 per security officer, so that is how they determine what the cover charge is. Sgt. Raden asked if Williams was shown insurance papers and if they are Licensed and bonded in the stated of Wisconsin. Williams stated he didn't know about that, but would look into it. Captain Wurth addressed what occurred with security during the shooting. Two security officers went over to a vehicle that was parked in the parking lot, they opened the trunk of the vehicle, placed a mask over their face and retrieved additional firearms from the vehicle. Those security officers were not located when the officers on scene observed the video of this occurring. Williams stated a few employees were terminated after this incident occurred. Williams and Walton were advised that security was charging \$20.00 to patrons who were underage (18) to allow entry into their establishment. One of the bartenders stated she had lowered the age limit to 21 for the evening. Both stated they were unaware of that occurring. They currently have an age restriction of 25 and older.

Captain Wurth asked, what their plan will be moving forward. Williams stated, he has had bad experiences with notifying MPD of special events in the past with PA-33's being filed against the business and Police overtaking the club. It was stated, when MPD is notified, the tavern cars usually conduct a business check. Sgt. Raden stated, this is good to show a presence to the the business as well as the patrons. Captain Wurth stated, PA-33's are not all negative of which are all read at the license renewal hearings. Williams and Walton stated they will start notifying District Four of upcoming events. Walton and Williams stated they will be adding additional cameras, purchase an ID scanner, but will only use the scanner for larger events.

Williams and Walton stated Runway Lounge is currently open on Thursday 8 PM-1:30 AM and Friday nights from 9 PM-2 AM. Williams stated Fridays are usually busier because the have performers come out.
