There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/20/23 at 4:37pm, officers were dispatched to 1845 W. Burleigh St, for battery. The computer aided dispatch, stated that a female subject maced her nephew in the face. The parties involved were not at the business. Officers were not provided video of the incident. Officers attempted repeated attempts contact the business agent for video of the incident.
2. On 12/05/23 at 1:40pm, officers conducted a business check at 1845 W. Burleigh St. Officers attempted to obtain video from a battery complaint that occurred in the business the night prior. The employee stated that he does not have video access, the owner is the only person with access to the video system. The employee stated that he will contact the agent for the video request. Officers were contacted to return for the video requested. Officers were able to view the video but the employee was not able to provide a copy of the video. The employee stated the owner is the only person able to fully access the video system.

On Tuesday, June 20, 2023, at approximately 4:37pm, Police Officer Eric SANTIAGO and I, while wearing full Milwaukee Police Department uniform with Axon body worn cameras activated, responded to the address of 3042 N 19th Street in the city and county of Milwaukee, Wisconsin regarding a battery domestic violence incident said to have occurred at 1845 W Burleigh Street.

I proceeded to enter the convenience store located at 1845 W Burleigh St, Burleigh Foods and Hand Car Wash and was informed by staff that I would have to contact the owner regarding viewing video surveillance. The staff member provided a name of Jatinder SINGH and a phone number of 414-614-9435. I immediately attempted to contact the number and the number went to a notification that the wireless customer was not available, and I was unable to leave a voicemail.

I later identified through mymilwaukeehome.com that the address is owned by Singh and Wade Real Estate LLC and located a contact # of 414-372-4283. I attempted to contact this number and it rang through until reaching a notification that the voicemail was not set up.

A check of the premise licensure revealed the owner to be Jatinder M SINGH (I/M, 7/15/1969). Two contact numbers for SINGH were listed on the license, 414-372-4283 which rang through and did not have voicemail set up and 414-265-7025 which also rang through and did not have voicemail set up.

After repeated attempts to contact the owner I was unable to get in contact and obtain video surveillance regarding the domestic violence battery incident.

This report is being written by PO Stephen COLWELL, assigned to District Five, Early Power Shift, Squad 5266.

On Tuesday, December 5th, 2023, at approximately 1:40 PM, I conducted a Business Check at Burleigh Foods (1845 W Burleigh St), located within the City and County of Milwaukee.

This business check was in regard to a Battery complaint I investigated that occurred outside the location on 12/4/23. (CAD: 233381162)

On the night of the offense, I spoke to the cashier on duty who informed me he did not have access to the video surveillance system and that I would need to return the next day. I left my contact card with this individual and requested someone who has access to the surveillance system contact me. On 12/5/23, I conducted follow-up at the store to attempt to recover video footage. (CAD: 233390734) Inside the store I made contact with one of the employees who identified himself as Jordan N CURRIE (B/M, 6/11/1992) as well as a female employee who did not speak to me. CURRIE stated he did not have access to the system either and that I would need to come back when the owner was present. I provided my contact card to CURRIE and requested someone contact me when I am able to view video.

On Wednesday, 12/6/23, I received a voicemail from CURRIE stating I could now come to the store to view surveillance footage. On 12/6/23, at 11:24 AM, PO Christopher SCHLEI and I conducted follow-up at Burleigh Foods to view the footage. (CAD: 233400579) CURRIE was the only employee on duty when we arrived. CURRIE then began to operate the camera system which I was able to view from the customer area of the store. CURRIE located with battery incident without me providing him any details as to what had occurred and when, which indicated to me he had reviewed the footage prior to allowing me to view it.

After viewing the footage, I requested to recover this footage onto a flash drive which CURRIE stated was not possible at the time. CURRIE stated the owner of the store is the only one allowed to assess the DVR and CURRIE could not assist me any further in recovery of the footage without the owner present.

This establishment was found to have active and valid licenses for Cigarette and Tobacco as well as a Food Dealer Retail. The licensing agent was Jatinder M SINGH (W/M, 7/15/1969).

Burleigh Foods has numerous high-quality cameras on the interior and exterior of the store.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place at 1:25 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are invited to view via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 224-2850 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day before the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


