The reason I'm going to be reimbursed on Aug 5, 2011 my Lexus Truck was parked on 6th Cherry between 12:00 and 12:30 noon a city worker began spraying white lines on the street. As he was spraying the paint went onto the hood front side of the truck. I was parked on the corner of 6th Cherry. A lady came into the day care and asked if there was anyone driving a Lexus truck. My supervisor came and told me that I need to go and look at my truck. The paint that the city worker was using was sprayed all on the truck. As he was spraying the water onto the street the gravel was hitting against the truck which caused

a chip to be on the front of the hood. I asked the worker do you see my truck? The worker started in an arrogant tone. "Don't worry about it. It will come off. I tried to explain to him that I just got my truck painted. He acted like as though he didn't want to listen to what I had to say and jumped in the city's truck.

I just got my truck painted on June 3, 2011 at Player Choice Customizing auto which cost me \$1500 + 198.00 tax. I took my truck back to Player's Choice Customizing Autobody to get an estimation on how much it will cost to remove the white spots that's in the paint. The estimation was 792.92 that is included the chip on the hood that came from the gravel that was flying.
