

On Tuesday September 13th, 2005 during a storm, a tree limb fell from a city tree and damaged my truck. The limb caused 2 dents on the right side of my truck and tore the tonneau cover on the truck bed. This happened on the 4000 block of North 71st Street a little after 6:00 p.m.

A supervisor from the forestry department came out on September 20th, 2005 and assessed the damage.

I am asking that the city reimburse me for the cost of removing the 2 dents caused by the city tree and also reimburse me for the replacement tonneau cover that was torn by the tree limb. I am requesting a sum of \$215.51. The receipt for the dent removal and the receipt for the tonneau cover are enclosed.


