On Tuesday, December 12, 2023 at 4:30PM, we held a meeting with the Regal Beagle Tavern at District Four regarding few incidents that recently occurred there. Lt Shannon Taylor, Alderwoman Laressa Taylor, paralegal Austin Baldwin, tavern owner, Justin Jackson and myself were all present at the meeting. Justin gave the group updates on the new safety measurements that he has been taking at his establishment since the incidents have occurred. Jackson stated that he reduced his hours, so he closes every night at 1:30AM now, in addition to a new dress code, cover charge for male patrons, and the age restriction is 25 for males and 21 for females. Mr. Jackson also showed the group the new ADT system that sends alerts to his phone regarding the number of patrons in the bar. He gets an alert when the number hits 20, then 50 and finally at 70 which is his maximum capacity. The app also sends alerts as customers leave. He advised us that he has lost a lot of customers after the changes were implemented, therefore he has gotten rid of many staff members and does a lot of the work himself. Jackson has noticed a change in the atmosphere since the new safety measures have taken place, but sales are down, so he is planning on putting the building up for sale soon. Alderwoman Taylor recommended that he tries more of a sit down restaurant or to change the bar to cater to the neighborhood. Mr. Jackson touched on all of the community outreach he has done in the neighborhood, from backpack giveaways, to donating coats and sponsoring youth football leagues in the area. We confirmed the upcoming CPTED that is scheduled at the bar and Alderwoman Taylor will be scheduling another Town Hall meeting at the establishment next month after the CPTED is complete.
